Kaiser Permanente Tax Sheltered Annuity Plan Notes to Financial Statements

Note A – Description of the Plan

The following description of the Kaiser Permanente Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan was established on January 1, 2017 (inception date), for the purpose of providing retirement benefits to employees who meet specified requirements. As of the inception date, assets of the Plan totaling approximately \$1,436,988,000 attributed to the accounts of certain collectively bargained participants, were transferred from the Original Kaiser Permanente Tax Sheltered Annuity Plans (TSA I and TSA II) to this Plan.

Effective July 1, 2024, the Plan was amended and restated and renamed from the Kaiser Permanente Tax Sheltered Annuity Plan III to the Kaiser Permanente Tax Sheltered Annuity Plan.

The Plan is a 403(b)(7) defined contribution plan which is intended to comply with the applicable provisions of the Internal Revenue Code (IRC) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustees and custodians – Vanguard Fiduciary Trust Company (Vanguard) serves as the trustee and custodian for the mutual funds and participant directed brokerage accounts. Metropolitan Life Insurance Company (MetLife) serves as the custodian of the investment contract with the insurance company.

Eligibility – Certain non-union employee may participate in this Plan. Certain mental health workers, clerical and technical employees, home health nurses, registered nurses and nurse practitioners, respiratory therapists, behavioral health, social workers, pharmacists, IT workers, optometrists, security personnel, laboratory professional employees, dental hygienists, dietician, audiologists, speech therapists, health educator employees represented by unions may participate in the Plan.

Participant accounts – Each participant's account is credited with the participant's contributions, as well as any relevant employer's contributions plus allocated plan earnings and losses, and charged with administrative expenses. Allocations are based on participant account balances, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other plan service providers, may be charged against the accounts of plan participants at the discretion of the Administrative Committee or the Investment Committee (the Committees) as defined in the Plan document. During the current year, these fees were paid by the plan sponsor. The Committees may use such discretion to charge these administrative expenses to participant accounts in future years. Any actual administrative expenses charged to a participant's account shall be reflected in the participant's quarterly account statement. The benefit to which a participant is entitled is based on the participant's vested account balance.

Contributions – A participant may elect to contribute 1% to 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provisions whereby certain employee groups who are newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Effective July 1, 2024, unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 6%.

The Employer makes contributions for certain employee groups as defined by the Plan document. All contributions are subject to applicable limitations set by the Internal Revenue Service (IRS).

Vesting – Each participant is fully and immediately vested at all times in his or her employee contribution accounts unless a transfer account where the applicable vesting applies. Participant vests 20% per year of service in his or her employer contribution account and is 100% vested after 5 years of service.

Notes receivable from participants – A participant with a minimum account balance of at least \$1,000 may borrow up to the lesser of 50% of his or her account balance or \$50,000, reduced by the highest outstanding loan balances carried by the participant in this and/or all other employer plans during the 12-month period prior to the new loan. The term of the loan is limited to not more than 5 years, except for residential loans which may be extended up to 15 years. The interest rate is “Prime Rate” plus 1%. Loan repayments are made through payroll deductions and are credited to the participant’s account. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 10.50%, with various maturities through September 2056.

Payment of benefits – A participant shall be entitled to receive all or a portion of his or her account upon occurrence of the earlier of the participant’s retirement, death, disability, or termination of employment, upon attainment of age 59½ or the participant’s hardship, as defined by the Plan document. Participants with account balances greater than \$5,000 have the option of leaving their accounts in the Plan after termination.

Forfeitures – Forfeitures are any amounts properly removed from a Plan account for any reason provided under the terms of the Plan other than a distribution of withdrawal pursuant to an appropriate election. Forfeitures are retained in the Plan and never revert to the plan sponsor. Forfeiture amounts in a plan year are first used to restore rehired participants’ and abandoned accounts. Then, to the extent forfeiture amounts remain, the Plan Administrator, in its discretion, may use such remaining amounts to pay reasonable administrative expenses of the Plan or reduce future employer contributions. For the year ended December 31, 2024, and prior years, the Plan Administrator has used forfeiture amounts that remained after the reinstatement of rehired participants’ and abandoned accounts to pay Plan administrative expenses and has not used forfeitures to reduce employer contributions.

Note B – Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value (except for the investment contract with MetLife which is valued at contract value (see Note 4- Investment Contract with Insurance Company). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3 – Fair Value Measurements).

Purchases and sales of securities are recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the notes receivable from participants on the Statements of Net Assets Available for Benefits.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers may be paid by the Plan. During the current year, these fees were paid by the plan sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants account balances and are included in administrative expenses.

Subsequent events – The Plan's financial statements have been evaluated for subsequent events or transactions for potential recognition through August 1, 2025, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

Note C – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.
- Participant-directed brokerage accounts held mutual funds, money market accounts, and cash.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D – Investment Contract with Insurance Company

Kaiser Foundation Health Plan Inc. entered into a group annuity contract with MetLife. MetLife maintains the contributions in separate accounts. These accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.00%. Such interest rates are reset on an annual basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such value even, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note E – Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

Note F – Tax Status

The Plan meets the qualification requirements under Section 403(b), and is tax exempt under provisions of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualifications. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as restated, is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G – Party-In-Interest Transactions

Certain plan investments are managed by an affiliate of Vanguard. Vanguard is the trustee of the Plan. An affiliate of Vanguard also serves as the recordkeeper. Transactions with the trustee and recordkeeper qualify as party-in-interest transactions.

Note H – Risk And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note I – Plan Obligations

In accordance with GAAP, benefits due to terminated participants are included in the Statements of Net Assets Available for Benefits. There were no benefits due to terminated participants as of December 31, 2024 and 2023.

Note J – Plan Transfers

Effective December 29, 2023, the Kaiser Permanente Washington 403(b) Plan, the Kaiser Permanente Tax Sheltered Annuity Plan, and the Kaiser Permanente Tax Sheltered Annuity Plan II (the Merged Plans) were merged into the Plan and all eligible employees of the Merged Plans became eligible to participate in the Plan on December 29, 2023. The Board of Directors of the Company approved the merger of the Kaiser Permanente Washington 403(b) Plan, the Kaiser Permanente Tax Sheltered Annuity Plan, and the Merged Plans with the Plan and assets of approximately \$8,771,867,000 were transferred in December 2023, including participant loans in the amount of approximately \$87,729,000.
