## Notes to Financial Statements

---

### **Note A – Description of the Plan**

The following description of the Kaiser Permanente Supplemental Savings and Retirement Plan for Union Groups (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a money purchase plan which is intended to comply with the provisions of Section 401(a) and other applicable provisions of the Internal Revenue Code (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The purpose of the Plan is to provide additional retirement benefits for employees who meet specified requirements.

**Trustees and custodian** – Vanguard Fiduciary Trust Company (Vanguard) serves as the trustee for the mutual funds, collective investment funds, and participant directed brokerage accounts.

**Eligibility** – Certain food and commercial employees, longshoreman, warehouse employees, nurses, laboratory workers, pharmacists, healthcare professionals, physical, speech and occupational therapists, psychology and social workers, optometrists, optical workers, office and professional employees represented by unions may participate in the Plan provided they are employed by a participating company and have met a two-year service requirement. Certain hourly employees in the southern California region classified as lifestyle educator, physician assistant, and research employees may participate in the plan immediately upon hire.

**Participant accounts** – Each participant's account is credited with the participant's contributions, as well as any relevant employer's contributions plus allocated plan earnings and losses and charged with administrative expenses. Allocations are based on participant account balances, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other plan service providers, may be charged against the accounts of plan participants at the discretion of the Administrative Committee or the Investment Committee (the Committees) as defined in the Plan document. During the current year, these fees were paid by the plan sponsor. The Committees may use such discretion to charge these administrative expenses to participant accounts in future years. Any actual administrative expenses charged to a participant's account shall be reflected in the participant's quarterly account statement. The benefit to which a participant is entitled is based on the participant's vested account balance.

**Contributions** – A participant may elect to make contributions, through payroll deductions, in increments of 1% up to a maximum 10% of compensation. The Employer contributes 5% of eligible compensation of participating employees. Certain Profession Participants and members of the National Union of Healthcare workers in Southern California who meet the eligibility conditions receive employer contributions equal to 6% of their eligible compensation. Certain physical, occupational, or recreational therapists in Southern California receive employer contributions equal to 2.5%. Certain longshore and warehouse workers in Hawaii receive employer contributions equal to 6%. Certain optical workers receive employer contributions equal to 6%. All contributions are subject to applicable limitations set by the Internal Revenue Service (IRS).

**Vesting** – Each participant is fully and immediately vested in his or her employee and employer contribution accounts.

**Notes receivable from participants** – A participant with a minimum account balance of at least \$1,000 may borrow up to the lesser of 50% of his or her account balance or \$50,000, reduced by the highest outstanding loan balances carried by the participant in this and/or all other employer plans during the 12-month period prior to the new loan. The term of the loan is limited to not more than 5 years, except for residential loans which may be extended up to 15 years. The interest rate is “Prime Rate” plus 1%. Loan repayments are made through payroll deductions and are credited to the participant’s account. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturities through January 2040.

**Payment of benefits** – A participant shall be entitled to receive all or a portion of his or her account upon occurrence of the earlier of the participant’s retirement, death, disability, or termination of employment, as defined by the Plan document. A participant may take a distribution of any after-tax contribution plus applicable earnings at any time. Participants with account balances greater than \$5,000 have the option of leaving their accounts in the Plan after termination.

**Forfeitures** – Forfeitures are any amounts properly removed from a Plan account for any reason provided under the terms of the Plan other than a distribution of withdrawal pursuant to an appropriate election. Forfeitures are retained in the Plan and never revert to the plan sponsor. Forfeiture amounts in a plan year are first used to restore rehired participants’ and abandoned accounts. Then, to the extent forfeiture amounts remain, the Plan Administrator, in its discretion, may use such remaining amounts to pay reasonable administrative expenses of the Plan or reduce future employer contributions. For the year ended December 31, 2024 and prior years, the Plan Administrator has used forfeiture amounts that remained after the reinstatement of rehired participants’ and abandoned accounts to pay Plan administrative expenses and has not used forfeitures to reduce employer contributions.

### **Note B – Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan.

**Basis of accounting** – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3 – Fair Value Measurements).

Purchases and sales of securities are recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the notes receivable from participants on the Statements of Net Assets Available for Benefits.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers may be paid by the Plan. During the current year, these fees were paid by the plan sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants account balances and are included in administrative expenses.

**Subsequent events** – The Plan's financial statements have been evaluated for subsequent events or transactions for potential recognition through August 1, 2025, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

### **Note C – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.
- Collective investment funds are stated at fair value as determined by the issuers based on the unit values of the funds. Unit values are determined by dividing the funds' net assets, which represent the unadjusted prices in active markets of the underlying investments, by the number of units outstanding at the valuation date. While not publicly traded, the funds are comprised primarily of underlying securities represented by a variety of asset classes that are publicly traded on exchanges or over the counter, and price quotes for the assets held by the funds are readily observable and available. Redemption requests on the collective investments funds must be received at least 10 business days prior to the specified valuation date of withdrawal. There are no unfunded commitments or other redemption restrictions on the collective investments funds.
- Participant-directed brokerage accounts held mutual funds and cash.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note D – Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Note E – Tax Status

The Plan obtained its latest determination letter dated November 3, 2015. The IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Subsequent to this determination letter, the Plan was restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as restated, is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note F – Party-In-Interest Transactions

Certain plan investments are managed by an affiliate of Vanguard. Vanguard is the trustee of the Plan. An affiliate of Vanguard also serves as the recordkeeper. Transactions with the trustee and recordkeeper qualify as party-in-interest transactions.

### Note G – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note H – Plan Obligations**
