Note A – Description of the Plan

The following description of the Kaiser Permanente Washington Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Kaiser Permanente acquisition – Kaiser Foundation Health Plan of Washington acquired and became the sole corporate member of Group Health Cooperative (Cooperative) on February 1, 2017. Following the acquisition, Kaiser Foundation Health Plan of Washington was renamed KFHPW Holdings, and the Cooperative was renamed Kaiser Foundation Health Plan of Washington (KFHPWA).

Effective February 1, 2017, the Board of Trustees of KFHPWA (the Board) amended the Plan to appoint the Kaiser Permanente Retirement Plans' Investment Committee (KPIC) as the named fiduciary as defined under Section 402(a) of the Employee Retirement Income Security Act of 1974 (ERISA), as amended for investment matters.

Effective February 1, 2017, the name of the Plan was changed from Group Health Cooperative Employee Defined Contribution Plan to Kaiser Permanente Washington Defined Contribution Plan.

Effective July 11, 2017, the Board amended the Plan to appoint the Kaiser Permanente Administrative Committee (KPAC) the Plan administrator of the Plan.

General – The Plan is a defined contribution plan established for the purpose of providing eligible employees a source of retirement income pursuant to Section 401(a) of the Internal Revenue Code (IRC). The Plan covers eligible employees of Kaiser Foundation Health Plan, Inc. (KFHPI) and participating employers. The Plan is subject to provisions of ERISA. KPAC became the Plan administrator effective July 11, 2017. Prior to that date, the Plan administrator was the Group Health Cooperative Pension and Deferred Compensation Plans Committee.

Trustees and custodian – Vanguard Fiduciary Trust Company (Vanguard) serves as the trustee for the mutual funds, collective investment funds and participant directed brokerage accounts.

Eligibility – All non-union employees participate in this Plan. Certain physical and occupational therapists, social worker and therapists, registered nurses and advanced registered nurse practitioners, service staff, office and professional employees, and food and commercial employees represented by unions may participate in the Plan.

Participant accounts – Each participant's account is credited with allocations of KFHPWA's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other Plan service providers, may be charged against the accounts of Plan participants at the discretion of KPAC or KPIC (the Committees) as defined in the Plan document. These fees were paid by the plan sponsor. The Committees may use such discretion to charge these administrative expenses charged to a participant's account shall be reflected in the participant's quarterly account statement. The benefit to which a participant is entitled is based on the participant's vested account balance.

Contributions – Participants may not contribute to the Plan. KFHPWA contributes an amount equal to 6.3% of the participant’s certified earnings as defined by the Plan provisions, up to the Social Security Taxable Wage Base (SSTWB) amount, plus 12% of the participant’s certified earnings above the SSTWB amount, up to the maximum amount permitted by the Internal Revenue Service (IRS). Contributions are subject to regulatory limitations.

Vesting – Vesting in KFHPWA’s contributions, and earnings thereon, is generally based on years of continuous service with a minimum of one hour of new service required per year, unless otherwise specified in the Plan’s provisions.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive (1) a lump-sum amount equal to the value of the participant’s vested account balance, (2) payment in a series of annual or more frequent installments, or (3) an annuity to be paid in installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant or designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Forfeitures are any amounts properly removed from a Plan account for any reason provided under the terms of the Plan other than a distribution of withdrawal pursuant to an appropriate election. Forfeitures are retained in the Plan and never revert to the plan sponsor. Forfeiture amounts in a plan year are first used to restore rehired participants’ and abandoned accounts. Then, to the extent forfeiture amounts remain, the Plan Administrator, in its discretion, may use such remaining amounts to pay reasonable administrative expenses of the Plan or reduce future employer contributions. For the year ended December 31, 2024, and prior years, the Plan Administrator has used forfeiture amounts that remained after the reinstatement of rehired participants’ and abandoned accounts to pay Plan administrative expenses and has not used forfeitures to reduce employer contributions.

Note B – Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3 – Fair Value Measurements).

Purchases and sales of securities are recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers may be paid by the Plan. During the current year, these fees were paid by the plan sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants' account balances and are included in administrative expenses.

Subsequent events – The Plan's financial statements have been evaluated for subsequent events or transactions for potential recognition through August 1, 2025, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

Note C – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.
- Collective investment funds are stated at fair value as determined by the issuers based on the unit values of the funds. Unit values are determined by dividing the funds' net assets, which represent the unadjusted prices in active markets of the underlying investments, by the number of units outstanding at the valuation date. While not publicly traded, the funds are comprised primarily of underlying securities represented by a variety of asset classes that are publicly traded on exchanges or over the counter, and price quotes for the assets held by the funds are readily observable and available. Redemption requests on the collective investment funds must be received at least 10 business days prior to the specified valuation date of withdrawal. There are no unfunded commitments or other redemption restrictions on the collective investment funds.
- Participant-directed brokerage accounts held mutual funds, common stocks, and cash.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D – Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain fully vested in their accounts.

Note E – Tax Status

The Plan obtained its latest determination letter dated September 30, 2016. The IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Subsequent to this determination letter, the Plan was restated and amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as restated and amended, is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note F – Party-In-Interest Transactions

Certain plan investments are managed by an affiliate of Vanguard. Vanguard is the trustee of the Plan. An affiliate of Vanguard also serves as the recordkeeper. Transactions with the trustees and recordkeeper qualify as party-in-interest transactions.

Note G – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note H – Plan Obligations

In accordance with GAAP, benefits due to terminated participants are included in the Statements of Net Assets Available for Benefits. There were no benefits due to terminated participants as of December 31, 2024 and 2023.

Note I – Subsequent Events

Effective February 1, 2025, non-union, non-executive employees in National Functions who reside in the Washington Region became eligible employees of the Plan. Effective July 1, 2025, non-union, non-executive employees who reside in the Washington Region who established Washington residency on or after June 1, 2027, and before February 1, 2025, became eligible employees of the Plan.
