Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Oregon Federation of Nurses and Health Professionals - Kaiser Foundation Health Plan Retirement and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Oregon Federation of Nurses and Health Professionals - Kaiser Foundation Health Plan Retirement and Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note A – Description of the Plan

The following description of the Oregon Federation of Nurses and Health Professionals - Kaiser Foundation Health Plan Retirement and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a non-contributory, defined contribution plan covering nurses who became eligible effective January 1, 1989, and technical employees and registered hygienists who became eligible effective January 1, 1995. The Plan and Trust was established to be effective as of January 1, 1989, pursuant to a collective bargaining agreement between the Kaiser Foundation Health Plan of the Northwest, Kaiser Foundation Hospitals, and the Oregon Federation of Nurses, Local 5017, FNHP, AFL-CIO. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustees and custodian – Vanguard Fiduciary Trust Company (Vanguard) serves as the trustee for the mutual funds and collective investment funds.

Eligibility – Effective January 1, 2009 (the freeze date), the Plan was frozen to new participants. The participants in the Plan began participating in the Kaiser Permanente Tax Sheltered Annuity Plan.

Participant accounts – Each participant's account is credited with plan earnings or losses, and charged with administrative fees. Allocations are based on participant account balances, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other plan service providers, may be charged against the accounts of plan participants at the discretion of the Administrative Committee or the Investment Committee (the Committees) as defined in the Plan document. The Committees may use such discretion to charge these administrative expenses to participant accounts in future years. Any actual administrative expenses charged to a participant's account shall be reflected in the participant's quarterly account statement. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Contributions – There are no employee and employer contributions allowed under the Plan.

Vesting – Effective as of the freeze date, all accounts are 100% vested.

Payment of benefits – Upon termination of service, a participant's benefits will be paid out in a lump sum amount equal to the value of his or her vested account, provided that the participant is of retirement age as specified by the Internal Revenue Code (IRC). Participants with account balances greater than \$5,000 have the option of leaving their accounts in the Plan after termination.

Note B – Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3 – Fair Value Measurements).

Purchases and sales of securities are recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers may be paid by the Plan. During the current year, these fees were paid by the plan sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants account balances and are included in administrative expenses.

Subsequent events – The Plan's financial statements have been evaluated for subsequent events or transactions for potential recognition through August 1, 2025, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

Note C – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.
- Collective investment funds are stated at fair value as determined by the issuers based on the unit values of the funds. Unit values are determined by dividing the funds' net assets, which represent the unadjusted prices in active markets of the underlying investments, by the number of units outstanding at the valuation date. While not publicly traded, the funds are comprised primarily of underlying securities represented by a variety of asset classes that are publicly traded on exchanges or over the counter, and price quotes for the assets held by the funds are readily observable and available. Redemption requests on the collective investments funds must be received at least 10 business days prior to the specified valuation date of withdrawal. There are no unfunded commitments or other redemption restrictions on the collective investments funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D – Plan Termination

Although it has not expressed any intent to do so, subject to any applicable collective bargaining agreement, the Union or the Trustee have the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Note E – Tax Status

The Plan obtained its latest determination letter dated October 28, 2015. The Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Subsequent to this determination letter, the Plan was restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as restated, is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note F – Party-In-Interest Transactions

Certain plan investments are managed by an affiliate of Vanguard. Vanguard serves as the trustee and recordkeeper. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note G – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that change in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note H – Plan Obligations

In accordance with GAAP, benefits due to terminated participants are included in the Statements of Net Assets Available for Benefits. There were no benefits due to terminated participants as of December 31, 2024 and 2023.
