NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of Azara Healthcare 401(k) Plan (the “Plan”) provides only general information. The Plan Agreement should be referred to for a more complete description of the Plan’s provisions.

General – The Plan is a qualified defined contribution plan with a cash deferral arrangement covering all eligible employees (“participants”) of Azara Healthcare, LLC (the “Company”). The Plan was established on January 1, 2013 and is administered on the basis of the Plan year, which is the 12 month period commencing each January 1 and ending on December 31. Effective January 1, 2024, the Plan was amended to change the eligibility requirements for the discretionary match and profit sharing contributions to only include participants who are employed with the Plan sponsor on the last day of the Plan year. This condition is waived for participants whose employment is terminated due to death, disability, or after normal retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants are offered a selection of mutual funds for the placement of their contributions (“participant-directed funds”). The determination of the participant-directed funds made available to participants is made by the Plan’s administrator.

Eligibility – As defined by the Plan, there is no age, service, or other requirements for participants to be eligible to contribute to the Plan. Eligible participants can enter the Plan on the first day of the month coinciding with or next following the date of hire.

Contributions – Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan agreement. Participants have the option of contributing a percentage of their taxable compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations as outlined in the Internal Revenue Code (“IRC”). Participants are automatically enrolled in the Plan with a 3% contribution unless elected otherwise.

The Company may make matching or non-elective contributions as permitted by the Plan at the discretion of the Company. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$400,000. The Company did not make any contributions to the Plan during the year ended December 31, 2023.

Notes Receivable from Participants – Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account subject to certain Internal Revenue Service (“IRS”) limitations. Participants may only have one loan outstanding at any given time. Loans are to be repaid within five years, unless the loan is for a primary residence. Loans are secured by the remaining vested balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are repaid through after-tax payroll deductions on a semi-monthly basis. At December 31, 2024 and 2023, loans bear interest at rates ranging from 5.25% to 10.50% with maturity dates through January 2029.

Vesting – Participants are vested immediately in their deferral contributions, rollover contributions, and any earnings thereon along with discretionary matching or non-elective contributions and earnings.

Forfeitures – Forfeitures may first be used to pay any administrative expenses, then to reduce any employer contribution on a per payroll period basis. As of December 31, 2024 and 2023, there were no unallocated forfeitures.

Payment of Benefits – Upon termination of service, retirement, death, or disability, distributions under the Plan shall be paid through a single lump sum amount, equal installments, or partial withdrawals. The Plan also allows for hardship withdrawals and in-service withdrawals upon the participant reaching age 59½ of all or a portion of a participant’s vested account.

Note 1—Description of the plan (continued)

Participant Accounts – Each participant’s account is credited with (a) the participant’s pre-tax elective deferrals, Roth elective deferrals, and rollover contributions, (b) Company’s discretionary matching or non-elective contributions and (c) the Plan’s net investment earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Plan Administration – The Company is the Plan sponsor and Plan administrator. Assets of the Plan are in the custody of Reliance Trust Company, the Trustee of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Such estimates relate primarily to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 5). Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

Benefits Paid – Benefit payments are recorded when paid.

Administrative Expenses – Certain administrative expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses, recordkeeping, and other Plan administration expenses paid by the Plan are recorded in the net appreciation in fair value of investments and in administrative expenses.

Note 3—Risks and uncertainties

The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 4—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, (the "qualified institution") of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and notes receivable from participants as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Fair value measurements

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 or 2023:

Mutual Funds – These public investment vehicles are valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6—Parties-in-interest transactions

Certain Plan investments are shares of investments managed by Reliance Trust Company, the recordkeeper and Trustee, and, therefore, these transactions qualify as parties-in-interest transactions for which a statutory exemption exists. Fees paid to the recordkeeper and Trustee totaled \$34,406 for the year ended December 31, 2024. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Administrative fees related to the Trustee’s administration of the Plan may be paid by the Company.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9—Tax status

The Plan obtained its latest opinion letter on October 6, 2020, in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and the related trust is tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10—Operational failure

In accordance with the Plan adoption agreement, all employees except for nonresident aliens and residents of Puerto Rico are eligible to participate in the Plan. For the year ended December 31, 2023, the Company determined there was a failure to include an employee as an eligible participant in the Plan. During 2024, the Company corrected this failure by funding the applicable participant's account with a qualified non-elective contribution for the missed deferrals and lost earnings.

Note 11—Subsequent events

The Plan sponsor has evaluated all subsequent events through August 26, 2025, the date the financial statements were available to be issued and determined that no additional subsequent events had occurred that would require recognition or disclosure in these financial statements, except as discussed below.

Effective January 1, 2025, Reliance Trust Company resigned as Trustee of the Plan and was succeeded by ADP Retirement Trust Services, LLC.

In 2025, the Plan Sponsor acquired another company, and all eligible employees of the acquired company began contributing to the Plan as of February 2025.
