Basis for Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of Plumbers' Supply Company 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Plumbers' Supply Company (the Company or the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 1, 2023, to recognize prior service for new participants who were employed with predecessor employer Ellsworth Plumbing Heating & A/C Supply LLC (Ellsworth), as the Plan Sponsor acquired Ellsworth in 2023. The Plan was amended effective August 1, 2024, to add the auto-enrollment of employees who become eligible to participate in the Plan after the effective date at a rate of 3%.

Eligibility: Employees of the Company become eligible to enter the Plan and to make elective deferrals when they have completed 60 days of service and are age 18 or older. Employees become eligible to receive employer contributions when they have completed one year of service and are age 18 or older. In addition to the previous requirements, employees must also work at least 1,000 hours of service during the plan year and be employed on the last day of the plan year to be eligible for a discretionary profit sharing employer contribution, unless requirements were not met due to retirement, disability or death. Under the terms of the Plan, the following employees are considered excluded and may not participate in the Plan: employees covered by a collective bargaining agreement and nonresident aliens who do not receive U.S. source income from the Plan Sponsor.

Contributions: Each year, participants may contribute up to 100% of their pretax annual compensation to the Plan subject to Internal Revenue Service (IRS) and ERISA limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another qualified defined benefit or contribution plan (rollovers). The Plan provides for an employer safe harbor contribution to the Plan based upon 3% of participants' eligible compensation. Safe harbor contributions for the year ended December 31, 2024, amounted to \$699,674. The Plan Sponsor may also make discretionary profit sharing contributions to the Plan. Discretionary profit sharing contributions to the Plan for the year ended December 31, 2024, amounted to \$1,707,222. Participants may designate deferrals as Roth deferral contributions; and the Plan Sponsor may also make discretionary additional matching contributions limited to 4% of the participants' plan year compensation. The Plan Sponsor did not make any discretionary additional matching contributions to the Plan during the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's safe harbor contributions, discretionary profit sharing contributions and discretionary additional matching contributions. Plan earnings are allocated to participant accounts daily based on account balances and the returns on investments elected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in their contributions and the Plan Sponsor's safe harbor contributions plus actual earnings thereon. The Plan Sponsor's discretionary profit sharing contributions, discretionary additional matching contributions and related earnings thereon are subject to the years of service vesting schedule below:

Forfeitures: The forfeiture and unallocated asset holding account totaled \$4,592 and \$12,919 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay plan expenses, reduce any nonelective contribution or to reduce any matching contribution. Forfeitures and earnings on forfeiture and unallocated asset balances generated during the year ended December 31, 2024, were \$23,371 and \$189, respectively. During the plan year ended December 31, 2024, forfeitures and unallocated assets of \$24,604 and \$7,222 were used to pay plan expenses and reduce employer contributions, respectively.

Investment options: All participant accounts are self-directed and investment options offered by the Plan include several mutual funds and a common/collective trust fund. Each participant may change his or her investment allocations at any time.

Payment of benefits: Upon termination due to death, disability or retirement, a participant may elect to receive the value of his or her account in a lump-sum amount, rollover to a qualified plan, or installments. Upon any other type of termination or upon normal retirement age, a participant shall be entitled to a lump-sum benefit equal to his or her vested interest in the Plan. If, after termination, no election is made and the participant's vested account balance is \$1,000 or less it will be distributed in a lump-sum payment. Unless otherwise elected, balances from \$1,001 to \$5,000 will be automatically distributed to a qualified individual retirement account. In-service distributions are permitted for certain financial hardships and upon attaining age 62.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) and are presented on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits: Benefits are recorded when paid.

Expenses: As provided by the plan agreement, expenses incurred in the administration of the Plan may be paid by the Company or the Plan. Fees associated with distributions to participants and the use of other plan features may be charged directly to the participant's account and are included in expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Income taxes: U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

Note 3. Information Prepared and Certified by the Plan's Trustee

Note 4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the current period.

Mutual funds: Mutual funds are valued at the quoted market price. (Level 1).

Stable value fund: The stable value fund is valued at the net asset value (NAV) unit value reporting by the investment manager at year-end. The fund's underlying assets consist of investment contracts and security-backed contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment adviser reserves the right to temporarily delay withdrawal from the stable value fund in order to ensure securities liquidations will be carried out in an orderly business manner. The stable value fund is not included in the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan has adopted a nonstandardized form of a preapproved plan. The preapproved plan provider, Empower Retirement LLC, has received on November 14, 2022, an opinion letter from the IRS as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Administrative expenses of the Plan were paid to the Plan's trustee and other service providers and therefore qualify as party-in-interest transactions.
