### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Burris Logistics Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the Burris Logistics Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all union and non-union employees of Burris Logistics and its subsidiaries (the "Company"). All non-union employees and union employees are eligible to participate after the completion of six months of service and are age nineteen or older. Effective October 1, 2023, the Plan was amended to remove the six month service requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 24, 2023, the Plan was amended to include the participants from Sunny Morning Foods, Inc., a newly acquired subsidiary.

**Contributions** - Contributions to the Plan are made by participating employees and the Company. Participants may elect to contribute up to any percentage of eligible compensation as defined by the Plan, which is matched by a Company contribution. The Company match is 100% of the first 6% of the employee's eligible compensation for non-union employees and union employees.

The Plan permits participants to contribute amounts representing distributions from other defined benefit or defined contribution plans ("rollover contributions").

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of the Company's pension and profit sharing contributions and Plan earnings. Allocations are based on participant earnings, hours worked or account balances, as defined. Participants direct the investment of their accounts among available investment options.

**Vesting** - All participants are immediately vested in their contributions and actual earnings thereon. Participants become 100% vested in the Company's Qualified Automatic Contribution Arrangement (QACA) contributions after the completion of two years of services. Participants will become 100% vested in other Company contributions after the completion of three years of service. A participant becomes 100% vested at age 65, or in the event of disability or death.

**Notes Receivable From Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear a fixed rate of interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates of similar notes at the time the note is originated. All notes must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home notes that may be repaid over a period not to exceed fifteen years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

**Payment Of Benefits** - Payments of benefits are permitted in various methods depending upon whether the request for payment results from retirement, in-service death, an event of disability or termination. The Plan administrator may allow distribution of 100% of the participant's contributions and vested portion of Company contributions in cases of hardship. Balances less than \$5,000 may be paid in lump-sum distributions, without requiring participant approval.

**Forfeited Accounts** - Forfeitures of Company contributions resulting from the termination of participants with less than fully vested rights under the Plan shall be used to reduce future contributions, pay certain Plan expenses or be allocated to the remaining participants of the Plan. During 2024 and 2023, the Plan utilized approximately \$138,900 and \$23,800, respectively, of forfeitures to reduce Company contributions and pay Plan expenses. At December 31, 2024 and 2023, approximately \$169,600 and \$164,000, respectively, of forfeitures were available for future use.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis Of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation And Income Recognition** - Investments in registered investment companies and pooled separate accounts and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in fully benefit-responsive insurance contracts are reported at contract value. Contract value is the price participants would receive if they were to initiate permitted transactions under the terms of Plan.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Use Of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Payment Of Benefits** - Benefits are recorded when paid.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for uncollectible participant notes has been recorded as of December 31, 2024 and December 31, 2023.

**Plan Expenses** - Substantially all Plan expenses are paid by the Company, outside of the Plan.

NOTE C - CERTIFIED ASSETS

All information on investments and notes receivable from participants included in the accompanying financial statements and schedule was obtained or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. The Plan held no level 2 or 3 investments in 2024 or 2023.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts** - These investments are accounts maintained by an insurance company for the collective investment and reinvestment of assets contributed thereto from employee benefit plans maintained by more than one Company or controlled group of corporations. They are valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment, the insurance company reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan currently offers a fixed income guaranteed option through Principal Life Insurance Company.

NOTE E - INSURANCE CONTRACT - CONTINUED

The Principal fixed income guaranteed option is a benefit-responsive group annuity contract. The methodology for calculating the interest crediting rate is defined by the contract. Under the terms of the contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate. Amounts allocated to the fixed income option are backed by the Company's general account. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in the general account assets. Withdrawals to pay participants benefits from the fixed income option are made at contract value.

NOTE F - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company, custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Approximately 9% and 11% of Plan investments are invested in funds managed by Principal Trust Company as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment management services and administrative services totaled \$124,481 and \$119,520 for the years ended December 31, 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$1,639,347 and \$1,566,681, respectively.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE H - TAX STATUS

The Plan has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator timely adopted the prototype plan. The Plan administrator believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE I - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

NOTE J - SUBSEQUENT EVENTS

The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through August 29, 2025, the date the financial statements were available to be issued.

NOTE K - PARTIAL PLAN TERMINATION

Effective December 2023, the Company sold part of a division resulting in a partial plan termination. Upon termination, the effected participants were immediately fully vested in their employer match contributions. Pursuant to the terms of the sale, the effected participants will be provided the opportunity to transfer their account balances to the Lineage Logistics 401(k) Plan in 2024.
