Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### 1. DESCRIPTION OF THE PLAN

The following description of JJF Management Services, Inc. 401(k) Plan (the Plan), is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

##### *General*

The Plan is a defined contribution plan covering substantially all employees of JJF Management Services, Inc. and participating employers (the Company) who are at least 18 years old. Employees are eligible upon date of hire but are not enrolled until the first pay cycle of the upcoming quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan. Participants can also make Roth and after-tax contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Effective February 1, 2023, JJF Management Services, Inc., implemented an Employee Stock Ownership Plan (ESOP) and effectively ceased making the 1% employer contributions to the JJF Management Services, Inc. 401(k) Plan.

Effective October 1, 2023, eligibility requirements to join the Plan were removed, except the associates must by 18 years of age requirement. Entry for eligible associates is immediate, beginning the first quarterly pay cycle. Additionally, all new associates will be auto enrolled at 5%.

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan.

##### *Participants' Accounts*

Each participant's account is credited with the participant's contributions, the Company's fixed contributions, as well as allocations of the Company's discretionary contribution, if any, and plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's fixed and prior discretionary contributions is based on years of continuous service. A participant is 20 percent vested after two years of service is completed and vested an additional 20 percent per year until full vesting after six years.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years.

*Notes Receivable from Participants (Continued)*

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Principal and interest are paid through payroll deductions.

*Payment of Benefits*

Benefits are payable upon retirement at age 65, early retirement at age 55 with ten years of service, disability, death, or termination of employment. In-service withdrawals at age 59½ and hardship withdrawals are also permitted, subject to provisions described in the plan document which were amended January 1, 2020. Withdrawals from rollover and after-tax contributions are permitted at any time. Benefits are payable in lump sum and installment payments.

*Forfeitures*

Terminating participants forfeit the non-vested portions of the participants' employer contributions. Forfeitures can be used to pay administrative costs, restore previously forfeited account balances as necessary, or reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$48,775 and \$115,264, respectively. These accounts will be used to offset administrative costs or reduce future Company contributions. During 2024, \$139,564 of forfeitures were used to reduce Company contributions and administrative costs.

*Administrative Expenses*

Certain expenses to maintain the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The Plan presents its financial statements under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

*Investment Valuation and Income Recognition (Continued)*

Investments reported at fair value include shares of registered investment companies (mutual funds) are valued at the published net asset values of shares held by the Plan at year end. The net asset values represent the current market values of the underlying assets of the funds. Purchases and sales of investments are recorded on a trade date basis. Unrealized appreciation and depreciation in the fair value of investments are recognized in the financial statements in the period in which such changes occur.

Other income is made up of rollover distributions, loan payoffs, and credited earnings revenue that the Plan used to pay administrative fees.

*Notes Receivable from Participants*

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

*Payment of Benefits*

Benefits are recorded when paid.

**3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Matrix Trust Company, the trustee of the Plan, has certified completeness and accuracy of all investment balances, related investment activity, notes receivable from participants, and related interest income from notes receivable from participants reflected in the accompanying financial statements and supplementary schedule.

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the accounting literature are described as follows:

*Level 1* - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for the substantially full term of the asset or liability.

*Level 3* - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at quoted net asset value (NAV) of shares held by the Plan on the last business day of the plan year.

*Common Collective Investment Trusts:* The fair value of the common collective trust funds is based on the net asset value (NAV) on the last business day of the plan year provided by the entity holding the trust funds. The NAV of the common collective trusts is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of underlying assets in the trusts, less the liabilities. These investments can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits, or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024.

The preceding methods described may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. RELATED PARTY TRANSACTIONS**

Certain plan investments are managed by affiliates of Matrix Trust Company. Matrix Trust Company was the trustee as defined by the Plan. Certain plan investments are managed by OneAmerica, an affiliate and subservice organization to Matrix Trust Company. These transactions qualify as exempt party-in-interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts.

**7. TAX STATUS**

Effective October 1, 2015, the Plan is a volume submitter plan of OneAmerica Financial Partners, Inc., which received an opinion letter on March 31, 2014, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**7. TAX STATUS (CONTINUED)**

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under that guidance, the Plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities based on the technical merits of the position. For the Plan, a tax position is the Plan's tax-exempt status under the provisions of the Internal Revenue Code (IRC) and ERISA. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits related to uncertain tax positions identified or recorded as liabilities for the year ended December 31, 2024.

The Plan's policy would be to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements. No interest and penalties were assessed or recorded during the year ended December 31, 2024. The Plan's Forms 5500, *Annual Return/Report of Employee Benefit Plan*, is open for inspection by the taxing authorities, generally for three years after filing.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) was signed into law on March 27, 2020, and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) was signed into law December 29, 2019. These laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

Effective April 17, 2020, certain provisions were implemented under the CARES Act. The Plan will be formerly amended for the CARES Act and the SECURE Act provisions elected in accordance with applicable law and IRS guidance. Under Notice 2022-33 and Notice 2022-45, the IRS has extended the deadline for retirement plans to adopt the amendments required by the SECURE Act and the CARES Act until December 31, 2025.
