## Independent Auditors' Report

### **The Plan Administrator of President Container Group II, LLC 401(k) Plan**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### 1. Plan Description

The following description of President Container Group II, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the summary plan description or the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution profit-sharing plan that provides cash or deferred future benefits pursuant to applicable sections of the Internal Revenue Code (the "IRC"). The Plan covers all eligible employees of President Container Group II, LLC (the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### ***Eligibility and Enrollment***

Employees (except for employees covered by a collective bargaining agreement, leased employees, or non-resident aliens) who have attained 21 years of age are eligible to make elective deferrals to the Plan. All new employees will be eligible to enter the Plan on the first day of each calendar month. To be eligible for matching contributions, employees must attain 21 years of age and complete one year of service.

#### ***Contributions***

Each year, eligible employees may elect to have up to 100% of their eligible compensation, as defined by the Plan, deducted on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. There is an annual limit as to the amount that can be contributed that is determined by the IRC. The Plan permits participants to contribute amounts representing distributions from other qualified plans.

At the employer's sole discretion, the Company may make a matching contribution on behalf of each eligible employee in an amount equal to 20% of the participant's contributions up to 6% of their eligible compensation. The matching contributions for 2024 were \$69,770.

In addition, the Company may make a non-elective discretionary contribution on behalf of each eligible employee. No non-elective discretionary contributions were made to the Plan for the 2024 or 2023 Plan years.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant directed.

### 1. Plan Description (*continued*)

#### ***Vesting***

Participants are fully vested in their contributions plus actual earnings thereon. Vesting in employer matching contributions is as follows:

Period of Service	Vested Percentage
Less than 2 full years	0%
2 full years	20%
3 full years	40%
4 full years	60%
5 full years	80%
6 or more full years	100%

#### ***Forfeitures***

If a participant terminates their employment with the Company, the non-vested contribution plus allocated earnings thereon may be used to reduce future employer contributions. Any remaining forfeitures not used to reduce employer contributions may be used to reduce administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts totaled \$12,101 and \$4,708. During 2024, no employer contributions or administrative expenses were reduced by the forfeited non-vested accounts.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at a rate of prime plus 1%. Loans must be repaid within a five-year period unless the loan is made for the purchase of a principal residence in which the period can be more. Principal and interest is paid ratably through periodic payroll deductions. A participant may not have more than 2 loans outstanding from the Plan.

#### ***Payment of Benefits***

Under the terms of the Plan, a participant may make a withdrawal for reasons of economic hardship prior to attaining age 59½. Such hardship withdrawals are available for immediate and heavy financial need and only when other financial resources are exhausted. Upon attaining age 59½, participants may withdraw their entire vested account balance or a portion thereof, no more frequently than once in a Plan year. Upon termination of employment prior to retirement, Plan participants with account balances greater than \$5,000, may elect to defer distributions to normal retirement age. Participants with account balances less than \$5,000 will receive a lump sum cash payment as soon as practicable following termination of employment.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, the pooled separate accounts are not categorized within the fair value hierarchy since fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient.

#### ***Investment Valuation and Income Recognition***

All investments of the Plan are stated at fair value except for the guaranteed investment contracts, which are stated at contract value. The pooled separate accounts are valued at the NAV of units held by the Plan. The NAVs, as provided by the trustee of the accounts, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. The guaranteed investment contracts are reported at contract value, which represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Excess Contributions Payable***

Amounts payable for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 contributions to the applicable participants prior to March 15, 2025 and 2024.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 8, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, a qualified institution.

### 4. Guaranteed Investment Contracts

The Plan has two fully benefit-responsive guaranteed investment contracts, which are the Guaranteed Stable Value Account and the Managed Principal Protection Portfolio. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in the guaranteed investment contracts at contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or participants.

#### ***Guaranteed Stable Value Account***

The Guaranteed Stable Value Account (the "Account") is backed by the general assets of Lincoln National Life Insurance Company. The Account is designed to provide plan participants with a guaranteed return of principal, along with attractive crediting rates and liquidity. The crediting rate is calculated and reset quarterly. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate. In addition, a market value adjustment may apply at plan or contract termination.

The Plan requires that any funds transferred by a participant from the Account remain in a noncompeting fund for a minimum of 90 days before the participant may transfer such funds to a competing fund. It also requires that if any funds from a noncompeting fund are transferred by a participant to a competing fund, no further transfers from the Account by the participant may occur for a period of 90 days.

### 4. Guaranteed Investment Contracts (*continued*)

#### ***Managed Principal Protection Portfolio***

The Managed Principal Protection Portfolio is backed by the general assets of Lincoln National Life Insurance Company. The Managed Principal Protection Portfolio has a guaranteed minimum interest rate and a portfolio interest crediting rate. The portfolio interest crediting rate is the rate that will actually be applied to assets in the Managed Principal Protection Portfolio and will always be at or above the guaranteed portfolio interest rate of 1.00%. The portfolio interest crediting rate may change quarterly. In addition, a market value adjustment may apply at Plan or contract termination.

The credit risk of The Lincoln National Life Insurance Company, as evaluated by nationally recognized statistical rating agencies, is as follows: Moody's Investors Service (A2 as of September 2024), Standard and Poor's (A+ as of July 2024), A.M. Best (A as of February 2025), and Fitch (A+ as of July 2024).

### 5. Pooled Separate Accounts

The Plan offers various pooled separate accounts as investment options under the Plan. The pooled separate accounts have different investment objectives, investment policies, and risks. The pooled separate accounts are direct filing entities and have no unfunded commitments.

### 6. Tax Status

The IRS issued an opinion letter to the prototype plan document preparer, Lincoln National Life Insurance Company, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examination for any tax periods in progress.

### 7. Party-in-Interest Transactions

All Plan investments are managed by Lincoln. Lincoln is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans are secured by the vested balances in the participant accounts. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
