Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Northern Corporation Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Great Northern Corporation Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Great Northern Corporation Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of Great Northern Corporation and its subsidiaries, StrataGraph LLC, Great Northern - Twin Cities, LLC, and Great Northern Instore, LLC (collectively referred to as the "Company"), who are not covered by a collective bargaining agreement, and not considered leased employees or summer help. Employees are eligible to participate in employee deferrals and receive the Company match on the first day of the month following completion of three months of service. Employees are eligible to receive the discretionary profit sharing contribution after completion of one year and 1,000 hours of service, and must be an active participant on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Retirement Plan Committee (the "Committee") is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitoring of investment performance.

On January 1, 2019, the United Displaycraft, Inc. 401(k) Profit Sharing Plan was merged into the Plan. The Plan does not permit participant loans, but in accordance with the merger, pre-existing participant loans were transferred and will continue to be paid in accordance with their respective agreements. No new participant loans are allowed to be taken in the Plan. The adopting employer of the United Displaycraft, Inc. 401(k) Profit Sharing Plan is Great Northern Instore, LLC.

Contributions

Each year, participants may contribute to the Plan up to the maximum allowable limits of the Internal Revenue Service (IRS) on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation with no annual increase in the automatic rate.

During 2024, the Company contributed a safe harbor matching contribution of 100% of the first 3% of deferrals that a participant contributed to the Plan plus 50% of the next 2%. Rollover contributions are not matched. In addition, the Company has the option of making a discretionary profit sharing contribution, which is determined by the Board of Directors. For the year ended December 31, 2024, the Company made a \$9,977,734 discretionary profit sharing contribution to the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, (b) plan earnings (losses) and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are reduced by withdrawals and are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and the Company's safe harbor matching contributions, plus related earnings thereon. The Company's discretionary profit sharing contributions and related earnings thereon become 20% vested after one year of credited service. The vesting percentage increases an additional 20% each year thereafter, with 100% vesting after five years of credited service. In addition, participants become 100% vested upon reaching normal retirement age, disability, or death.

Notes Receivable From Participants

Notes receivable from participants are not allowed by the Plan. Due to the merger as previously discussed, participant loan balances transferred into the Plan. The notes are secured by the balance in the participant's account and bear interest at 5.00%. Principal and interest are paid ratably through biweekly payroll deductions.

Excess Contributions Payable

Contributions in excess of amounts allowed by the IRS during 2024, totaling \$134,754, are recorded as a liability on the statements of net assets available for benefits at December 31, 2024. This amount includes \$9 of excess Company matching contributions, which will be used to offset Company matching contributions in 2025 and is recorded as a reduction to Company contributions on the statement of changes in net assets available for benefits. The remainder will be distributed to participants during 2025, and is recorded as a reduction to participant contributions on the statement of changes in net assets available for benefits as it relates to excess participant contributions.

Contributions in excess of amounts allowed by the IRS during 2023 totaling \$159,936, are recorded as a liability on the statements of net assets available for benefits at December 31, 2023. This amount includes \$911 of excess Company matching contributions, which were used during 2024 to offset Company matching contributions. The remainder was distributed to participants during 2024, as it related to excess participant contributions.

Note 1: Description of Plan (Continued)

Payment of Benefits

Plan benefits are available at termination due to normal retirement (age 65), death, disability, or termination of employment with vested interests. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. The Plan also allows for in-service distributions upon attaining age 59 1/2 and for financial hardship, if certain criteria are met. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary profit sharing contributions. Forfeited nonvested accounts totaled \$232,971 at December 31, 2024, and \$443,462 at December 31, 2023. Forfeitures may be first used to pay plan expenses, reduce Company contributions, or can be allocated to participant accounts. No forfeitures were used to pay plan expenses during 2024. Forfeitures of \$269,279 were used to reduce Company discretionary profit sharing contributions and \$228,983 were allocated to participant accounts during 2024.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing laws for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Principle areas of the act addressed participant saving assistance, required minimum distributions (RMD), catch-up contributions, and lost participants. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings, automatic enrollment and automatic increases, and the RMD provisions required for 2023 which have already been adopted by the Plan. The Plan also adopted provisions to allow distributions for emergency expenses and for penalty-free distributions in cases of domestic abuse, as well as increased the dollar limit for mandatory distributions effective January 1, 2024. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, and the participant has reached a distributable event, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan (except fees for withdrawals and loan maintenance) are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trust: The Principal Stable Value Preferred Fund is a common/collective trust composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value ("NAV") of units of the bank collective trust (primarily synthetic investment contracts). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. This fund can be redeemed daily with no redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Life insurance contracts: Valued at the cash surrender value of the policies, which approximates fair value based on discounted cash flows.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts (excluding real estate fund): Carried at NAV per share or its equivalent and valued as a practical expedient. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's share price is quoted on a private market that is not active; however, the share price is based on underlying investments, which are traded on an active market. These funds can have one transfer per 30 days with no other redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Real estate pooled separate account (U.S. Property Separate Account): Carried at NAV per share or its equivalent and valued as a practical expedient. NAV is estimated using discounted cash flow valuation models that utilize public real estate market data inputs, such as transaction prices, market rents, vacancy levels, leasing absorption, market cap rates, and discount rates. In addition, each property is appraised annually by an independent appraiser. This fund can have one transfer per 30 days with no other redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the custodian of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their Company discretionary profit sharing contributions.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Principal, the custodian of the Plan and therefore, transactions with Principal qualify as party-in-interest transactions. Administrative and investment expenses paid by the Plan to Principal amounted to \$136,830 during 2024. Certain other fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
