We have performed audits of the financial statements of Blackhawk Community Credit Union 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blackhawk Community Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Blackhawk Community Credit Union 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Blackhawk Community Credit Union (the Employer). An employee becomes eligible to participate in the Plan after reaching the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Each year, participants may contribute up to 100% of pre-tax or after tax annual compensation, as defined by the Plan and subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation on a pre-tax basis, which increases to 6% after four years unless changed by the participant. During 2024, the Employer made safe harbor matching contributions of 100% of a participants' elective deferrals up to 5% of eligible compensation. Additional profit sharing amounts may also be contributed at the discretion of the Employer. In order to share in the discretionary profit sharing contributions, participants must be employed on the last day of the Plan year, terminate due to death, disability, or retirement, or complete more than 500 hours of service during the Plan year. No such discretionary profit sharing contributions were made by the Employer during the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer safe harbor matching contributions, as well as allocations of Employer discretionary profit sharing contributions, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contributions are as follows.

Discretionary profit sharing contributions are vested based on the following schedule:

Notwithstanding the above, participants shall become 100% vested in their Employer contribution portion of their account upon attaining normal retirement (age 64), early retirement (age 50 and at least six years of service), their death, or becoming totally or permanently disabled.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Note repayment terms range from one to five years (longer if the note is made for the purchase of a primary residence). The notes are secured by the vested balance in the participant's account and bear interest at a reasonable rate determined by the Plan administrator. Participants are allowed to have only one note outstanding. At December 31, 2024, the interest rate on outstanding notes was 4.25-9.50%. Principal and interest are paid ratably through payroll deductions.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution, substantially equal installments, or partial withdrawals. Distributions to terminated participants with vested account interests of \$1,000 or less are made as a lump-sum distribution without the participant's consent. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants, while still employed, may receive an in-service distribution from their 100% vested accounts upon attaining age 59 ½ or may receive a hardship distribution from their salary deferral account, subject to Plan provisions.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeitures are used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, Employer contributions were reduced by \$5,857 from forfeited nonvested accounts. During the year ended December 31, 2024, expenses of \$1,400 were paid from forfeited nonvested accounts.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

The Employer pays certain administrative expenses on behalf of the Plan which are excluded from these financial statements. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds held in pooled separate accounts:* Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission.

### Note 4: Information Prepared and Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, the fully benefit responsive investment contract, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by CMFG Life Insurance Company, the Custodian of the Plan.

### **Note 5: Fully Benefit-Responsive Investment Contracts**

The Plan invests in a FBRIC with CUNA Mutual Group (CMG) in the form of a guaranteed investment contract (GIC). CMG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. CMG is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contractor issuer or otherwise. The crediting rate is based on the best interest rate that is consistent with the performance of CMG's general account assets.

Certain events limit the Plan's ability to transact at contract value with CMG including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants or the issuer are probable of occurring. The GIC does not permit CMG to terminate the agreement prior to the scheduled maturity date.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by CMFG Life Insurance Company or its affiliates. CMFG Life Insurance Company is the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the contract administrator fees were \$2,600 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from prohibited rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **Note 8: Tax Status**

The Plan adopted a nonstandard prototype document with an IRS determination letter dated June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
