Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Stowers Machinery Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. (1) Description of plan

The following description of the Stowers Machinery Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was adopted on January 1, 1965 to provide retirement benefits for employees of Stowers Machinery Corporation ("Plan Sponsor"). The Plan covers substantially all full-time employees who are age eighteen or older and have completed thirty days of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Participants may contribute eligible pretax or aftertax (Roth) annual compensation up to the maximum percentage and amounts allowed by the Internal Revenue Code ("IRC"). Eligible compensation as defined in the Plan primarily excludes overtime, bonuses, and commissions. Participants may also contribute rollover amounts from other qualified plans and pre-tax Individual Retirement Account assets into the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan automatically enrolls all new employees at a deferral rate of 5%, unless the employee elects to not participate in the Plan or elects otherwise. Each enrolled employee's deferral percentage automatically increases by 1% on June 1 of each year unless the employee elects otherwise. The automatic increases continue up to the maximum deferral rate permitted by the IRC. Plan participants who have suspended their deferrals are automatically re-enrolled each year at the same deferral rate as a new employee unless they elect to continue not deferring funds into the Plan.

The Plan Sponsor may elect to make a discretionary percentage match of contributions to those participants still employed on the last day of the Plan year. The Plan Sponsor elected to make a discretionary match of 100% of the first 4% of compensation contributed and 70% of the next 4% of compensation contributed by employees during calendar year ended December 31, 2024 and 200% of the first 3% of compensation contributed and 162.5% of the next 2% of compensation contributed by employees during calendar year ended December 31, 2023.

(c) Participant accounts

Each participant's account is credited with the Plan Sponsor's contributions as calculated above and the participant's contributions. Each participant account is credited or charged with the actual earnings (losses) of the investment options selected by the participant and an allocation of administrative expenses. Allocations of administrative expenses are based on account balances as defined in the plan agreement. Participants can change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are fully vested in all accounts; benefits cannot be forfeited for any reason.

(e) Notes receivable from participants

The Plan does not permit participants to borrow from their accounts.

(f) Payment of benefits

Distributions of benefits are available in the form of partial withdrawals or installment payments for participants who have reached the normal retirement age of 65, or early retirement age of 55, or who are required to receive minimum distributions under the IRC. All other participants are required to take a lump sum payment. Retirement benefits are distributed as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

(g) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

(h) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to trustee, administrative, and advising services paid from the assets of the Plan are charged to the participant accounts and are included in administrative expenses. Fees incurred and paid by the Plan for investment management services are included in net appreciation in fair value of investments.

(i) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Under the provisions of the Plan, the trust has been declared irrevocable. Should the Plan be discontinued, Nationwide Trust Company, FSB, ("Nationwide") will continue to administer the fund exclusively for the benefit of participants or their beneficiaries. The trust agreement expressly prevents any portion of the fund from reverting or becoming the property of the Plan Sponsor.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and August 29, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments presented and disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by Nationwide.

(4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2024 and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Plan at year end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a profit sharing retirement plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the form of the profit sharing plan is acceptable under the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

As described in Note (1), the Plan paid expenses to various service providers which qualify as party-in-interest transactions.

(7) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
