*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### *Other Matter*

#### *Supplemental Schedule Required by ERISA*

### Note 1 - Description of Plan

The following description of the Shore Line Delivery Employees' Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees covered by a collective bargaining agreement, as defined by the Plan, of Shore Point Distributing Company Inc. (the "Company") who have completed 90 days of service. The Plan is subject to the provisions of ERISA. The Plan administrator and Plan trustee are responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustee.

#### **Contributions**

##### **Employees**

Participants may elect to defer up to 100% of pre-tax annual compensation, subject to certain Internal Revenue Service ("IRS") limitations. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a money market fund as investment options for participants. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Contributions are subject to certain IRS limitations.

Participants may elect to have all or a portion of deferrals to be Roth Elective Deferrals, which are deferrals includible in the participant's gross income at the time deferred. In addition, each participant may elect to defer up to 100% of any cash bonus paid by the employer during the Plan year.

A participant may, with the consent of the Plan, make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from other qualified plans in which employees participated prior to their employment with the Company.

##### **Employer**

Each year, the Company may make discretionary contributions to participant plan accounts in which the participants are automatically 100% vested. The Company made no such contributions in either 2024 or 2023.

The employees entered into three collective bargaining agreements in which participants employed during the Plan year were eligible to share in the nonelective employer contributions. The Plan includes an auto-enrollment provision whereby all eligible employees receive employer contributions in the Plan after 90 days of service.

Effective on April 1, 2020, under the collective bargaining agreement that expires on March 31, 2025, for warehousemen and driver union employees, employees receive a contribution from the Company of \$4.00 per hour up to a maximum of forty hours per week. The Company contribution amount will increase by \$0.50 on the first day of each year the agreement is in effect (\$6.00 as of December 31, 2024).

Subsequent to year ended December 31, 2024 and effective on April 1, 2025, the Company entered into a new collective bargaining agreement expiring on March 31, 2030 for warehousemen and driver union employees to receive a contribution from the Company of \$6.25 per hour up to a maximum of forty hours per week. The contribution amount will increase on the first day of each year the agreement is in effect by 19 cents first two years, and 20 cents the remaining three years.

The Company entered into an additional collective bargaining agreement for sales representatives that expires on February 28, 2025. Effective January 1, 2021, employees receive a contribution of 4.5% for weekly pay to the plan and will match 100% of an employee's contributions up to the first 3% of the employee's compensation. The Company contribution percentage will increase by 0.25% on the first day of each year the agreement is in effect (5.25% as of December 31, 2024).

Subsequent to year ended December 31, 2024 and effective on April 1, 2025, the Company entered into a new collective bargaining agreement expiring on March 31, 2030. Effective January 1, 2025, sales representative to receive a contribution of 5.25% of weekly pay to the Plan and will match 100% of an employee's contributions up to the first 3% of the employee's compensation. The Company contribution percentage will increase by 0.25% on the first day of each year the agreement is in effect.

The Company also entered into an additional collective bargaining agreement for nonalcoholic division expiring on May 1, 2025. Effective May 15, 2024, employees receive a contribution of 5.25% for weekly pay to the Plan and will match 100% of an employee's contributions up to the first 3% of the employee's compensation.

Subsequent to year ended December 31, 2024 and effective May 1, 2025, the Company entered into a new collective bargaining agreement expiring on April 30, 2026. Effective on May 1, 2025, nonalcoholic division employees to receive a contribution of 5.25% of weekly pay to the Plan will match 100% of an employee's contributions up to the first 3% of the employee's compensation. The Company contribution percentage will increase to 5.50% on January 1, 2026.

The Company made contributions to the Plan of \$1,445,019 for the year ended December 31, 2024.

#### **Participant accounts**

Each participant's account is credited with the participant's contributions and the Company's discretionary and nondiscretionary contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Each participant's elective deferrals and contributions made in accordance with the collective bargaining agreement are fully vested at all times, including employer contributions.

#### Notes receivable from participants

Participants may obtain loans from the Plan, subject to approval by the Plan administrator. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. There is a maximum of two loans that may be outstanding at one time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions over a period that may not exceed five years, except for loans used to purchase a principal residence as to which the repayment period is at the discretion of the Plan administrator.

#### Payment of benefits

Upon termination of service due to death, disability, retirement or upon attainment of age 59 and a half, participants may elect to receive their account balance in either a lump-sum cash amount or monthly, quarterly, semiannual or annual cash installments. Participants may not receive distributions prior to termination of service due to death, disability, retirement or reaching age 59 and a half, unless the distribution is for a proven financial hardship.

#### Note 2 - Summary of accounting policies

##### Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and Plan trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant's compensation is earned.

#### Payment of benefits

Benefits are recorded upon payment to participants. As of December 31, 2024, amounts allocated to the accounts of participants who have elected to withdraw from the plan but have not yet been paid amounted to \$148,769.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of mutual funds.

#### Subsequent events

The Plan has evaluated subsequent events through June 19, 2025, which is the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds/Money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds and a money market fund managed by Charles Schwab Bank. Charles Schwab Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator totaling \$6,050, which were not covered by revenue sharing. The Company pays directly any other expenses related to the Plan's operations.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 6 - Tax status

The underlying nonstandardized prototype plan obtained its latest opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "Code"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Bank, the custodian of the Plan.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
