1. Description of the Plan

The following description of the Samuel Shapiro & Co., Inc. (the Company) Savings and Profit Sharing Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering most full-time employees of the Company with a minimum age of 21 years that have completed 90 days of service. Employees enter the Plan on the first day of the month coinciding with or next following the date all requirements are met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions - Participants may contribute up to 100% of their eligible compensation for each year in which they are a participant in the Plan up to the maximum allowable contributions under the Internal Revenue Code (IRC). The Plan allows for pre-tax and Roth deferrals. The Plan provides for automatic enrollment of a 3% pretax deferral of eligible compensation, which will increase every January 1 by 1% up to a maximum of 6%, for newly eligible employees, unless the employee affirmatively elects to make no pretax contributions or elects to make pretax contributions of a different amount. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions subject to limitations imposed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit plan or defined contributions plans. The Company provides safe harbor matching contributions on employee deferrals. The Company's safe harbor matching contributions are 100% of deferrals up to 1%, and 50% of deferrals in excess of 1% but not exceeding 6% of annual compensation. The Company may make additional discretionary profit sharing and matching contributions at the discretion of the Board of Directors. There are no allocation conditions to be eligible to share in these discretionary contributions. These contributions are to be credited to participants in an amount equal to a uniform percentage of each eligible individual's compensation. There were no discretionary profit sharing or matching contributions made during 2024. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.
- C. Participant Accounts - Each participant account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor and discretionary profit sharing and matching contributions are based on years of service, as defined by the Plan. A participant is 100% vested in the Company's safe harbor contribution after two years of credited service and in the Company's discretionary profit sharing and matching contributions after four years of credited service. A participant is 100% vested upon death, termination due to permanent disability, or early retirement, or if the Plan is terminated or partially terminated.

1. Description of the Plan (continued)

- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with the prime rate as listed in The Wall Street Journal on the first business day of the month in which the loan is requested, plus 1%. The term of loans cannot exceed a period of 5 years. The maximum number of loans outstanding for a participant at any one time is two and the loan origination dates must be at least 18 months apart. Principal and interest are paid ratably through payroll deductions.
- F. Payment of Benefits – Upon termination of employment or termination of service due to death, disability, or retirement, a participant or their beneficiary, in the event of death, is entitled to the distribution of their vested account balance. A participant who has attained age 59 ½ and has been a participant for at least four years may elect to withdraw an amount equal to all or a specified portion of the value of his or her vested account.

If a participant's vested account balance is greater than \$7,000, the participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, installments over time, or partial withdrawals. If a participant's vested account balance does not exceed \$7,000, but is greater than \$1,000, the participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or the Plan can transfer the balance into an IRA outside the Plan. If a participant's vested account balance is less than \$1,000 upon termination of service and no distribution election is made by the participant, the plan administrator will direct the trustee to make a lump-sum payment. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, participants are allowed to take hardship withdrawals from their vested account balance. Participants may also elect an in-service distribution from their vested account balance resulting from rollover contributions. Such distributions are paid directly to an eligible retirement plan specified by the participant in a direct rollover. If less than the entire amount of an eligible rollover distribution is paid directly to an eligible retirement plan, the minimum partial rollover must equal at least \$500. Qualified reservist distributions are also allowed in the Plan. Distributions are subject to the applicable provisions of the plan agreement. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, no amounts were payable to participants who had elected to withdraw from the Plan.

- G. Forfeited Accounts - Nonvested amounts will be forfeited by participants when the vested portion of their account is distributed. Any forfeitures may be used to reinstate previously forfeited account balances of participants, to satisfy certain contributions as defined by the plan document, and to pay administrative expenses of the Plan. Any remaining forfeitures are then allocated to reduce the same type of future contribution (i.e.: forfeitures attributable to matching contributions are used to reduce future matching contributions for the plan year). Lastly, forfeitures in excess of these amounts are to be allocated to participants as an additional contribution. At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$4 and \$4, respectively. For the year ended December 31, 2024, forfeitures of \$5,009 were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Expenses of maintaining the Plan are paid directly by the Plan and are included in administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 at the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Guaranteed Investment Contract with Empower Annuity Insurance Company of America

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Guaranteed Investment Contract with Empower Annuity Insurance Company of America (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$659,496 and \$725,903, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related Party Transactions

The Plan invests in a fixed annuity managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the trustees and Empower Retirement, LLC is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

9. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

10. Subsequent Events

The Plan has evaluated subsequent events through August 10, 2025, the date the financial statements were available to be issued.
