We have audited the financial statements of the **Fanning/Howey Associates, Inc. 401(k) Profit Sharing Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024 and have issued our report thereon dated August 19, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company, the Trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 14, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the Plan's financial statements in the proper period.

Qualitative Aspects of Accounting Practices – continued

Accounting estimates are an integral part of the Plan's financial statements prepared by management and are based on Plan management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the Plan's financial statements, and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the Plan's financial statements was management's estimate of the allowance for uncollectible loans receivable. We evaluated the key factors and assumptions used to develop the estimate in determining that it is reasonable in relation to the Plan's financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to the Plan's financial statement users. The most sensitive disclosures affecting the Plan's financial statements are the disclosure describing the Plan (Note 1), the disclosure for certified investments (Note 3), the disclosure for fair value measurements (Note 4), the disclosure for related party transactions (Note 6), and the disclosure for the tax status of the Plan (Note 8).

The Plan's financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with Plan management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of our audit procedures.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

Reportable Findings – continued

During our testing of distributions, we noted that documentation to verify three participants' hire dates and termination dates was not available. During our testing of participant data, we noted that documentation to verify one participant's termination date was not available. We recommend that Plan management ensure that documentation for dates of hire and termination is maintained for all employees.

During our testing of participant data, we noted that one participant (Timothy Placie) deferring 5% with a \$5,567 limit; however, the supporting documentation for the contribution limit could not be located. We recommend Plan management ensure that supporting documentation for the contribution is maintained for all employees.

During our review of internal controls around contributions, we noted that contributions are not being reconciled to trust reports on a periodic basis. We recommend that Plan management reconcile total contributions per payroll records to the trust reports or other online information from Ascensus on a monthly or quarterly basis. In addition, we recommend that contributions for the year per the payroll records be reconciled to the contributions per the annual trust statement provided by Ascensus. These controls will help to ensure that contributions are being properly classified by Ascensus and will help to ensure that all contributions are being remitted and received by Ascensus on a timely basis.

During our review of internal controls around distributions, we noted that there was no review of distributions. Although no discrepancies were noted in this area during the audit, this review is still a prudent business practice. We recommend the Plan management review distributions at least quarterly.

Disagreements with Management

For purposes of this letter, a disagreement with Plan management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the Plan's financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from Plan management that are included in the management representation letter dated August 19, 2025.

Management Consultations with Other Independent Accountants

In some cases, Plan management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements, or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with Plan management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

We communicated the significant risks of material misstatement identified as part of our audit planning in our letter to you dated April 14, 2025. We did not identify any additional significant risks in performing and completing our audit.

Other Matters
