**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Community West Bank Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

On April 1, 2024, Central Valley Community Bank, completed its acquisition of Community West Bank. Immediately after the merger, Central Valley Community Bank, as the surviving entity, changed its name to Community West Bank. The Plan was amended effective April 1, 2024, and the Plan name was changed to Community West Bank Retirement Plan.

General: The Plan was established with an effective date of January 1, 1983. The Plan is a safe harbor defined contribution plan covering all eligible employees of Community West Bank (the “Company”). The Administrative Committee of the Plan is responsible for administration and management of the Plan. All investments in the Plan are participant directed. Empower Retirement is the record keeper for the Plan and Empower Trust Company, LLC serves as the trustee and custodian for the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Under the Plan, generally all employees of the Company are eligible to begin salary deferrals on the first day of the month after completing one month of service.

Participants are eligible for employer safe harbor matching contributions after they have completed three months of service, and are eligible to receive employer safe harbor matching contributions during any quarter in which the participant contributes to the Plan regardless of the number of hours worked during the quarter or whether the participant is employed at the end of the quarter.

Participants are eligible for employer discretionary profit sharing contributions if they are employed as of the last day of the calendar year and have completed two years with at least 1,000 hours of service.

The Plan provides for automatic enrollment of eligible employees into the Plan at a 3% salary deferral contribution rate, with automatic annual re-enrollment provisions each June 1st at a 3% contribution rate for eligible employees not enrolled in the plan. Participants in the Plan whose salary deferral contribution rate is less than 3% will have their contribution rate automatically increased to 3%, and participants in the Plan whose salary deferral contribution rate is at least 3% will have their contribution rate automatically increased 1% annually, up to 10%, both as of June 1st. Plan participants may cancel their participation in the Plan or change their salary deferral contribution rate at any time.

Vesting: Participants are immediately 100% vested in all of their voluntary contributions, as well as in any employer safe harbor matching and discretionary profit sharing contributions.

Contributions: Each year, participants may make salary deferral contributions in any percentage of their pretax annual compensation, as defined in the Plan, subject to regulatory limitations. Participants may make after tax Roth 401(k) elective deferrals. Participants can also make after-tax deferrals up to \$5,000. The after-tax deferral is not eligible for Company matching contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes quarterly safe harbor matching contributions on the eligible participant’s behalf of 100% of the first 5% of the salary that the participant defers each quarter. The Company made matching contributions of \$1,653,771 during 2024.

The Company may make discretionary profit sharing contributions on behalf of the eligible participants. During 2024, the Company’s discretionary profit sharing contribution was \$550,000. Company contributions are subject to certain regulatory limitations.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, allocation of Company matching contributions, any discretionary profit

sharing contributions and Plan earnings, and charged with withdrawals, allocations of Plan losses, and administrative expenses. Allocations are based on participant earnings, as defined.

Participants' Investment Options: Participants direct all of their voluntary contributions and their portion of any employer contributions among any or all of the investment options offered by the Plan. Participants may change their investment options at any time through the custodian.

Notes Receivable from Participants: The Plan was amended effective April 1, 2024 to allow notes receivable from participants. Starting April 1, 2024 participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed fifteen years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 9.50%, with various maturities through December 2029.

Payment of Benefits: Generally, on termination of service due to death, disability, retirement, or other reasons, a participant shall receive a lump sum distribution equal to the value of the participant's vested interest in his or her account. Terminated participants whose account balance is less than \$1,000 automatically receive a lump sum distribution. Terminated participants whose account balance is between \$1,000 and \$5,000 will automatically have their account balance rolled into an individual retirement account in the event that the participant does not make a distribution election. Terminated participants with account balances greater than \$5,000 will have their funds remain in the Plan until the earlier of the date the participant requests a distribution, or age 65. At age 65, a terminated participant must receive a lump sum distribution or have their account balance rolled into an individual retirement account. If participants are a 5% or greater owner of the Company, they must receive their benefits no later than April 1 following the calendar year in which they attain age 70-1/2, regardless of their employment status. If participants are not a 5% or greater owner of the Company when they attain age 70-1/2 and they are still employed by the Company, they must wait until termination of employment to receive benefits, unless they elect to take a withdrawal. As of December 31, 2024 and 2023, there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net unrealized market appreciation of investments and net realized gains and losses on the sale of investments during the period.

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds, and a collective trust. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in these financial statements.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees: Administrative expenses are generally paid by the Company and participants. The Plan pays expenses related to contract administrator fees, professional fees and investment advisory fees. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 21, 2025, which is the date the financial statements were available to be issued.

### **NOTE 3 – CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee of the Plan, has certified to the completeness and accuracy of the following:

- a. Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Net appreciation in fair value of investments, dividends, and interest and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c. Investments reflected on the schedule of assets (held at end of year).

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair Value Hierarchy: Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the level in the fair value hierarchy within which the fair value measurement in its entirety falls has been determined based on the lowest level input that is significant to the fair value measurement in its entirety.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual Funds* – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Common/Collective Trusts* – Units held in common/collective trusts (CCTs) are valued using the NAV practical expedient of the CCTs as reported by the CCTs managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCTs, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information.

In regard to the CCTs, there were no restrictions regarding participant-initiated withdrawals, and no unfunded commitments. Although, should the Plan Sponsor direct distributions from the investments, the Plan Sponsor is required to provide the trustee of the investments at least 12 months written advance notice of intent to withdraw; however, at the discretion of the investment’s trustee, the notification period may be waived.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FEDERAL INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 20, 2013 that the Plan was designed in accordance with the applicable regulations of the Internal Revenue Code. The Plan has been amended subsequent to the receipt of the determination letter; however, the Administrative Committee of the Plan believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan continues to be tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to

routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are mutual funds issued by an affiliate of the record keeper or the custodian. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
