Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Norland International, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Norland International, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following brief description of Norland International, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan, which became effective January 1, 2000 and was most recently amended January 1, 2023, is a defined contribution plan covering certain groups of employees of Norland International, Inc. (the Company), who have attained the age of 19. Entry is available on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Elective Contributions. Each year eligible employees may make pre-tax salary and Roth reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 30 mutual funds and one collective trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their pre-tax contributions are invested in a designated target date fund that matches their retirement date based on their birthdate until changed by the participant.

Employer Contributions. The Plan allows for safe harbor matching contributions and discretionary nonelective contributions for employees who have attained age 19. The Company's safe harbor matching contributions of 100% of the first 3% of participant deferrals, plus 50% of elective deferrals between 3% and 5%. The Company made contributions of \$165,722 during the year ended December 31, 2024. The Company did not make a discretionary nonelective contribution for 2024.

Participant Accounts. Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions is based on years of service on a 6-year graded schedule. A participant is also fully vested if they incur severance from employment as a result of death or disability.

Payment of Benefits. On separation of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum or (b) substantially equal installments or (c) partial withdrawals with no minimum required. Distributions may be made to a participant who has not separated from service upon age 59½ or having incurred a hardship. Distributions may be made as soon as administratively feasible at the participant's election.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Payment of Benefits – Continued.

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$7,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election is made, the benefit will be rolled over to an IRA. If the account balance is less than \$1,000, the distribution will be paid in cash. If the vested account balance is greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for purpose specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

Forfeited Accounts. Forfeitures, if any, are used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, the account totaled \$567 and \$6,557, respectively. Forfeiture account balances used to pay plan expenses during 2024 totaled \$12,040.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition – Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Transfers between levels shall occur at the actual date of the event or change in circumstances that caused the transfer. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Investments measured at net asset value (NAV) per share (or its equivalent using the practical expedient in FASB's fair value measurement guidance) are not required to be categorized in the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE C - FAIR VALUE

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the years ended December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: Collective trust accounts are valued based on each underlying contract's pro-rata share of the fair value of the securities in the underlying separate accounts in which the contracts participate. Units of the Trust are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is computed by dividing the total assets of the Trust, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Trust and included in the determination of unit values.

NOTES TO FINANCIAL STATEMENTS

NOTE C - FAIR VALUE – CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

NOTE D – INVESTMENT IN COLLECTIVE TRUST

The Plan holds units of participation in the Reliance Trust Company Stable Value Fund Collective Investment Trust Series (the Trust), which is invested solely in the MetLife Group Annuity Contract 25053 for the years ended December 31, 2024 and 2023. The Trust provides for the collective investment of defined contribution plans. The underlying assets of the MetLife Group Annuity Contract is primarily in a pool of investment contracts that are issued by insurance companies and in contracts that are backed by bond funds. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries.

The Trust allocates its assets in proportion to each plan's beneficial interest in the Trust. At December 31, 2024 and 2023, the Plan's interest in the net assets of this Trust was less than .0004 percent.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The Plan is based on the Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA Plan of Union Bank & Trust Company, which received a determination letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's federal returns for 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS

NOTE H - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Union Bank & Trust Company (the trustee of the Plan). Accordingly, Union Bank & Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE I - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan receives custodial services from Union Bank & Trust Company and its affiliates, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also pays for recordkeeping services. Fees paid by the Plan to Union Bank & Trust Company were \$9,047 for the year ended December 31, 2024. Additional indirect compensation was paid to Union Bank & Trust Company and Matrix Clearance and Settlement, which is included in net appreciation in fair value of the investments. As described in Note B, the Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE J - SUBSEQUENT EVENTS

Subsequent events have been evaluated through the audit report date, the date the financial statements were available to be issued.
