### Note 1: Description of Plan

The following description of the NOG, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### General

The Plan is a participant-directed defined contribution plan sponsored by NOG, Inc. (the "Company"). Matrix Trust Company ("Matrix") is the Plan Custodian. Matrix holds the Plan's investment assets and executes investment transactions. One America Retirement Services LLC ("One America") is the Plan's third-party administrator ("TPA") and executes participant transactions.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility

The Plan allows for elective contributions (subject to Plan limitations) on behalf of all eligible employees. Generally, an employee is eligible to participate in the Plan if they have completed three continuous months of service and attained at least 18 years of age.

#### Contributions

The Plan has an automatic enrollment provision (5% salary deferral), whereby employees must elect out of the Plan if they do not wish to participate. Participants may change their deferral amount at any time. Each year, participants may defer a percentage of eligible earnings, not to exceed the limits of the Internal Revenue Service ("IRS"). For eligible participants, the Company matches 100% of salary deferrals up to the first 3% of eligible compensation, plus 50% of salary deferrals up to the next 2% of eligible compensation.

The Company has the option to make a profit sharing contribution to the Plan on behalf of all eligible participants. To be allocated a portion of the profit sharing contribution, a participant must be employed at some point during the Plan year. If employment is terminated, the participant is eligible to receive a portion of the profit sharing contribution. For the year ended December 31, 2024, no profit sharing contribution was made.

### **Note 1: Description of Plan (Continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant's elective deferrals, Company contributions, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses, or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in all contributions and any earnings or losses thereon.

#### **Investments**

Contributions to a participant's account can be invested in a variety of investment vehicles and are managed on the participant's behalf by the Plan's Custodian. Investment options are selected by participants and may be changed at any time. The Plan's Investment Committee periodically reviews the performance of each investment and adjusts investment offerings as necessary.

#### **Notes Receivable From Participants**

Participants may receive a note from their account balance with a minimum note of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

#### **Payment of Benefits**

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 60. Distributions may be deferred until the participant reaches the age of 73, provided the account balance is greater than \$7,000. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or an annuity. In addition, hardship distributions from the participant's vested account balance are permitted if certain criteria are met.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from these estimates and are subject to change in the near term.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Custodian. See Note 6 for details on inputs, valuation techniques, and fair value measurement levels within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Fees relating to the administration of notes receivable from participants are charged directly to the participant's accounts and are classified as administrative expenses. Fees charged by the TPA are paid by the Plan and are also classified as administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 20, 2025, which is the date the financial statements were available to be issued.

### Note 3: Party-in-Interest Transactions

The Plan holds investments in funds and accounts managed by the TPA of the Plan, pays fees to the Custodian, and holds notes receivable from participants. These transactions are party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations.

### Note 4: Information Prepared and Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix.

### Note 5: Risks and Uncertainties

The Plan invests in various investment securities that are exposed to certain risks inherent to interest rates, credit markets, and prevailing economic conditions. Accordingly, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 6: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 6: Fair Value Measurements (Continued)

*Stable value collective trust fund:* The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. As of December 31, 2024 and 2023 there were no unfunded commitments.

### **Note 7: Tax Status**

The IRS has determined and informed the Company by a letter dated November 30, 2020, that the Plan, as then designed and operated, was in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has since been amended to comply with new regulations, but has not applied for a revised determination letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan as currently designed and operated complies with the relevant sections of the IRC. The Plan is subject to income tax examinations generally for three years after they are filed. There are currently no examinations in process.

### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
