#### NOTE A - GENERAL DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees of the United States Liability Insurance Company (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may contribute up to \$23,000 and \$22,500 of pre-tax annual compensation during 2024 and 2023, respectively. In addition, participants who reach age 50 or older may make an additional pre-tax contribution (a "catch-up contribution") of up to \$7,500 during both 2024 and 2023. These contributions are made through payroll deductions and are directed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon.

**Participant Loans** - The Plan does not permit participant loans.

**Payment of Benefits** - On termination of service due to death, total disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, unless another form of payment is selected by the participant. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution if that interest did not exceed \$1,000. For vested balances exceeding \$1,000, terminated participants may elect to defer payment until April 1 of the calendar year following the attainment of age 72 or retirement, whichever is later.

**Plan Termination** - Although it has not expressed any intent to do so, the Plan may be terminated at any time by the Company. In the event of Plan termination, distribution of participant accounts shall be in accordance with the Plan document.

##### **Plan Amendments**

On December 29, 2022, the “Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act” was signed into law in the Under States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies employed in the preparation of the accompanying financial statements of the Plan are described below.

***Basis of Accounting*** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments*** - The United States Liability Insurance Company 401(k) Plan’s (the “Plan”) investments are carried at fair market value. See Note D for a description of the valuation methods.

***Payment of Benefits*** - Benefits to participants are recorded upon distribution. Amounts to be paid to participants who have terminated or have elected to withdraw from the Plan, but did not yet receive distributions from the Plan, totaled \$5 and \$611 for the years ended December 31, 2024 and 2023, respectively.

***Revenue Recognition and Method of Accounting*** - Purchases and sales of investments are recorded based on the trade date. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Realized gains or losses on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as incurred.

***Administrative Expenses*** – Certain administrative expenses, excluding transaction fees, are paid by the company.

***Use of Estimates*** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE E - TAX STATUS OF THE PLAN**

The Plan uses a standardized prototype plan. The prototype sponsor has received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust is tax-exempt.

### NOTE E - TAX STATUS OF THE PLAN (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### NOTE G - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of a money market fund and mutual funds managed by Fidelity Investments ("Fidelity"). Fidelity is the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.
