Note 1: Description of Plan

The following description of the Friendship Bancorp 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions.

General

Friendship Bancorp, Inc., including subsidiaries Friendship State Bank and Friendship Financial Services, LLC (Company or Employer), established the Plan effective as of January 1, 1993. The Plan was originally established as a 401(k) plan and was restated as an employee stock ownership plan (ESOP) effective January 1, 1997, and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The ESOP was spun out in 2020 and subsequently terminated. The Plan is administered by the Benefits Committee. The Friendship State Bank Trust Department is the trustee of the Plan. John Hancock Life Insurance Company (John Hancock) is the 401(k) component custodian.

Contributions

Each pay period, participants may make salary deferred contributions of their compensation up to 50% of participants' compensation, up to the maximum allowed by law. Rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may make matching contributions or discretionary Company contributions as determined by the Company's Board of Directors annually. To receive matching contributions or discretionary contributions, participants must complete 1,000 hours of service or terminate due to death, disability or normal retirement. The Company elected to make matching contributions of 50% of participants' deferrals on the first 6% of eligible compensation for 2024 and 2023. The matching contributions are calculated and remitted on a paycheck by paycheck basis.

Participant Investment Account Options

Investment account options available include various funds. For the 401(k) portion of the Plan, each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

The Plan is a defined-contribution plan under which a separate individual account is established for each participant. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Eligibility

Employees of the Company, and any subsidiary, who have attained age 18 years and completed their 90-day probationary period, are generally eligible to participate in the Plan after completion of either (1) employed in a position requiring the completion of at least 1,000 hours of service in a Plan year, or (2) completion of one year of eligibility service. Entry dates are January 1 and July 1 after completing eligibility requirements.

Vesting

Participants are 100% vested in all accounts except the discretionary employer contribution accounts. Participants also become 100% vested after the age of normal retirement has been attained, or they die or become disabled while still an employee of the Company. Prior to normal retirement age, vesting in the remainder of their accounts is based on years of credited service in accordance with the Plan Document. Participants vest 20% for each year of service and become 100% vested after five years of credited service.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to the participant's beneficiary or, if none, his or her legal representatives), becomes disabled or otherwise terminates employment with the Company and its participating subsidiaries. Distributions are made in cash or, if a participant elects, in the form of Company common shares plus cash for any fractional share. The Plan also allows in-service distributions for participants who have attained age 59½ on the participants' deferral portion of their 401(k) account. Hardship distributions are permitted, under certain circumstances, from the 401(k) contributions not invested in Company stock.

Forfeited Accounts

Forfeitures result from nonvested employer contributions and can be used to pay administrative expenses and to reduce future employer contributions. Forfeited nonvested accounts totaled approximately \$1,715 and \$3,574 for the years ended December 31, 2024 and 2023, respectively.

Notes Receivable From Participants

Participants may borrow from their account up to a maximum equal to or lesser of \$50,000 or 50% of the 401(k) contributions balance of the account for hardship reasons only. Minimum loan amount is \$1,000. Principal and interest payments are made through payroll deductions. All loans are covered by demand notes and are generally repayable over a period of five years through payroll withholdings unless the participant is paying the loan in full. All loans bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make use of estimates and assumptions that affect the reported amounts of net assets and liabilities and changes in net assets available for benefits. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by John Hancock. Unit prices of the pooled separate accounts are published daily.

The Plan's interest in the collective investment trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. At December 31, 2024 and 2023, there were no unfunded commitments, the redemption frequency was daily, and there were no restrictions on the redemption notice period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value in investments.

Subsequent Events

Subsequent events have been evaluated through August 20, 2025, which is the date the financial statements were available to be issued.

Note 3: Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and participant loans included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Disclosures About Fair Values of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the year ended December 31, 2024.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. There are no Level 1 securities. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities include the pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no securities classified with Level 3 of the hierarchy.

Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The majority of administrative fees of the Plan are paid by the Company. The Company is a trustee for the Plan and provides certain accounting, recordkeeping, and administrative services to the Plan for which it is not compensated. Certain Plan investments are shares of pooled separate accounts with John Hancock. Contract administration and advisory fees of approximately \$57,000 and \$52,000 were paid to John Hancock and its investment advisor by the Plan for the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

Note 6: Plan Tax Status

The IRS has determined and informed the Company by a letter dated June 11, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 7: Risks and Uncertainties

The Plan primarily invests in Company stock but also invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
