INDEPENDENT AUDITOR'S REPORT

Opinion

DECEMBER 31, 2024**

Note 1 – DESCRIPTION OF THE FUND

The NYSA-ILA Fringe Benefits Escrow Fund (the “Fund”) was established pursuant to the Collective Bargaining Agreement (“CBA”) between the New York Shipping Association, Inc. (“NYSA”), an association of New York and New Jersey port employers and ocean carriers, and the International Longshoremen’s Association, AFL-CIO (“ILA”), representing longshoremen, maintenance workers, and all other craft employees in the Port of New York and New Jersey. The Fund was created to distribute the monies collected by the NYSA from its employer members, less administrative costs of the Fund, to certain fringe benefit trust funds established in accordance with various NYSA-ILA collective bargaining agreements.

In March 2025, a new CBA for the period from October 1, 2024 to September 30, 2030 was agreed to and ratified by the parties.

The Fund is administered pursuant to the Agreement and Declaration of Trust and Plan dated August 15, 1972.

Note 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

b) Cash

The Fund maintains its cash in non-interest bearing accounts in one commercial bank, which at times may exceed federally insured limits. The Fund has not experienced any losses as a result of such policy.

c) Property and Equipment

Plan assets for furniture and fixtures, office equipment, leasehold improvements, and software used in Plan operations are reported at cost less accumulated depreciation or amortization. Furniture and fixtures, office equipment, and software are computed on a straight-line basis over the estimated useful lives of the respective assets. Leasehold improvements are amortized over the shorter of the term of the lease or the life of the improvement. Depreciation and amortization charges amounted to \$275,429 and \$283,692 for the years ended December 31, 2024 and 2023, respectively.

Note 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

d) Leases

In February 2016, the Financial Accounting Standards Board (“FASB”) issued guidance under Accounting Standards Codification ASC 842, Leases to increase transparency and comparability among organizations by requiring the recognition of right-of-use (“ROU”) assets and lease liabilities on the Statement of Net Assets. Most prominent among the changes in the standard is the recognition of ROU assets and lease liabilities by lessees for those leases classified as operating leases. Under the standard, disclosures are required to meet the objective of enabling users of financial statements to assess the amount, timing, and uncertainty of cash flows arising from leases.

The Fund adopted the standard effective January 1, 2022, and recognized and measured leases existing on January 1, 2022 (the beginning of the period of adoption) through a cumulative effect adjustment with certain practical expedients available. The Fund elected the available practical expedients to account for their operating leases as operating leases (the Fund did not have any capital leases classified as financing leases as of January 1, 2022), under the new guidance, without reassessing (a) whether the contracts contain leases under the new standard, (b) whether classification of capital leases or operating leases would be different in accordance with the new guidance, or (c) whether the unamortized initial direct costs before transition adjustments would have met the definition of initial direct costs in the new guidance at lease commencement.

In addition, the Fund elected the hindsight practical expedient to determine the lease term for existing leases. Our election of the hindsight practical expedient may have resulted in the shortening of lease terms for certain existing leases since the adoption of the new standard was as of January 1, 2022, and certain leases may have commenced prior to January 1, 2022. Lastly, in the application of hindsight, the Fund used the determination that most renewal options would not be reasonably certain in determining the expected lease term unless the lease was renewed during 2022 or as a subsequent event through the date the financial statements were issued for 2022 in 2023.

As a result of the adoption of the new lease accounting guidance, the Fund recognized on January 1, 2022, a lease liability at the carrying amount of their operating lease obligations on January 1, 2022, of \$73,171, and a right-of-use asset of \$73,171. The lease liability the Fund recognized on January 1, 2022, of \$73,171, represents the present value of the remaining operating lease payments, discounted using an average “risk-free treasury rates” ranging from 1.04% to 1.54% (see Note 6) and the right-of-use asset of \$73,171, represents the operating lease liability of \$73,171.

The implementation of the new standard had a material impact on the Fund’s Statement of Net Assets but did not have an impact on the Fund’s Statement of Changes in Net Assets. The most significant impact was the recognition of ROU assets and lease liabilities for operating leases.

e) Contributions

The NYSA is ultimately responsible for the assessment and collection of the monies due from the port employer members and the ocean carrier pursuant to the CBA. The assessments are on a basis that will produce an amount sufficient to fund anticipated benefits and related administrative expenses. ILA members make no contributions to the Fund.

f) Transfers

The Fund's cash transfers to other funds, as reflected in the Statement of Changes in Net Assets, may differ from the requirements of these funds for a fiscal year. Any such differences are normally reflected in the Fund's cash transfers in the next fiscal year and are not recorded as a payable to or receivable from the recipient funds as of the Statement of Net Assets date because the employer members of the NYSA, not the Fund, are responsible for funding the benefit payment requirements of these funds.

g) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Note 3 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service ("IRS") has advised the Fund that it is not eligible for Federal income tax exemption under provisions of the Internal Revenue Code. However, the IRS has issued a general information letter, dated October 31, 1972, to the ILA and NYSA indicating, among other things, that a trust receiving money on behalf of tax-exempt organizations and using such money to satisfy obligations incurred by the exempt organizations does not realize taxable income from the receipt of such monies. In the opinion of management, the Fund has operated in accordance with the provisions of the IRS general information letter. Therefore, no provision for federal income taxes has been recorded in the accompanying financial statements. The Fund had no unrecognized tax benefits as of and for the year ended December 31, 2024 and has no open years subject to examination prior to the year ended December 31, 2023. The Fund had no income tax related penalties or interest for the period reported in the financial statements.

Note 4 – ALLOCATED AND ADMINISTRATIVE EXPENSES

a) Allocated Expenses

Certain administrative expenses of the Fund are allocated to various funds on the basis of estimated utilization of services. The allocation of 2024 expenses to the various funds amounted to \$2,458,909 and comprise the following:

b) Administrative Expenses

Administrative expenses of \$703,976, consisting primarily of utilities, rent, and insurance, were incurred by the NYSA-ILA Pension Trust Fund and allocated to the Fund during 2024.

Note 5 – RETIREMENT PLANS

Employees of the Fund participate in NYSA-ILA Medical and Clinical Services Fund Retirement Trust, a multiple-employer defined contribution retirement plan. Under this plan, the Fund contributes an amount equal to 10% of the employees' base salaries, and the employees may voluntarily contribute up to 100% of their salaries, post-tax, subject to the contribution limits set forth by the Internal Revenue Service. The Fund's contribution to this plan for the year ended December 31, 2024 amounted to \$624,292, net of forfeitures.

The Fund also made contributions to the NYSA-ILA Pension Trust Fund with respect to four employees, in the amount of \$10,800 for the year ended December 31, 2024.

The Fund also made contributions to the 401k plan. The Fund matches the employee's pre-tax or ROTH contributions up to 3% of the employee's base salary. The employee must contribute to the plan in order for the Fund to make a matching contribution. Total employer contributions under this plan for the year ended December 31, 2024 amounted to \$180,689.

Note 6 – OPERATING LEASES

The Fund leases two postage meters and two copiers as of December 31, 2024. The Fund determines if an arrangement is a lease at inception. Any leases for operating leases that did not extend for more than a year after January 1, 2022 (ASC 842 inception date), or that were considered immaterial were accounted for and are disclosed in these financial statements under the prior lease standard ASC 840. Operating leases that commenced prior to January 1, 2022, and any new leases after January 1, 2022, that expire more than twelve months after January 1, 2022 are classified and disclosed under the new lease accounting standard (ASC 842) as operating lease right-of-use (“ROU”) assets, and included as other assets, and operating lease liabilities on the Statement of Net Assets. The Fund did not have any finance leases classified as capital leases. ROU assets represent the Fund’s right to use an underlying asset for the lease term and lease liabilities represent our obligation to make lease payments arising from the lease. Operating lease ROU assets and liabilities are recognized at commencement date based on the present value of lease payments over the lease term. The Fund has elected to use the risk-free treasury rate based on the information available at the commencement date of each lease in determining the present value of lease payments. The operating lease ROU asset also includes any lease payments made and excludes lease incentives. The Fund’s lease terms may include options to extend or terminate the lease when it is certain that the option will be exercised. Lease expense for lease payments is recognized on a straight-line basis over the lease term as an administrative expense.

Note 7 – OTHER

Certain NYSA-ILA Funds trustees, in their capacities as officers of the International Longshoremens’s Association, AFL-CIO (“ILA”), are defendants in a civil lawsuit (05 Civ. 3212) (ILG) (VVP) filed by the United States Department of Justice in the United States District Court for the Eastern District of New York on July 6, 2005 and brought under the Racketeer Influenced and Corrupt Organizations Act (“RICO”), which names the ILA and other jointly trusteeed Taft-Hartley funds as nominal defendants, which funds are other than the NYSA-ILA Funds and which funds were established and are maintained under other collective bargaining agreements and not under the NYSA-ILA collective bargaining agreement.

It is the opinion of co-counsel and the trustees of the NYSA-ILA Funds that this matter will not have any adverse impact on the NYSA-ILA Funds should some or all of the relief sought by the U.S. Department of Justice, including the removal of certain ILA officers, some of whom are trustees of the NYSA-ILA Funds, be awarded in the civil RICO action.

Note 8 – SUBSEQUENT EVENTS

NYSA-ILA Fringe Benefits Escrow Fund evaluated its December 31, 2024 financial statements for subsequent events through August 27, 2025, the date the financial statements were available to be issued. The Fund is not aware of any subsequent events that would require recognition or disclosure in the accompanying financial statements.
