## *Independent Auditor's Report*

### **Plan Sponsor The Infirmary 401(k) Plan**

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Infirmary 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of The Infirmery 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees, as defined in the Plan document, of Infirmery Health System, Inc. (the Sponsor). All regular, full time, and part-time employees of the Sponsor are eligible to participate in the Plan upon employment. Flex or PRN employees are eligible after completing one year of service (generally defined as 1,000 hours worked). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation (as defined in the Plan document) and Roth contributions not to exceed federal limits. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Effective April 1, 2024, the Plan was amended to include an automatic escalation provision, whereby eligible participants' pretax or Roth elective deferral is increased by one percent each April 1 up to a maximum of 12 percent (unless the participant opts out). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In 2024, the Sponsor contributed matching contributions equal to a percentage of the aggregate pretax contributions determined based on the number of the participant's years of vested service as of the first day of the Plan year. The Plan also provides for an automatic special contribution for eligible employees who, as of December 31, 2016, had 10 or more years of vesting service under the Infirmery Health System Pension Plan. The amount of each eligible employee's automatic special contribution equals a percentage of his/her compensation for the Plan year based on his/her combined age as of the first day of the Plan year and years of vested service under the Infirmery Health System Pension Plan. The Sponsor may also contribute supplemental retirement contributions. No supplemental retirement contribution was made in 2024. Contributions are subject to certain limitations. Participants direct the investment of their contributions and Sponsor contributions into various investment options offered by the Plan.

## The Infirmary 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Sponsor's contributions and Plan earnings or losses from that account's investment activities. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after one year of credited service for Sponsor matching and automatic special contributions. A participant is 100 percent vested after three years of credited service for Sponsor supplemental retirement contributions.

##### **Benefit Payments**

On termination of service due to separation, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a fixed period of time, not to exceed the life expectancy of the participant or the beneficiary, or in the form of an annuity contract. A participant may obtain an in-service withdrawal, including hardship withdrawals, from his or her tax-deferred contributions subject to certain conditions and penalties (as defined in the Plan document).

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Company are excluded from these financial statements. Participant initiated distribution and loan fees are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

##### **Forfeitures**

Forfeitures of terminated, nonvested participant accounts are first used to pay administrative expenses and then may be used to reduce future Sponsor contributions.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Participant Loans**

Participants may borrow from their fund accounts (attributable to elective deferrals plus earnings) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their Sponsor contributions.

#### **2. Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. Management of the Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and custodian. See Notes 4 and 5 for discussion of fair value and contract measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and any investment-related expenses.

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **3. Investment Information**

All information related to investments and participant loans disclosed in the accompanying financial statements and supplemental schedule, including investments held and participant loans receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the Sponsor and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustee and custodian of the Plan, respectively.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: consists of mutual funds that are valued on the basis of readily determinable market prices and a cash equivalent that is stated at cost, which approximates fair value.

#### 4. Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Fully Benefit-Responsive Investment Contract

The Plan holds an investment in the Empower Annuity Insurance Company Guaranteed Income Fund. This group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and has no minimum or maximum interest rate. The crediting rate is reviewed on a semi-annual basis for resetting.

### Notes to Financial Statements (continued)

#### **5. Fully Benefit-Responsive Investment Contract (continued)**

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the contract issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The contract may be terminated upon written notice by the Plan sponsor or by the contract issuer if the Plan sponsor does not comply with the terms of the contract or if it is determined that this class of business is no longer commercially feasible. Upon notice of contract termination, distribution of assets will begin within 90 days after receipt of payment of all outstanding billed expenses. The book value of contributions credited to the Guaranteed Income Fund, together with accumulated interest, will normally be transferred in a lump sum on the termination payout date or on an installment basis if elected by the Plan sponsor (as defined in the contract). There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

#### **6. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated September 26, 2022, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

#### **7. Subsequent Events**

Management of the Sponsor evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 16, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to modify the vesting schedule for Company matching contributions from one year of credited service to three years of credited service for a participant hired on or after January 1, 2025.
