Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Recycling Management Resources, LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Recycling Management Resources, LLC 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Recycling Management Resources, LLC (the “Company”). The Plan was established effective January 1, 1993. The Plan is a single employer-defined contribution plan, which is offered to the employees of Wilmington Paper, LLC, and RMR, LLC (collectively, the “Employers”). Voya Retirement Insurance and Annuity Company served as an insurance carrier of the Plan and is the recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

The Plan covers all eligible employees, as defined in the Plan agreement, who have completed six months of service. An employee is eligible to participate in the plan on the first day of the month coinciding with the date the eligibility requirements are met.

Contributions

Each year, participants may contribute 100% of their annual compensation up to a maximum of \$23,000 and \$22,500 for 2024 and 2023, respectively, as defined in the plan. Participants who reached the age of 50 before the end of both Plan years are eligible for an additional catch-up contribution of up to \$7,500, subject to certain Internal Revenue Code limitations. Participating employers may contribute a discretionary percentage of the amount deferred by the employees. The employer may also contribute a discretionary amount and determined each year by the participating employer. For the years ended December 31, 2024 and 2023, the Company elected to contribute a matching contribution of 100% of the participants’ salary deferrals up to 3% of their compensation and an additional 50% of the participants’ salary deferrals up to 5%.

Funding Policy

The Plan Sponsor makes monthly contributions to the Plan on behalf of covered employees in amounts determined by the signed adoption agreement.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the company’s matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of Plan expenses are based on participant account balances or specific transactions directed by the participant as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. A participant is 33% vested after one year of service, 66% after two years of service, and 100% after three years of service.

Participant Loans

Participant loans are a Plan option that must be elected by the co-adopting employer. The rules are covered in a separate loan application form and promissory note form, and loans must be applied for through the plan administrator. Participants may borrow from their employee elective deferral accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with prevailing rates as determined quarterly by the plan administrator. Loan terms range from 1-5 years or up to a reasonable amount of time for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions at market rates from 8.75% to 9.50% currently.

Payment of Benefits

Participants will receive the full amount of their vested account balances in the event of normal retirement, termination of service, death, or disability. Early withdrawals are permitted at the participant's request after the age of 59-1/2. Certain hardship withdrawals are also permitted. Distributions will be made in lump-sum payments, joint and survivor annuities, or pre-retirement survivor annuities.

Hardship Withdrawals

The Plan provides for hardship withdrawals, not to exceed an amount required to meet the immediate need created by the hardship, and then only to the extent such immediate need cannot be satisfied by other sources readily available to the participant. Permissible circumstances for hardship withdrawals include education expenses, costs directly related to the purchase of a principal residence, and costs necessary to prevent eviction from the participants' personal residence and such other circumstances as the Plan Administrator may determine based on rules set forth in the Internal Revenue Service regulations. Salary deferral contributions are suspended for six months following a hardship withdrawal.

Forfeited Accounts

All forfeitures from non-vested interests in the Plan occurring during the plan year shall be applied to reduce employer contributions. In addition, forfeitures shall be calculated and applied separately with respect to employees of each particular employer. Balances in forfeited non-vested accounts at December 31, 2024 and 2023 were \$94,828 and \$88,757, respectively. During 2024 and 2023, no forfeited balances were used to offset the employer contributions.

Investment Options

Participants direct the investment of their employer contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts, a Voya Fixed Account, and life insurance to participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America and provisions related to financial Accounting Standards for Plan Accounting ASC (Topic 962).

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities.

Allowance for Credit Losses

When the Plan records customer receivables, contract assets, and financing receivables arising from revenue transactions, the Plan records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets. The Plan evaluates debt securities with unrealized losses to determine whether any of the losses arise from concerns about the issuer's credit or the underlying collateral and record an allowance for credit losses, if required.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be a distribution, the participant's loan balance is reduced, and a deemed distribution is recorded. On a periodic basis, the Plan sponsor evaluates notes receivable from participants and, if necessary, establishes an allowance for credit losses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Valuation techniques used in fair value measurements maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. Assets and liabilities measured at fair value are categorized into one of three different levels depending on the observability of the inputs employed in their measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability, including the Plan's own assumptions in determining the fair value of the assets or liabilities.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold during the year.

Employer Contributions Receivable

The Plan's policy is to recognize contributions based on the date of the participant's paycheck date. Contributions from the plan sponsor are based on the Plan rules and relate to the contributions recognized as income by the Plan. Contributions due but not paid prior to year-end are recorded as contributions receivable.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Certain costs, such as the annual contract fees, are paid by the Plan. Certain other administrative and auditing fees are paid by the Employer.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions in 2024. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

Concentrations

The investments of the Plan are held in publicly traded mutual funds and collective investment funds and are administered by the Voya Trust Company. Investments that represent 10% or more of total plan assets are separately identified.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Life insurance is valued at the cash value, which is derived from interest at a guaranteed rate specified in each policy and dividends declared by the insurance annually and paid on December 31st each year.

Pooled Separate accounts are valued at NAV each day by the trustee. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities, and then divided by the number of shares outstanding. The NAV of a pooled separate account is used as a practical expedient to fair value. Life Insurance

4. Guaranteed Investment Contract with Voya Insurance Company

The Plan holds a traditional investment contract with Voya Retirement Insurance and Annuity Company that meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. The contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The traditional investment contract held by the Plan is a guaranteed investment contract.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a yearly basis for resetting. The contract does not have a maturity date. However, the issuer may terminate the contract after completion of a certain number of years without application of any otherwise required market value adjustment or contract surrender charge.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

4. Guaranteed Investment Contract with Voya Insurance Company, continued

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. Life Insurance Held with Guardian Life

Five participants in the Plan have purchased life insurance with policies through Guardian Life Insurance Company using proceeds from their account balances. At December 31, 2024 and 2023, the base face value of the policies were \$3,000,000, and net surrender value of \$373,594 and \$336,092, respectively. Participants made premium payments of \$24,579 and \$5,503 on December 31, 2024 and 2023, respectively. These contracts do not meet the fully benefit-responsive investment contract criteria. These contracts are reported at surrender value, which is the contract value minus the outstanding participant loans. This value is the amount a participant would receive if they were to initiate permitted transactions under the terms of the Plan. Surrender value, as reported to the Plan by Voya Life Insurance Company, represents premiums paid under the contract, minus insurance charges, plus earnings, less participant withdrawals.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer. There are no reserves against surrender value for credit risk of the contract issuer or otherwise. The crediting dividend rate is based on the declaration of the issuer. Dividends are credited to the policies on December 31st of each year.

6. Related Party and Party in Interest Transactions

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the Plan's custodian, therefore these transactions qualify as party in interest transactions. The Plan also extends loans to participants who are considered parties in interest. Certain administrative functions are performed by officers and employees of the Company, who may also participate in the Plan, at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Company may determine.

8. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Tax Status

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that required recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
