## INDEPENDENT AUDITORS' REPORT

The Plan Administrator  
Western New York Public Broadcasting Association Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform an audit of the financial statements of Western New York Public Broadcasting Association Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution (TIAA-CREF) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Disclaimer of Opinion on the Financial Statements

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion on the Financial Statements

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and TIAA-CREF did not provide sufficient accounting records and supporting documentation related to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we were unable to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## **Additional Information**

### *Supplemental Schedule Required by ERISA*

Because of the significance of the matter described in the Basis for Disclaimer of Opinion on the Financial Statements section, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

## Notes to Financial Statements

---

### 1. Description of Plan:

The following brief description of Western New York Public Broadcasting Association Retirement Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the text of the Plan document.

#### General:

The Plan is a defined contribution 403(b) plan covering substantially all full-time employees of Western New York Public Broadcasting Association (the Sponsor). An employee can immediately make salary reduction contributions to the Plan. Participants who attain age 21 and complete a year of service, as defined in the Plan, are eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan, provided total additions to the account of participating employees for any Plan year shall not exceed the amount permitted by Internal Revenue Service regulations. Additionally, participants age 50 or older may elect to make catch-up contributions. The Sponsor provides a contribution of 7.5% of a participant's base compensation, as defined by the Plan. To qualify for the contribution, participants must defer at least 3.5% of their base compensation. Participants may contribute amounts representing distributions from other qualified plans.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution, the Sponsor's contribution, and investment earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting:

Participants are immediately vested in their contributions, the Sponsor's contributions, and actual earnings thereon.

#### Investment Options:

Participants may direct contributions into a variety of registered investment company shares, a pooled separate account or fixed annuity contracts offered by Teachers Insurance and Annuity Association, College Retirement Equity Fund (TIAA-CREF), some of which are proprietary in nature.

#### Participant Loans:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 year to 5 years. Loans to purchase a primary residence may be repaid over a period longer than 5 years. The loans are secured by the vested balance in the participant's account and bear interest at an adjustable rate as determined by TIAA-CREF. The Plan requires repayments on at least a quarterly basis, however, repayment terms are designated in the loan agreement.

Beginning in 2021, participant loans are issued from, and are assets of, the Plan. Before 2021, pursuant to the Plan's arrangement with TIAA-CREF, certain participant loans were issued from TIAA-CREF owned assets, and secured by participant account balances. At December 31, 2024 and 2023, these plan loan balances total \$103,031 and \$119,136. Interest rates on the loans range from 4.07% to 7.56%.

#### Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount, annual installments or an annuity equal to the participant's vested account balance. When a participant's vested balance is converted to a lifetime annuity, the present value of the stream of payments is equal to the vested balance, and the entire amount is recorded as a payment to the insurance company to purchase contracts excluded from plan assets in the statement of changes in net assets available for benefits. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for certain in-service withdrawals for active employees that have reached normal retirement age or undergoing financial hardship, as defined by the Plan.

## **2. Significant Accounting Policies:**

### **Basis of Accounting:**

The financial statements of the Plan are prepared under the accrual method of accounting.

### **Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Investment Valuation:**

The Plan's investments are stated at fair value (except for the fully benefit responsive fixed annuity contract, which is reported at contract value (see Note 4)). Inputs to the valuation methodology of registered investment company shares are unadjusted quoted prices for identical assets in active markets. The pooled separate account is valued based on the net asset value (NAV) per share without further adjustment, as a practical expedient to determine fair value. Net asset value is based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction. The non-benefit responsive fixed annuity contract is valued based on discounted cash flows and theoretical transfer methods (fair value approximates contract value).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments brought and sold as well as held during the year.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

### **Payment of Benefits:**

Benefits are recorded when paid.

## **Administrative Expenses:**

The majority of administrative expenses of the Plan are borne by the Sponsor. Investment fees are paid by the Plan and netted with investment income in the accompanying statement of changes in net assets available for benefits.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 24, 2025 (the date the financial statements were available to be issued).

## **3. Investments and Fair Value Measurements (Unaudited):**

Accounting guidance established a three-level fair value hierarchy that prioritizes the inputs used to measure assets at fair value. Inputs refer broadly to the assumptions that market participants would use in pricing the asset, including assumptions about risk. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset and are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own perceptions about the assumptions market participants would use in pricing the asset and are based on the best information available.

The three levels of fair value hierarchy are as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access on the reporting date.

Level 2 - Inputs other than quoted market prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. If the asset or liability has a specific (contractual) term, a Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable for the asset or liability.

The fair value hierarchy gives the highest priority to Level 1 inputs and the lowest priority to Level 3 inputs.

The Plan uses NAV per share (or its equivalent) as a practical expedient to determine the fair value of investments that (i) do not have a readily determinable fair value predicated upon quoted prices in active markets, and (ii) have the attributes of an investment company or prepare their financial statements consistent with the measurement principles of an investment company.

Level 3 investment purchases for 2024 totaled \$897,725.

#### 4. Fully Benefit-Responsive Investment Contract:

The Plan maintains a benefit-responsive fixed annuity contract with TIAA-CREF. TIAA-CREF maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity contract. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The fixed annuity contract does not permit the insurance company to terminate the agreement before the scheduled maturity date.

#### 5. Financial Information Certified by TIAA-CREF:

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained a certified "Statement of Account" from TIAA-CREF as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the information summarized below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits – Investment income and interest income on notes receivable from participants.
- Supplemental Schedule of Assets Held (At End of Year) – all items and amounts.

#### 6. Income Taxes:

The Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision has been made for income taxes.

#### 7. Plan Termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **8. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
