NOTE A. DESCRIPTION OF PLAN

The following description of the Gasbarre Products, Inc. (“Company”) Profit Sharing Plan & Trust (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan as described under Internal Revenue Code Section 401(k). The Plan covers all employees of Gasbarre Products, Inc. Employees are eligible to participate as long as they are age twenty-one or older and have at least ninety days of service with the Company (1,000 hours). Employees are eligible to receive the discretionary profit-sharing contribution after one year of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

The Plan is funded through discretionary employer non-elective contributions and before-tax employee payroll deductions. Effective January 2025, the Plan is also funded by after-tax Roth contributions. Participants can contribute as much as twenty-five (25%) of gross compensation to a maximum amount as determined annually by the Internal Revenue Service. The Company’s contributions are allocated to all eligible employees, regardless of who is making before-tax contributions to the Plan, based on the ratio of each eligible employee’s compensation to the total compensation of all eligible employees. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company can make a discretionary profit-sharing contribution to be determined prior to the end of each plan year. This discretionary contribution amounted to approximately 2% of each eligible participant’s salary for each of the plan years ended December 31, 2024 and 2023. Current year employer contributions are allocated to the individual employees’ accounts subsequent to year end once eligibility is determined.

Contributions (Continued)

Effective February 1, 2019, the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's respective deferral, the Company's discretionary profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of certain investment and administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount or installments, over a period not to exceed the life expectancy of the participant, in an amount equal to the vested value of his or her account, or leave funds in the Plan. If the participant's vested account value is \$5,000 or less, the entire amount will be paid to the participant upon termination.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the Plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 1/2.

Forfeitures

The nonvested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeited nonvested accounts, when available, are used to offset administrative fees and reduce employer contributions.

Forfeitures (Continued)

In 2024, employer contributions were reduced by \$9,549 from forfeited nonvested accounts. At December 31, 2024 and 2023, forfeited nonvested accounts were \$6,972 and \$9,549, respectively.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The administrative committee determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassification

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

Date of Management's Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

NOTE D. FAIR VALUE MEASUREMENTS (CONTINUED)

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of shares held by the Plan at year end. The fair value of common stock, corporate bonds and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded and are classified within Level 1 of the fair value hierarchy.

The fair value of the stable value collective trust funds is measured at the NAV of each account on the last day of the plan year. The NAV is based on the market value of the underlying assets.

NOTE F. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor, Gasbarre Products, Inc., provides the Plan with certain accounting and administrative services for which no fees are charged. Fees paid by the Plan for administrative services amount to \$54,524 for the year ended December 31, 2024.

Members of the management team are currently participants in the Plan and one member serves as the plan administrator.

In addition, Gasbarre Products, Inc. directly pays certain administrative expenses for the Plan.

All of these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE H. TAX STATUS

The Internal Revenue Service has determined and informed the trustee by a letter dated March 31, 2014, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
