NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of Plan

The following description of the Gotham Per Diem, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established effective January 1, 1992 covering all full-time employees of Gotham Per Diem, Inc. (the "Company") and the affiliated entities ("participating companies"). A new employee is eligible to participate in the Plan upon attaining age 21 and completing one year of service in which the employee is credited with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The participating companies are as follows: (1) Gotham Per Diem, Inc., (2) Midpoint Associated Practitioners, Inc., (3) Square One Management Associates, LLC, and (4) Gotham Registry, Inc.

Participants' Contributions

Eligible employees electing to participate in the Plan may contribute up to 70% of their pre-tax (or post-tax Roth) annual compensation, as defined by the Plan, or up to the maximum amount permitted by the Internal Revenue Code ("IRC"). Participants who are age 50 or older may elect to make "catch-up" contributions. This limitation is an aggregate limit which applies to all deferrals made to this Plan, and to any other salary deferral plan. Participants may also contribute amounts representing rollovers from other qualified plans (rollover). Contributions are subject to certain IRS limitations (see participant accounts below).

Discretionary Matching Contributions

Under the terms of the Plan, the participating companies may make discretionary matching and profit-sharing contributions to the Plan equal to a discretionary percentage, to be determined by the participating companies, of the participant's elective deferrals. For the year ended December 31, 2024 and 2023 the participating companies made no contributions.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan and maintained by Fidelity Institutional Wealth Services, the custodian.

Participant Accounts (Continued)

Each participant's account is credited with the participant's contribution, employer contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that is paid by the Plan. Allocations are based on participants' earnings account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan's investments are held by the custodian. Contributions to the Plan by or on behalf of a participant are invested at the election of the participant in the investment options offered by Fidelity Institutional Wealth Services.

Vesting

Participants are fully vested immediately in their salary deferral contributions plus actual earnings thereon. Vesting in the participating companies' discretionary contribution (if any) portion of their accounts plus actual earnings thereon, is based on years of continuous service. A participant is vested 20% after one (1) year of service and 20% for each additional year of service thereafter, and fully vested (100%) after five (5) years of credited service.

Forfeitures

Upon termination of service, any unvested portion of the employer's matching contribution account will be forfeited. Forfeitures will be used first to reduce administrative expenses and then to reduce future discretionary employer matching and profit-sharing contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33 and \$9, respectively.

Participant Loans

Participants may borrow from their retirement accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balances in the participants' accounts and bear interest at a rate range of 4.25-9.50%, maturing through June 2028. The interest rate is determined by the loan administrator based on the prevailing interest rates charged by commercial lending institutions and shall remain fixed throughout the duration of the loan. Repayment of the loan is required to be made ratably of principal and interest through payroll deductions each pay period, and must be completed within five years, except for loans for the purchase of a primary residence, in which case the loan repay period may be extended.

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Terminated Employee Loans in default

A loan will be considered in default if any scheduled repayment remains unpaid as of the end of the "cure period," which ends on the last day of the calendar quarter following the calendar quarter in which the required repayments were due. After default occurs, if a distribution to the participant is permissible under the Plan, the vested amount of the participant's account balance will be reduced or offset by the outstanding principal and interest of the defaulted loan. If a distribution to the participant is not allowed the entire outstanding balance of the loan will be treated as a deemed distribution. A deemed distribution is treated as a distribution to the participant only for certain tax purposes and is not a distribution of the account. Interest continues to accrue on any defaulted loan which results in a deemed distribution, to the date of repayment.

Active Employee Loan Payments

Loan payments are processed through payroll deduction and a payroll deduction agreement is executed by the participant where installments and a loan amortization schedule is prepared according to the terms of the agreement. In accordance with the loan agreements the participant authorizes the payroll department to deduct the payments from the wages. Any loan payments that cannot be deducted from salary will be the responsibility of the participant to pay.

Payment of Benefits

A participant may elect to receive benefit payments at the normal retirement age of 65 or at an early retirement date. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account, or defer a lump sum payment, whereby payment must begin by age 72 and be subject to minimum distribution requirements. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-service distribution may be made from a participant's account at any time upon or after the occurrence of the following events:

- Due to hardships, as defined in the plan agreement,
- Participant's attainment of age 59
- Withdrawals after age 72, or
- Withdrawals after normal retirement age of 65

Hardship Withdrawals

The Plan allows participant withdrawals for hardship which cannot exceed the amount needed to meet the immediate financial hardship. The distribution will be limited to the participant's elective deferrals excluding any investment income.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the plan custodian. (See Note 3 for a discussion of fair value measurements.)

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The custodian executes buy and sell orders based on the participant's instructions and earnings, expenses, gains and losses on investments made with amounts in each participant's account as allocated to such account.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the participating companies and are excluded from these financial statements. Fees related to the administration of loans receivable from participants are charged directly to the participant's account and are included

in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Plan Termination and Amendments

Although they have not expressed any intent to do so, the participating companies have the right under the Plan to discontinue their contributions at any time and to terminate the participating Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100 percent vested in their employer contributions. The Plan terms were modified for the Cares Act.

Concentration of Credit Risk

Financial instruments that potentially subject the participants to risk of loss consist principally of Plan investments and participants' loans receivable.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3). The asset's or liability's fair value measurement level within fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair

value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

(a) *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(b) *Common trusts fund:* In 2024 and 2023, the Plan's investments are in a Morley Stable Value Fund.

4. Tax Status

The IRS has determined and informed the Company, by a letter dated March 9, 2010, that the

Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income examinations for years prior to 2021.

5. Information Prepared and Certified by Plan Custodian

The following information included in the financial statements and supplemental schedules was obtained from Reliance Trust Company for the 2024 and 2023 Plan Year, the plan custodian, certifying the investment information is complete and accurate as of December 31, 2024 and 2023.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

7. Prohibited Transactions

During 2024 or 2023 there were no prohibited transactions

8. Party-In-Interest Transactions

Certain Plan investments are in shares of mutual funds and common collective trust funds managed by Fidelity Institutional Wealth Services for the year ended December 31, 2024, the plan custodians. Therefore, these transactions qualify as party-in-interest transactions, and are exempt from prohibited transaction rules. Fees incurred and paid directly by the Plan for investment management services are included in net appreciation in fair value of the investments as they are paid through revenue sharing rather than a direct payment

9. Excess Contributions Payable

The Plan is required to return contributions to participants in the event certain non-discrimination tests and/or contribution limits defined under the IRC are not satisfied. For the years ended December 31, 2024 and 2023 no excess contributions were payable to participants.
