## **Report of Independent Auditors**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Pension Plan for Union Employees of Fox Television Stations, LLC (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

### 1. PLAN DESCRIPTION

The following description of the Pension Plan for Union Employees of Fox Television Stations, LLC (the "Plan") is provided for general information only. Participants should refer to the plan document for more complete information.

#### General

The Plan is a defined benefit pension plan sponsored by Fox Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Plan Administration

The Plan Administrative Committee is a named fiduciary with responsibility for administration of the Plan, other than with respect to the management of the Plan's assets. The Fox Investment Committee (the "Investment Committee") is a named fiduciary with responsibility for the management of the Plan's assets, appointment of trustees, and trust administration. The Plan's investments are held in the Fox Master Trust (the "Master Trust")

#### Eligibility

Employees of the Company who are members of a union with which the Company has a collective bargaining agreement ("CBA") become participants in the noncontributory component of the Plan after:

- Completing one year of service
- Attainment of the age of 21
- Becoming a member of an included Unit (as defined in the Plan document), provided that the person is not employed as an officer of the Company
- Providing that no more than one-half of the participant's compensation is customarily derived from services that are not rendered under the provisions of the CBA between the Company and a labor organization representing a Unit

Participation in the contributory component of the Plan occurs upon election subsequent to, or coincident with, becoming a noncontributory participant.

#### Participant Contributions

According to CBAs, participants may elect to contribute to the Plan an amount equal to 1% to 8% of the participant's compensation. Present employees' accumulated contributions at December 31, 2024 and 2023 were \$1,307,412 and \$1,284,832, respectively, including interest credited at an interest rate of 5% compounded annually through December 31, 1987, and thereafter as required by the Internal Revenue Code (the "Code").

### Pension Benefits

The Plan provides for retirement benefits: (1) for Membership Service (as defined in the Plan document), a retirement benefit consisting of a non-contributory benefit and in the case of a contributor, a contributory benefit; and (2) where applicable for past service, a retirement benefit consisting of a non-contributory benefit. The maximum annual retirement benefit payment to any one participant in 2024 and 2023 is the lesser of \$275,000 and \$265,000, respectively, subject to annual cost-of-living adjustments made pursuant to Internal Revenue Service ("IRS") regulations or the participant's average annual compensation, as defined in the plan document, for the highest three consecutive years. Participants become eligible to receive benefits at the normal retirement age of 65. Participants are eligible to receive certain early retirement benefits.

### Death Benefits

In certain circumstances, surviving spouses and designated beneficiaries are eligible for survivor benefits.

### Vesting

Participants become fully vested in the Plan at the earlier of attaining five years of service with at least 1,000 hours of service per year or upon the attainment of age 65.

### Employer Contributions

All contributions are made by the Company. The Company's funding policy is to contribute all amounts required under ERISA. The required minimum contributions are actuarially determined under the provisions of the Pension Protection Act of 2006. The Company may choose to contribute additional amounts to the Plan, above the required amounts, based on other relevant factors.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan retains an interest in the Master Trust, which holds all the Plan's investments. The investments are stated at fair value as further disclosed in Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Investment income includes interest income, dividends and other. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Master Trust's gains and losses on investments bought and sold, as well as held, during the year.

### Administrative Expenses

Plan administrative expenses, which consist primarily of actuarial, trustee, audit, legal and Pension Benefit Guaranty Corporation ("PBGC") fees, are reported as plan administrative expenses on the statements of changes in net assets available for benefits. Master Trust expenses are allocated to the Plan and are reflected in net investment income (loss) of the Master Trust. Any administrative expenses may be paid by the Company on behalf of the Plan.

### Benefit Payments

Benefit payments to participants are recorded upon distribution.

### Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. The Master Trust's exposure to credit loss in the event of non-performance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect the amounts reported in the accompanying financial statements.

Plan contributions are made and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the accompanying financial statements.

### 3. MASTER TRUST

The assets of the Plan are held in the Master Trust and commingled for investment purposes with the assets of the Fox Pension Plan and the Pension Plan of Locals 794 & 819, I.A.T.S.E.

The Master Trust is structured with multiple investment pools (the "pools") each representing a different category of assets. The participating plans do not have a right or title to any specific assets of the Master Trust but retain an undivided beneficial interest in one or more of the pools. JPMorgan Chase Bank, N.A. (the "Trustee") determines the value of each pool and each plan's beneficial interest in each pool, which is represented by a proportional dollar interest. Net appreciation (depreciation), investment income (loss) and Master Trust expenses are allocated to each participating plan based on each plan's proportionate dollar interest in the respective pool or the Master Trust as appropriate. Contributions, benefit payments and plan level expenses are credited or debited directly to each plan.

### Fair Value Measurements

The Plan's valuation methodologies were applied to all the Trust's investments carried at fair value. Mutual funds are valued at the quoted closing price reported on the active market in which they are traded. Common collective trusts are valued using the net asset value ("NAV"), which is determined daily, published and is the basis for current transactions with the fund's investment manager or issuer. Partnership interests are valued using the NAV as a practical expedient which is provided by the fund's investment manager or issuer.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

### Valuation Hierarchy

In accordance with ASC 820, Fair Value Measurement, investments are categorized based upon an established fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities
- Level 2: Not traded on an active market, but significant observable inputs are readily available
- Level 3: Significant unobservable inputs

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

The actuarial present value of accumulated plan benefits is the estimated future periodic benefit payments, including lump-sum distributions, attributable under the Plan's provisions to the service employees have rendered to the valuation date. The actuarial present value of accumulated plan benefits includes benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of deceased employees, and (c) present employees or their beneficiaries. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered prior to the valuation date.

The actuarial present value of accumulated plan benefits as determined by the Plan's actuary is the amount that results from applying actuarial assumptions to adjust the actuarial present value of accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment.

- Interest Rate: 5.50% per annum, compounded annually
- Mortality: Plan specific adjustment factor of 90% applied to the Pri-2012 mortality table with contingent survivor adjustments for existing survivors, projected generationally with scale MP-2021
- Retirement Age: The later of retirement eligibility over age 65 (except for certain NABET-represented employees at Network Engineering and Operations, KTTV and KCOP assumed retirement age range from 55 to 70, and immediately if over age 70)

The change in actuarial assumptions for the year ended December 31, 2023 is primarily driven by a change in the mortality assumption, offset by changes in the lump sum conversion rates and the lump sum conversion mortality table.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The actuary estimated the accumulated plan benefits as of January 1, 2024 and 2023. There were no significant changes to the plan that would have changed the valuations had they been performed as of December 31, 2023 and 2022.

## 5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the plan document to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- Benefits attributable to employee contributions, taking into account those paid out before termination
- Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire in the three-year period would have been receiving if they had retired with benefits in the normal form of an annuity under the Plan. The priority amount is limited to the lowest benefit

that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.

- Other vested benefits insured by the PBGC up to the applicable limitations
- All other vested benefits not insured by the PBGC
- All non-vested benefits
- Any surplus assets of the Plan remaining after the payment of all expenses and liabilities shall revert to the Company in the proportion determined by the Plan Administrator.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal retirement age benefits, early retirement benefits, and certain survivors' pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the level of benefits guaranteed by the PBGC.

### 6. TAX STATUS

The Plan has received a determination letter from the IRS, dated May 16, 2013, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related Master Trust is tax-exempt. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. INFORMATION CERTIFIED BY THE TRUSTEE

Certain investment information disclosed in the accompanying financial statements, including the Plan's interest in the Master Trust as of December 31, 2024 and 2023, and the net investment income from the Master Trust for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

The average asset value must be within 10% of market value, including discounted contributions receivable (discounted using the effective interest rate for the prior plan year.)

The method of computing the actuarial value of assets complies with rules governing the calculation of such values under the Pension Protection Act of 2006 (PPA). These rules produce smoothed values that reflect the underlying market value of plan assets but fluctuate less than the market value. As a result, the actuarial value of assets will be lower than the market value in some years and greater in other years. However, over the long term under PPA's smoothing rules, the method has a significant bias to produce an actuarial value of assets that is below the market value of assets.

**Benefits not valued**

WTW has reviewed the plan provisions with the plan sponsor and, based on that review, is not aware of any other significant benefits required to be valued that were not.

## Sources of Data and Other Information

The plan sponsor, through its plan administrator, has furnished participant data as of 1/1/2024. Information on assets, contributions and plan provisions was supplied by the plan sponsor. Data and other information were reviewed for reasonableness and consistency, but no audit was performed. Based on discussions with the plan sponsor, assumptions or estimates were made when data were not available, and the data was adjusted to reflect any significant events that occurred between the date the data was collected and the measurement date. We are not aware of any errors or omissions in the data that would have a significant effect on the results of our calculations.

## Assumptions Rationale - Significant Economic Assumptions

**Discount rate**

The basis chosen was selected by the plan sponsor from among choices prescribed by law, all of which are based on observed market data over certain periods of time.

**Plan-related expenses**

As required by regulations, plan-related expenses are calculated by estimating the expenses to be paid from the trust during the coming year (including, for example, expected PBGC premiums and actuarial, accounting, legal, administration and trustee fees to be paid from the trust).

- **Compensation** Assumed increases were chosen by the plan sponsor and they represent an estimate of future experience. If, after completing at least 5 Years of Service, a Participant's employment terminates prior to his or her Normal Retirement Date for any reason other than death or early retirement, the Participant shall receive a Non-Contributory Retirement Benefit commencing on his or her Normal Retirement Date equal to his or her Non-Contributory Retirement Benefit under Normal Retirement Benefit.

Contributory Retirement Benefit. If the employment of a Participant who is a Contributor terminates for any reason other than death or early, normal or late retirement, the Participant shall receive a refund of the amount of his or her Employee Contributions with accumulated Interest as soon as administratively feasible thereafter provided that the Actuarial Equivalent of the Participant's entire vested Accrued Benefit is not in excess of \$1,000.

## **Disability**

Retirement Benefit shall be equal to the Participant's Accrued Benefit through the date of his or her termination of active employment due to such Permanent and Total Disability and shall be paid only in equal monthly installments for his or her expected lifetime. The automatic pre-retirement Surviving Spouse benefit shall continue to apply to the Participant if he or she dies while receiving a disability Retirement Benefit and prior to his or her Normal Retirement Date.

Terminally Ill - a disabled Participant who is likely to die before Normal Retirement Date to elect a more generous survivor's benefit than would otherwise be available. A Participant who is in the terminal stage of an illness or injury (as determined in the sole discretion of the Plan Administrator) and is receiving or is eligible to receive a disability Retirement Benefit may instead elect to receive a reduced Retirement Benefit (see Section 5.2). Such an election must be made prior to commencement of the Participant's disability Retirement Benefit or, if later, when the Participant first becomes eligible for a reduced Retirement Benefit.

## Preretirement death

The spouse will receive a benefit equal to 50% of the joint and 50% survivor annuity as of the participant's death. The surviving spouse can choose to receive the benefit commencing at the participant Normal Retirement Date or early retirement date. Such early retirement benefit being reduced by 0.4% for each month payment precedes the Participant's Normal Retirement Date. If the participant was a contributor, his/her contributions plus interest (at a rate of 5% per annum) shall be paid to his/her beneficiary. If a pre-retirement surviving spouse benefit is payable, such benefit shall be reduced by the amount of the participant contributions plus interest.

If an eligible participant dies after his/her retirement benefit commences, the beneficiary will receive in form of a lump sum the return of the excess, if any, of employee contributions with interest (at a rate of 5% per annum) less benefits paid.

## Other Plan Provisions

### Forms of payment

Preretirement death benefits are payable only as described above. Monthly pension benefits are paid as described above as a life annuity, if the participant has no spouse as of the date payments begin, or if the participant so elects. Otherwise, benefits are paid in

Optional forms are a 10 year Guaranteed Life Annuity, a Joint and Survivor Annuity (100%, 75% or 50% continuance). A Lump Sum Distribution is mandatory when the present value is less than \$1,000 and voluntary when the present value is greater than \$1,000 and the participant has reached age 55 and 10 years of service or Normal Retirement Age.
