## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Jacobs Entertainment Inc.'s 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Jacobs Entertainment Inc.'s 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following is a brief description of Jacobs Entertainment, Inc.'s 401(k) Plan (the "Plan"), which is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**—The Plan is a defined contribution plan covering eligible employees of Jacobs Entertainment, Inc. (the "Company") and certain related employees who are members of the controlled group of the Company. Eligible employees include all employees of the Company and such related employees who have completed three months of service and have reached the age of 18. The 401(k) Plan Committee of the Company monitors and oversees the operation and administration of the Plan. Fidelity Management Trust Company (the "Trustee" or "Fidelity") serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**—Each year, participants may contribute not less than 1% and up to 90% of their pretax annual compensation, as defined in the plan document. Additionally, participants have the option to make Roth elective salary reduction contributions to the Plan. The Plan provides that participants who have attained age 50 by the end of the calendar year and who are making deferred contributions to the Plan may also make a catch-up contribution of up to \$7,500 (in 2024). After three months of service, the Company contributes an amount equal to 50% of each participant's elected contribution, not exceeding 5% of the participant's eligible compensation. For purposes of determining matching contributions under the Plan, contributions will include age 50 and over catch-up contributions. In addition to matching contributions, discretionary contributions may be awarded at the option of the Company's Board of Directors. During the year ended December 31, 2024, there were no discretionary contributions. Participants may also contribute eligible rollover distributions from other qualified plans. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**—Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, allocations of the Company's discretionary contributions, and Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**—Participants direct the investment of their contributions and all Company matching contributions into various investment options offered by the Plan, including mutual funds and a stable value fund, which is a common collective trust fund, and may change investments and transfer amounts between funds daily.

**Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service in accordance with the following schedule:

**Notes Receivable from Participants**—Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance during the prior twelve month period or 50% of their vested account balance. Borrowings are subject to approval by the Plan’s Trustee, and participants may have only one loan outstanding at any time. The loans are secured by the balance in the participant’s vested account and bear interest at 1% over the prime rate at the time the loan is issued. Principal and interest are paid ratably through regular payroll deductions over the life of the loan. As of December 31, 2024, notes receivable from participants mature through 2030 at interest rates ranging from 4.25% to 9.50%.

**Forfeited Accounts**—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67,986 and \$70,910, respectively. These accounts will be used to reduce future employer matching contributions or Plan administrative expenses. For the year ended December 31, 2024, employer contributions were reduced by \$87,592 from forfeited nonvested accounts.

**Payment of Benefits**—Upon termination of service with the Company due to death, disability, or retirement, a participant will become fully vested and entitled to a lump-sum amount equal to the value of the participant’s vested interest or any portion in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

## **2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risk and Uncertainties**—Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

**Contributions**—Participant contributions and Company matching contributions are recorded when withheld or when earned, respectively.

**Administrative Expenses**—Administrative expenses of the Plan are paid by the Company or the Plan as provided in the plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative revenues arise when investment managers return a portion of the investment fees to Fidelity. Participant accounts are credited for the administrative revenue allowance that each of the funds generates.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no participants who have elected to withdraw from the Plan, but have not yet been paid, as of December 31, 2024 and 2023.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the IRC limits.

**Subsequent Events**—Subsequent events were evaluated through August 28, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustments to the Plan's financial statements.

### 3. FAIR VALUE MEASUREMENT

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Investments are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds*—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund*—Common collective trust that is comprised primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds would sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level within the fair value hierarchy a summary of the Plan’s investments measured at fair value on a recurring basis as of December 31, 2024 and 2023. In accordance with Subtopic 820-10, certain investments that are measured at fair value using the NAV per share as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the investment amounts presented in the statements of net assets available for benefits.

## 6. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a common collective trust fund managed by Fidelity. Jacobs Entertainment, Inc. is the Plan sponsor and Fidelity is the trustee and recordkeeper, as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return on each fund. The Plan also issues loans to participants, which are secured by the vested balances in the participant's accounts.

## 7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

## 8. FEDERAL INCOME TAX STATUS

The Plan uses a non-standardized pre-approved plan document sponsored by Fidelity Management & Research Company LLC ("FMR"). FMR received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, which stated that the non-standardized pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The non-standardized pre-approved plan document has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Sponsor believes the Plan has

maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.
