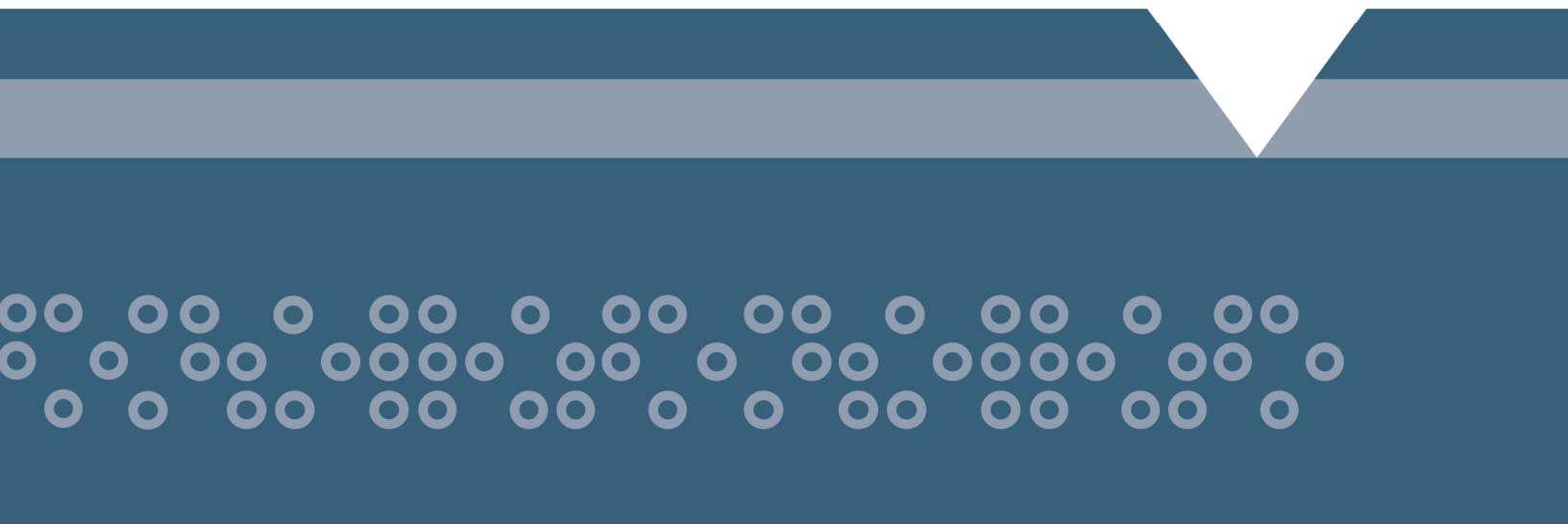

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Trendsetter 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of change in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Trendsetter 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Trendsetter 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Trendsetter 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Note 1 – Description of Plan:

The following description of Trendsetter 401(k) Plan (“the Plan”, “we”, or “our”) provides only general information. Participants should refer to the Plan agreement for a complete description of our provisions.

General

We are a defined contribution plan and are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan eligibility includes substantially all eligible employees of Trendsetter Construction, Inc. (the Company or the Employer). The Reliance Trust Company (Reliance Trust) serves as the Plan asset custodian and ADP, LLC (ADP) serves as the third-party administrator.

Eligibility

Participants in the Plan is limited to employees of the Trendsetter Construction, Inc. who have attained the age of 21 and have completed 6 months of continuous service as defined by the Plan document. Employees may enter the Plan on the first day of the month after they become eligible. Upon completion of eligibility requirements, participants are automatically enrolled in the Plan at the next available enrollment date.

Contributions

The Plan allows salary deferral contributions and employer discretionary match contributions. The Plan has no required matching contribution feature. Each year, participants may elect to contribute up to 90 percent of eligible compensation, as defined in the Plan. Participants who have met certain requirements are eligible to match “catch up” contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, even if they have not met the requirements to be a participant.

Effective January 1, 2024, the Plan elected safe harbor status under Internal Revenue Code Section 401(k)(12). Under the safe harbor provisions, the Employer is required to make a matching contribution equal to 100% of each participant’s elective deferrals up to 4% of eligible compensation. For plan year 2023, the Employer made discretionary matching contributions, which equaled 2% of eligible compensation for participants.

Participant’s Account

Each participant’s account is credited with the applicable contributions, and allocations of Plan earnings based on the participant’s individual account balances and investment options selected. The benefit to which a participant is entitled is the benefit that can be provided from their vested account balance.

Vesting

Participant’s interest in discretionary matching contributions that the Company made to the Plan is based on years of continuous service and generally begins at zero percent with up to two years of credited service and increases to 100 percent after three years of credited service. A year of service is considered to be 1,000 hours worked within one plan year. Participants are immediately vested in their voluntary and safe harbor contributions plus actual earnings thereon.

Payment of Benefits

Pursuant to the Plan document, after a participant terminates employment with the employer, the time at which the Plan will commence distribution and the form of that distribution depends on whether the vested balance exceeds \$5,000. Balances less than \$5,000 are generally payable as soon as possible after termination. Distributions on account balances in excess of \$5,000 will be made when elected by the participant.

The Plan may receive excess contributions for certain participants. Excess contributions are refunded to participants in the first two and a half months of the subsequent Plan year per IRS regulation.

Participants may make withdrawals from their account for hardship purposes as defined by the Plan document. Only vested account balances are available for hardship withdrawals. Participants must be a current employee of Trendsetter Construction, Inc. at the time of the hardship distribution. Additional distributions are available for terminated employees, current employees over age 59½, and required minimum distributions.

At December 31, 2024 there were no plan assets allocated to accounts of persons who had withdrawn from the Plan but had not been paid.

Forfeitures

Forfeitures represent the portion of non-vested benefit payments remaining in the Plan for terminated employees. Forfeitures are used to reduce employer matching contributions or pay administrative expenses. Forfeited amounts for 2024 totaled \$126. This amount accumulates from year-to-year and may be used to reduce employer matching contributions and to pay administrative expenses. The balance of this account as of December 31, 2024 and 2023 was \$126 and \$493, respectively. The Plan did not use any forfeiture funds for allowable reductions in matching contributions or Plan expenses for the 2024 and 2023 Plan years.

Note 2 – Significant Accounting Policies:

Basis of Presentation

Our financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires us to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from those estimates. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on an ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the market value of these investments may occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Concentration of Credit Risk:

The Plan contains certain investment options, whose balances represent a significant concentration of Plan investments. For the year ended December 31, 2024, Fidelity Freedom Index 2030, 2040, and 2050 represented 32 percent of total investments, and each individually represented in excess of 10 percent of total investments. For the year ended December 31, 2023, Fidelity Freedom Index 2030, 2040, and 2050 represented 45 percent of total investments, and each individually represented in excess of 10 percent of total investments.

Note 4 – Information Prepared and Certified by Plan Custodian:

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The assets of the Plan are held by the custodian.

The Plan has received certification from the custodian of the market value of all the Plan’s investments as of December 31, 2024 and 2023, and of interest income and net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023. The Plan’s financial statements and supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, have been prepared based upon this certified information and reflect the amounts certified by the custodian.

Note 5 – Expenses of Plan:

All reasonable expenses of administering the Plan will be paid out of the Plan assets, unless paid for by the Company. The Company paid or reimbursed the Plan for Plan expenses which amounted to \$9,000 for the years ended 2024 and 2023.

Note 6 – Income Tax Status:

The IRS has determined and informed the Plan sponsor by a letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) based on ADP’s prototype non-standardized profit-sharing plan. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan administrator believes the Plan has no income subject to unrelated business income tax.

Note 7 – Fair Value Measurements:

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. Following is a description of the valuation methodologies used for investments held within the group variable funding agreement which are measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued based on the unobservable NAV of the underlying investments. NAV, as provided by the trustee, is used as a practical expedient. The common collective trust is maintained in the general account of Reliance Trust and is credited with earnings of the underlying assets, participant withdrawals, and administrative expense.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 – inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 – observable inputs, such as, quoted market prices of similar assets or liabilities in active markets or for identical assets or liabilities in markets that are not active, and Level 3 – inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Note 8 – Amendment and Termination:

Although it has not expressed any intent to do so, the Company may elect to terminate the Plan entirely at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 9 – Party-in-Interest and Related Party Transactions:

The Plan paid both direct and indirect fees to the Trustee for investment management services. Additionally, certain trustees of the Plan may participate and transact within the parameters of the Plan document. Transactions such as these qualify as party-in-interest transactions.

The Plan holds various investment instruments via mutual funds and interest-bearing cash options. Each of the instruments is designed to offer participants various levels of risk tolerance. In general, all investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market volatility can be impacted by both domestic and global economic conditions. Due to the level of risk associated with certain investment options, it is reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported on the financial statements. However, it is difficult to forecast these conditions future impact on the Plans operations and assets with any certainty.

Note 12 – Subsequent Events:

We have evaluated subsequent events through August 28, 2025, the date which the financial statements were available to be issued.
