**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Tri-Supply Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was effective as of August 1, 1971, and amended and restated effective June 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: The Plan is a defined contribution plan, which covers eligible employees of Tri-Supply LLC and participating employers, Backyard & Patio LLC, Ray Plane LLC, Ray Mart Inc., and Tri-BCI, LLC (collectively, the Company or the Sponsor), who have completed 60 days of service and are age 18 or older. Employees who are classified as union employees, non-resident aliens who have no earned income from sources within the United States and self-employed individuals are excluded from the Plan. Employees can enter the Plan the first day of the month following the satisfaction of eligibility requirements.

Contributions: Each year, participants may contribute, on a pre-tax basis, up to 90% of their eligible annual compensation to the Plan. Participants may also designate some or all of their contributions as Roth contributions. A participant's contribution cannot exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) Section 402(g). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who are age 50 or will attain age 50 before the end of the calendar year, may also make additional catch-up salary deferral contributions that are in addition to any limits that are imposed by the Plan and federal law. Effective November 1, 2023, the Company adopted an automatic salary deferral feature. Upon eligibility, the Sponsor will automatically enroll participants at a 3% contribution rate.

The Sponsor may make a discretionary matching contribution equal to a percentage of the participants salary deferrals. The Sponsor may also make a discretionary nonelective contribution. The contribution will be determined by calculating the participant's share based on their annual compensation relative to annual compensation of all participants who are eligible to receive the nonelective contribution. In order to receive the discretionary nonelective contribution, the participant must be employed on the last day of the year and have completed at least 500 hours of service during the Plan year. For 2024, the Sponsor elected to not make any discretionary matching or nonelective contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, the employer contributions, rollover contributions, an allocation of Plan earnings (losses), and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants direct the investment of their entire interest in the Plan. Participants may modify elections, transfer existing balances, and obtain information regarding investments on a daily basis.

Vesting: Participants are immediately vested in all participant and Sponsor contributions plus actual earnings thereon.

Notes Receivable From Participants: The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are charged an interest rate equal to the prime rate as published in the Wall Street Journal on the 14th day of each month, plus one percent. All loans are repayable over a period not to exceed five years, except for loans for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive the value of vested interest in his or her account as a lump sum distribution. After a participant's termination of employment from the Company, if the vested amount of their account does not exceed \$7,000, their vested account will be distributed from the Plan. The participant may either elect to receive this distribution in cash or to roll over the distribution to an IRA or the qualified plan of their new employer. If the vested amount of a participant's account exceeds \$7,000, they must consent to any distribution of their account.

Participants who reach age 59½ may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Administrative Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Sponsor. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Subsequent Events: The Plan has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued. No events have occurred that would require adjustment to or disclosure in the financial statements.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivables From Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Participants' Contributions Payable: The accompanying statements of net assets available for benefits include \$38,068 and \$78,080 in excess participants' contributions payable as of December 31, 2024 and 2023, respectively. The excess contributions have subsequently been refunded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust – Stable Value Fund: The fair values of participation units held in the collective trust are based on the net asset values per unit as reported by the fund managers. Participant-level transactions in the collective trust are processed daily. Plan-level redemptions, such as full or partial withdrawals of the Plan’s investment, are subject to a 12-month irrevocable notice period

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor. ADP Retirement Services (ADP) is a service provider to the Plan and, therefore, the Plan's payment of fees to ADP qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC. The pre-approved profit sharing plan obtained its latest opinion letter on October 06, 2020, in which the Internal Revenue Service stated that the pre-approved profit sharing plan, as then designed, was acceptable under section 401 of the IRC for use by the employer for the benefits of its employees. Although the Plan has been amended from the original pre-approved document, the Sponsor believes that the Plan is currently being operated in accordance with the requirements of the IRC.

GAAP requires the Sponsor to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
