The undersigned (We) are providing this letter in connection with Forvis Mazars' audit of the financial statements of Atlas 401(K) Profit Sharing and Retirement Plan (the Plan) as of and for the years ended December 31, 2024 and 2023, and supplemental schedules as of December 31, 2024.

Further, the Plan Sponsor is solely responsible for all aspects of managing the Plan, including questioning the quality and valuation of investments.

18. We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan received in communications from participants, former participants, regulators, third-party servicers or others.
