Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Electri-Cord Manufacturing Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Electri-Cord Manufacturing Co. (“the Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration

The Company is the Plan Sponsor and Plan Administrator. Automatic Data Processing, Inc. (“ADP”) provides recordkeeping services for the Plan. Reliance Trust Company (“Reliance”) is the trustee and custodian of the Plan’s assets and executes investment transactions.

Eligibility

Employees of the Company that are not non-resident aliens or probationary employees, are at least 18 years of age, and who have completed one month of service at the Company are eligible to participate in the Plan.

Contributions

Participants are permitted to contribute up to 90% of their pre-tax compensation, subject to certain limitations under terms of the Plan and the Internal Revenue Code (“IRC”). The Company contributes a safe harbor match of 100% of the first 3% of eligible compensation, plus 50% of contributions over 3%, but not to exceed 5%, of a participant’s base compensation that a participant contributes to the Plan. Additional amounts may be contributed to the Plan at the discretion of the Company, subject to certain limitations. The Company did not make any discretionary contributions in 2024 or 2023.

Participant Accounts

Participants direct the investment of their contributions into the various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and allocations of: (a) the Company’s contributions (b) the participant’s share of Plan earnings/losses, and (c) certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company’s contributions plus actual earnings/losses thereon.

Investment Options

Upon enrollment in the Plan, participants may direct elective and non-elective contributions in any of the investment options offered by the Plan. Participants may change their investment options daily.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to a minimum loan amount of \$1,000. A participant may only have one note outstanding at any time. Loan terms range from one to five years but may be extended if the proceeds are used for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1% per annum on the date of the note. This rate is fixed for the duration of the note. Principal and interest is paid ratably through payroll deductions and is credited to the participant's account.

Benefit Payments

On termination of service, disability or retirement, a participant may elect to leave their funds in the Plan, receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, receive periodic installments over the expected life span of the participant or roll their funds into another plan. Terminated participants with a vested balance of \$5,000 or less are automatically paid in lump-sum payments. The normal retirement age is the date a participant reaches the age of 65.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance, subject to a minimum distribution amount of \$500, upon the attainment of age 59 ½. Participants may also withdraw any of their rollover contribution balance at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's vested account balance, subject to a minimum distribution amount of \$500. All hardship withdrawals are subject to the Company's approval and must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Administrative Expenses

The majority of the Plan's administrative expenses are paid by the Plan.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement. A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest on outstanding loans at year-end. Interest income is recorded on the accrual basis. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: valued at fair value based on quoted market prices in active markets.

Common collective trust funds: valued at fair value using the NAV per share practical expedient based on information reported by the investment advisors using the audited financial statements of the common collective trusts at year-end.

Investment in Entities that Calculate Net Asset Value

The Plan is invested in common collective trusts (CCT) that calculate NAV on a daily basis. Units are issued and redeemed as of the end of each day at the daily NAV.

The Plan's Stable Asset CCT's primary investment objective is to seek income while preserving principal and provide daily liquidity at contract value for participant withdrawals and transfers. The Plan's Lending Series CCTs' primary investment objectives are to approximate the performance of certain indices over the long term and provide daily liquidity at contract value for participant withdrawals and transfers. Redemptions are generally restricted to processing on a valuation date at the daily NAV per unit computed on that date. CCT units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the CCTs. The CCTs do not have any unfunded commitments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Reliance is the Plan trustee and custodian of the Plan's assets. As such, transactions between Reliance and the Plan qualify as party-in-interest transactions. Additionally, Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by ADP, LLC. The pre-approved plan received an IRS Opinion Letter dated October 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, ADP Retirement Trust Services, LLC became the trustee of the Plan. Effective June 1, 2025, the Plan was amended to allow for Roth elective deferrals.
