## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Participants of the  
Scott Miller Salon 401(k) Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Scott Miller Salon 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Scott Miller Salon 401(k) Profit Sharing Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Scott Miller Salon 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**



#### **Note 1 Description of Plan**

---

The following description of the Scott Miller Salon 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”) for the benefit of all eligible employees of the Scott Miller Salon (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The stockholders of the Company are responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

#### **Eligibility**

Employees are eligible to participate in the Plan on attaining age 18 and having completed one year of service during the Plan year. Employees covered by a collective bargaining unit, non-resident aliens, and interns and temporary employees hired for specific projects are not eligible for participation in the Plan.

#### **Contributions**

Each year, a participant may elect to contribute up to the maximum limits as permitted by law through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make discretionary matching contributions as declared by the Plan sponsor. There were no discretionary matching contributions for the Plan year ended December 31, 2024. The Company may also make discretionary profit sharing contributions, which are allocated to participant accounts in the ratio that each participant’s compensation for the Plan year bears to the total compensation for all participants for the Plan year. No discretionary profit sharing contributions were made in 2024. Participants generally must be employed on the last day of the Plan year to be eligible to receive either the matching or profit sharing contribution.

Participants direct the investment of their contributions, the discretionary employer matching, and profit sharing contributions into various investment options offered by the Plan.

Contributions are subject to certain statutory limitations.

---

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer discretionary matching contributions, an allocation of discretionary profit sharing contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

##### **Notes Receivable from Participants**

A participant may borrow from their account the lesser of \$50,000 or 50 percent of his or her vested account balance, with a minimum loan amount of \$1,000. The loans are secured by the balance in the participant's account and accrue interest at rates which are commensurate with prevailing market conditions as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

##### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant will receive an amount equal to the value of the participant's vested interest in his or her account balance. Terminated participants with balances of less than \$5,000 shall have their vested account balance paid in a single lump sum distribution.

##### **Forfeited Accounts**

Forfeitures of employer matching and profit sharing contributions may be used to reduce future employer contributions or pay plan expenses. Forfeited non-vested accounts are not significant for the plan.

#### *Note 2* Significant Accounting Policies

---

##### **Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Note 2 Significant Accounting Policies - Continued**

##### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's co-presidents determine the Plan's valuation policies utilizing information provided by the investment advisors, trustees and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Any related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Expenses of maintaining the Plan may be paid by the Plan or the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in the fair value of investments.

##### **Date of Management's Review**

The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through August 27, 2025, the date the financial statements were available to be issued. Management has determined that no such events have occurred.

#### **Note 3 Information Prepared and Certified by Mid Atlantic Trust Company**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, a qualified institution, and the custodian of the Plan.

#### **Note 4 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds:* Valued at the daily closing price as reported by the fund.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 Related Party Transactions and Party-In-Interest Transactions**

Mid Atlantic Trust Company is the custodian for the Plan and therefore custodial fees paid qualify as party-in-interest transactions. Paychex Retirement Services, Inc. is the record keeper for the Plan and therefore record keeping, loan, and benefit payment processing transactions qualify as party-in-interest transactions.

#### ***Note 6*** Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in employer contributions allocated to their account.

#### ***Note 7*** Tax Status

---

The Company adopted a Prototype Non-Standardized Profit Sharing Plan with the CODA feature which received a favorable opinion letter from the Internal Revenue Service dated August 31, 2020. The opinion letter stated that the Plan and the related trust were designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ***Note 8*** Risks and Uncertainties

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
