Note 1 - Plan Description

The following description of HCR ManorCare Retirement Savings 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of ProMedica Employment Services, LLC (formerly known as Heartland Employment Services, LLC) (the "Company"), a wholly owned subsidiary of HCR ManorCare, Inc., and employees of affiliated companies that adopted the Plan with the consent of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024 and 2023, many HCR ManorCare locations were either closed or sold, resulting in a significant decrease in total plan participants.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, reduced by the participant's highest outstanding note receivable balance, if any, over the 12-month period. Participants may have one note outstanding at a time and must wait 90 days after paying off a note before requesting another. Only one note can be requested in a 12-month period. Notes receivable are collateralized by the participant's account balance and bear interest at the prime rate plus 1 percent over a period not to exceed 5 years or, if used for the purchase of their primary residence, 10 years. Notes receivable are subject to a one-time administrative service fee at the time the note is initiated and a quarterly servicing fee.

Participant Accounts

Each participant's account is credited with the participant's contributions, company matching contributions, and allocation of the plan earnings, net of any participant-related administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Contributions

The Plan currently allows participants to contribute up to 75 percent of their annual compensation on a pretax or Roth basis subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan provides for a non-discretionary employer matching contribution. Participants must be employed on the last day of the of plan year and earn at least 1,000 hours of service, with the exceptions for reaching normal retirement age, death, and disability. For the plan years ended December 31, 2024 and 2023, employer matching contributions were calculated based on 50 percent of the participant's contribution, not to exceed 2 percent of the employee's eligible compensation.

The employer matching contribution is funded subsequent to year end. The employer match is directed to the participant's investment election. If the participant fails to make an investment election, it will be automatically invested in the plan-designated default fund based on the participant's year of birth and may be immediately redirected by the participant.

The Plan provides that the Company, at its sole discretion, may also make additional discretionary contributions to the Plan on behalf of the participants.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 20 percent after two years of service, an additional 20 percent after the third year of service, and another 20 percent per year thereafter until they become fully vested after six years of service.

As discussed below, the Company elected to discontinue the Plan. As a result, affected participants are immediately 100 percent vested in the Company's contribution, plus actual earnings thereon.

Payment of Benefits

Distributions are available upon attainment of 59½ years of age, retirement, death, disability, or termination of employment and can be paid in the form of a lump-sum amount equal to the vested balance or partial balance of a participant's account or a direct rollover.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$660,572 and \$1,196,346, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

During 2023, due to the reduction of participants, the Plan was partially terminated. ProMedica Employment Services, LLC is still deciding on if the Plan will fully terminate, or alternatively, merge into a separate plan. Subsequent to January 2025, there were no participants actively contributing to the Plan. On July 31, 2025, all active employees of the ProMedica system with an account balance and any employee terminated subsequent to November 4, 2024 with an account balance were spun off and merged into the ProMedica Health Systems, Inc. 401(k) Plan. Plan assets of approximately \$49,080,000 were transferred. The Plan is subject to the provisions set forth in the plan agreements and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note receivable balance is reduced by the outstanding amount and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 11, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
