INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of **Sabel Systems Technology Solutions, LLC 401(k) Plan**:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

A. Description of Plan

The following description of Sabel Systems Technology Solutions, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

Sabel Systems Technology Solutions, LLC (the "Company") is the Plan Sponsor and Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a defined contribution, tax-deferred safe harbor 401(k) profit sharing plan covering most salaried and hourly wage employees of the Company. Interns, part-time employees, and temporary employees are exempt from participation unless they work at least 1,000 hours in a Plan year or work at least 500 hours in each of three consecutive years. There are no age or service requirements for general participation. New employees may register and make employee deferrals contributions immediately upon employment. The eligibility requirement for safe harbor matching and employer profit sharing contributions is 180 days of service. Entry to the Plan for safe harbor matching and employer profit sharing contributions is monthly.

Contributions

Participants may contribute up to 100% of compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation is defined in the Plan documents, and includes Wages, Tips and Other Compensation on Form W-2, plus elective deferrals and contributions made to a qualified cafeteria plan. Certain components of compensation, such as commissions, taxable fringe benefits, and leave cash-outs, are excluded from the Plan definition of compensation, and thereby excluded from the calculation of both employee and employer contributions to the Plan.

Participants may elect to make deferral contributions either as pre-tax contributions, after-tax Roth contributions, or a combination of both. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also may make rollover contributions of distributions from other retirement plans and certain individual retirement accounts, subject to Plan provisions. Participant contributions are invested according to the direction of the participant.

The Company makes safe harbor matching contributions to eligible participants equal to 100% of salary deferrals up to 5% of compensation each pay period.

The Plan allows discretionary employer profit sharing contributions to participant accounts, although these contributions are not required. Any profit sharing contributions will be allocated to eligible employees according to the allocation formula specified in the Plan. No profit sharing contributions were made in 2024. Safe harbor matching contributions and employer profit sharing contributions are invested according to participant investment elections.

Participant Accounts

Each participant's account is credited with the participant's contributions, safe harbor matching contributions, and any profit sharing contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their own deferral contributions, rollover contributions, safe harbor matching contributions, employer profit sharing contributions, and the earnings thereon.

Participant Loans

Participants who are active employees may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, subject to certain other Plan provisions. Loans are secured by the balance in the participant's account and bear interest at prime plus 2%. Principal and interest are paid ratably through payroll deduction from each regular paycheck. A Participant may only have one loan outstanding at any time.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Benefit payments, limited to the value of the participant's vested interest in his or her account, may be elected as a lump-sum payment or rollover, or in certain cases as payments over a period of time to meet minimum distribution requirements, subject to Plan provisions. Terminated or deceased participants whose account balances do not exceed \$5,000 may be automatically distributed in the form of a single lump sum payment or other form of payment elected by the participant.

Forfeitures

At December 31, 2024 and 2023, forfeitures related to refunds of excess contributions were \$7 and \$1,536, respectively. Forfeitures may be used to cover Plan expenses or to offset employer contributions. \$7,869 of forfeitures were used to reduce employer contributions expenses during 2024.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. Recordkeeping, third party administration services, and advisory services are included in fees and other expenses. Other investment related expenses are included in net appreciation or depreciation of fair value of investments.

Subsequent Events

The Plan administrator has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

C. Information Prepared and Certified by the Plan Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, John Hancock Trust Company LLC, the trustee of the Plan, has certified as to the completeness and accuracy of reported investment and notes receivable balances and related activity in these financial statements and supplemental schedule, summarized as follows:

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or

liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Related Party and Party-In-Interest Transactions

John Hancock Trust Company LLC is the trustee of the Plan and receives fees for services. John Hancock Retirement Plan Services, LLC is the Plan recordkeeper and receives fees for services and per-use transactions. A third party administrator provides services and receives fees for services rendered. The company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as party-in-interest transactions.

F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts and the Company will arrange for distributions as soon as administratively feasible.

G. Tax Status

The IRS has determined and reported in its opinion letter dated June 30, 2020, that the form of adopted pre-approved plan is designed in accordance with applicable sections of the IRC for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
