Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Anchor Glass Container Corporation Hourly Employees' Supplemental Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP"), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

As of December 31, 2024 and 2023 and the Year Ended December 31, 2024

(1) Description of the Plan

The following description of the Anchor Glass Container Corporation Hourly Employees' Supplemental Retirement Plan (the "Plan") is provided herein for general information purposes only. Participants should refer to the Plan document for more complete information.

Plan Participation and Administration. The Plan is a defined contribution retirement plan covering substantially all hourly employees of Anchor Glass Container Corporation (the "Company" or "Employer"). The Plan is administered by the Company. The Plan's trustee is Vanguard Fiduciary Trust Company (the "Trustee" or "Vanguard").

Plan Provisions. All employees that have completed ninety days of service are eligible to participate in the Plan. Under certain conditions, as defined, the Plan allows the withdrawal of a participant's account upon termination, death or retirement. In addition, the Plan allows certain in-service withdrawals. Participants receiving distributions from other qualified plans are permitted to rollover (transfer) these distributions into the Plan. All distributions from the Plan are made in the form of a cash lump sum.

Employer Contributions. The Company makes employer contributions equal to 35% of participant eligible contributions, as defined in the Plan. Employer contributions are not to exceed the first 10% of participant's eligible compensation, as defined in the Plan.

Participant Contributions. Participants may contribute to the Plan through payroll deferrals using whole percentages of their compensation on a pre-tax basis and after-tax basis. The participant's total contribution is subject to limitation as defined in the Plan.

Participant Accounts. Participant accounts are credited with participant contributions and the allocated portion of employer contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined.

Vesting. Participants are immediately 100% vested in their pre- and after-tax contributions, rollover contributions and the earnings or losses there from. Participants are 100% vested in employer contributions after three years of service with the Company.

Forfeiture Allocation. Participants who terminate prior to becoming 100% vested forfeit their nonvested portion of employer contributions, as defined. Any such forfeitures are used to pay the Plan's administrative expenses and to reduce the Company's future contributions, except under certain defined conditions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39,548 and \$56,508, respectively.

(1) Description of the Plan, Continued

Investment Options. The Plan permits participants to direct the investment of all participant and Employer contributions.

Notes Receivable from Participants. Participants may take only one loan during any twelve-month period and no more than one loan may be outstanding at any time. The minimum amount of any loan is \$1,000. The maximum is an amount not to exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the balances in the participants' accounts. The repayment period shall not exceed five years for a general-purpose loan. Participants may take out loans used to acquire a principal residence. For loans used to acquire a principal residence, participants may select a repayment period up to fifteen years, with a minimum period of five years. Any unpaid loan balance that exists upon a participant's termination will be subtracted from the total account balance in determining the amount of actual distribution. The unpaid loan balance will be included as part of the taxable distribution from the Plan. Each loan shall bear interest at the prime rate. Interest rates on loans outstanding during 2024 range from 3.25% to 8.50%. Loan repayments are generally handled through payroll deductions. Loans are measured at the unpaid principal balance plus accrued interest.

Plan Termination. Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. Upon termination of the Plan, participants become 100% vested in their accounts.

(2) Significant Accounting Policies

The following is a summary of significant accounting policies and practices followed by the Plan in the preparation of its financial statements:

Basis of Presentation. The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition. Mutual funds of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

(2) Significant Accounting Policies, Continued

Investment Valuation and Income Recognition, Continued. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gains distributions are included as dividend income.

Investment contracts held by a defined contribution plan are reported at contract value. This applies even when the contracts are not held directly by the Plan but are underlying assets in Common Collective Trust ("CCT") investments held by the Plan. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a CCT.

Payment of Benefits. Benefits are recorded when paid.

Party-In-Interest. The Plan invests in shares of mutual funds and common collective trusts managed by an affiliate of Vanguard, who acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Use of Estimates. The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts in the statements of net assets available for benefits and the statement of changes in net assets available for benefits for the reporting period. Actual results may differ from those estimates.

Subsequent Events. Management has evaluated all significant events occurring subsequent to the financial statements date through August 13, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

(4) Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Common Collective Trust

The Plan entered into a common collective trust with Vanguard totaling \$20,091,057 and \$24,411,551 at December 31, 2024 and 2023, respectively. Vanguard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Vanguard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate for the common collective trust is based on the earnings of the underlying assets in the common collective trust and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the common collective trust was 2.6% for the year ended December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

(6) Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes the Plan is currently operating in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The Plan provides for investments in CCTs and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risks associated with such investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
