## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the Cintas Corporation (G&K Services) 401(k) Savings Incentive Plan (the Plan) provides general information about the Plan's provisions. Cintas Corporation (the Company) is the Plan Sponsor. Participants should refer to the Plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

#### **General**

The Plan is a defined contribution plan covering substantially all qualified legacy G&K Services, Inc. union employees of the Company. Cintas serves as the Plan Administrator. Fifth Third Institutional Services serves as the trustee, and, as of January 19, 2023, Alight Solutions, LLC serves as the recordkeeper of the Plan. Prior to January 19, 2023, Empowerment Retirement, LLC served as the recordkeeper of the Plan, as an agent of Fifth Third Institutional Services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Participants may elect to make contributions to the Plan of up to 75% of their annual compensation, as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Code (the Code). Under provisions of the Code, the Plan also allows participants to roll over funds from other qualified plans into the Plan. Non-union employees were no longer allowed to contribute to the Plan effective June 4, 2017, when they became eligible to participate in the Cintas Partners' Plan. Union employees with Legacy G&K locations continue to be eligible to contribute to the Plan.

The Company will contribute an amount equal to 100% of a participant's elective deferrals that do not exceed 3% of their compensation (as defined by the Plan), plus 50% of the participant's elective deferrals that exceed 3%, but do not exceed 5%, of such participant's compensation.

The Company shall also make employer transition contributions for participants eligible to receive such contributions. For the year ended December 31, 2024 and 2023, there were no employer transition contributions.

## Notes to Financial Statements (continued)

### **1. Description of Plan (continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant and Company contributions and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### **Vesting**

Participant pre-tax contributions, rollover contributions, safe harbor matching contributions and employer transition contributions are 100% vested and cannot be forfeited. Participants become 100% vested in employer matching contributions after completing three years of service. Participants reaching the normal retirement age of 65 while still employed by the Company or terminating employment due to permanent disability or death automatically become fully vested in all Company contributions.

#### **Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts are used to pay the Plan's administrative expenses. At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$26,759 and \$66,260, respectively. Forfeitures were used to pay the Plan's \$40,381 in administrative expenses in 2024.

#### **Investment Elections**

Participants are allowed to invest in a variety of investment choices, as more fully described in the Plan's literature. All choices vary in type of investment, rate of return and investment risk. Participants may elect to have all or part of their account balance and future contributions transferred from one fund to another or in any combination.

## Notes to Financial Statements (continued)

### **1. Description of Plan (continued)**

#### **Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms may not exceed five years, unless the purpose of the loan is to acquire a principal residence. Participants are only allowed to have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, as defined by the Plan. At December 31, 2024 and 2023, the interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions, and notes are due in various amounts through May 2029.

#### **Payment of Benefits**

Upon termination of employment, death, permanent disability or termination of the Plan, a participant or designated beneficiary will receive the vested portion of the participant's account balance. A participant or designated beneficiary will receive a lump-sum amount, if the vested account balance is \$1,000 or less. If the vested account balance is greater than \$1,000, the participant or beneficiary either may elect to receive a lump-sum amount or may elect to have the balance paid directly to an eligible retirement plan. If the vested account balance is greater than \$5,000, the distribution can also be received in the form of installments over a period of time. If the vested account balance is greater than \$5,000, the participant may also elect to leave their balance in the Plan. Withdrawals of rollover contributions and hardship withdrawals are allowed at any time. Upon obtaining age 59½, a participant may request a withdrawal of all or part of his vested account balance without limitation. Certain other benefit options are available to participants of former plans.

#### **Administrative Expenses**

Administrative expenses of the Plan are paid primarily from Plan assets. Certain fees and expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Certain Plan expenses are charged directly to the participants' accounts and are included in administrative expenses.

### **1. Description of Plan (continued)**

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA and the union Collective Bargaining Agreement. In the event of the Plan's termination, each participant's account would become fully vested, nonforfeitable and distributable in accordance with the provisions of the Plan document.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document.

#### **Use of Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, the accompanying notes and supplemental schedule. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by The Fifth Third Bank, the trustee.

### 4. Fair Value Measurements

The Plan follows the provisions of the Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement* (ASC 820), which defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a framework for measuring fair value. ASC 820 defines a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date.

ASC 820 emphasizes that fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing an asset or liability. As a basis for considering market participant assumption in fair value measurements, and as noted above, ASC 820 defines a three-level fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity and the reporting entity's own assumptions about market participants.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

The fair value hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

- *Level 1:* Inputs utilize unadjusted quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- *Level 2:* Inputs may include quoted prices for similar assets and liabilities in active markets, as well as inputs that are observable for the asset and liability (other than quoted prices), such as interest rates, foreign exchange rates, and yield curves that are observable at commonly quoted intervals.
- *Level 3:* Inputs are unobservable inputs for the asset or liability, which is typically based on an entity's own assumptions, as there is little, if any, related market activity.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability.

The following is a description of the valuation method used for investments measured at fair value:

- *Shares of mutual funds:* The fair value of these securities is based on the observable market quotations for the actual underlying funds, which is traded on national exchange and is priced daily at the close of business. The Plan does not adjust the quoted price.
- *Shares of common collective trusts:* The common collective trusts are public investment vehicles valued at net asset value (NAV) provided by the manager of each fund. The NAV is based on the underlying net assets owned by the fund divided by the number of shares outstanding. The daily NAV is available to participants of the Plan when they log into their online account to view their current balance. The common collective trusts allow participants to make daily redemption requests at the current NAV. As a result, the Plan has determined that the common collective trusts have a readily determinable fair value based on similar assets (i.e., mutual funds) and, therefore, each meet the criteria to be classified as Level 1.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **6. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated January 25, 2018, stating that the Plan is qualified under Section 401(a) of the Code, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended as of October 4, 2018. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Subsequent Events**

Management evaluated subsequent events for the Plan through September 2, 2025, the date the financial statements were available to be issued.
