We have audited the financial statements of **Gosiger 401(k) Savings Plan and Trust** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024, and have issued our report thereon dated August 27, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Voya Institutional Trust Company, the Trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements of information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated April 14, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### ***Qualitative Aspects of Accounting Practices***

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the Plan's financial statements in the proper period.

Accounting estimates are an integral part of the Plan's financial statements prepared by management and are based on Plan management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the Plan's financial statements and because of the possibility that future events affecting them may differ significantly from those expected. There are no significant estimates within the Plan's financial statements.

### ***Qualitative Aspects of Accounting Practices - continued***

Certain financial statement disclosures are particularly sensitive because of their significance to the Plan's financial statement users. The most sensitive disclosures affecting the Plan's financial statements are the disclosure describing the Plan (Note 1), the disclosure for certified investments (Note 3), the disclosure for fair value measurements (Note 4), the disclosure for related party transactions (Note 6), and the disclosure for the tax status of the Plan (Note 8). The Plan's financial statement disclosures are neutral, consistent, and clear.

### ***Form 5500 Procedures***

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit that have not been corrected.

### ***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in dealing with Plan management in performing and completing our audit.

### ***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No such misstatements were noted during our audit.

### ***Reportable Findings***

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable finding:

During our participant testing, we noted that a participant in our sample had wages related to personal use of a company car that were only partially deferred upon and matched. It was noted that the payroll system was set up to not defer on pre-tax contributions related to these wages, but was set up to defer Roth contributions related to these wages. We also noted that this impacts many other participants that have this type of wages. Plan management should work with Voya to determine what corrections are necessary for these participants.

### ***Disagreements with Management***

For purposes of this letter, a disagreement with Plan management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the Plan's financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

### ***Management Consultations with Other Independent Accountants***

In some cases, Plan management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements, or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### ***Other Audit Findings or Issues***

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with Plan management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

We communicated the significant risks of material misstatement identified as part of our audit planning in our engagement letter to you dated April 14, 2025. We did not identify any additional significant risks in performing and completing our audit.

### ***Other Matters***

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Basis for Opinion

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Gosiger 401(k) Savings Plan and Trust** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - On January 1, 1987, Gosiger, Inc. adopted a Section 401(k) profit-sharing plan. Effective January 1, 2013, Gosiger, Inc. was dissolved and restructured to form Gosiger Holdings, Inc. (the "Plan Sponsor"). Subsequent to the dissolution of Gosiger, Inc., the Plan changed its name from Gosiger, Inc. 401(k) Savings Plan and Trust to Gosiger 401(k) Savings Plan and Trust. Gosiger Holdings, Inc. is a parent entity to several operating entities, with all entities collectively recognized as Gosiger Holdings, Inc. and Subsidiaries (the "Company"). The operating entities that are participating employers in the Plan include Gosiger Machine Tools, LLC, Gosiger Automation, LLC, Gosiger High Volume, LLC, and CG Machinery, LLC. The Plan allows all employees of the Company who have attained age 18 to participate, excluding interns, co-op students, and summer or seasonal employees. Upon satisfaction of the eligibility requirements, employees are automatically enrolled at a 3% deferral rate unless they elect otherwise. Participants' deferral rates will automatically increase 1% each year on July 1, up to a maximum of 12%, unless the participants elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth contributions. The Company may make discretionary profit sharing or matching contributions. For the years 2024 and 2023, the Company made discretionary matching contributions of 35% of the first 10% of elective deferrals that a participant contributed to the Plan. The Company made no discretionary profit sharing contributions for the years 2024 and 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Voya Institutional Trust Company (the "Trustee") is the Trustee and Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution, discretionary employer match, and discretionary profit sharing contribution are to be invested.

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, and corresponding earnings. A participant is 100% vested in the Company's profit sharing contributions and corresponding earnings after three continuous years of service. The following schedule will be used to determine vesting in the employer matching contribution and its earnings:

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Notes Receivable from Participants** - Participants may borrow from the Plan in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at an agreed-upon percentage based on prevailing market rates, subject to applicable usury limits. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts and participants may not have more than one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, partial withdrawals of at least \$5,000, substantially equal installments (beginning January 1, 2024), or in a form agreeable to the Plan Administrator. Upon termination, the Plan Administrator may automatically distribute to a participant in a single-sum payment any account balances that do not exceed \$1,000. If the balance does not exceed \$5,000, and the participant does not elect to have the distribution paid directly to an eligible plan, the Plan Administrator may make a lump-sum distribution to a direct rollover individual retirement account. In addition, participants may receive distributions of the employee deferral amount for qualified financial hardships.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions and pay Plan expenses. Forfeitures in the amount of \$39,000 and \$212,598 were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$139,940 and \$41,934.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in any available investment option in increments of one percent. Participants may change their investment options and deferral percentages at any time via telephone or the Internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year. Interest and dividends includes reinvested capital gains and gains and losses on investments sold during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses is deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Plan entered into a Recordkeeping Expense Account (REA) Agreement that allows the Plan to accumulate any excess revenue into this REA and to use the funds to defray the reasonable expenses of administering the Plan. The Company may pay certain administrative expenses of the Plan that are not paid by the REA. The REA is included in Plan assets and is invested in the Voya Fixed Account. The excess revenue is accumulated into the account at the end of each month. All payment requests must be submitted prior to the close of business on March 31 following the end of the year in which the excess revenue was credited to the REA account. The unused balance after submission of the expenses will be allocated to participants on a pro-rata basis. No income was used to pay administrative expenses of the Plan in 2024 and 2023. Income in the amount of \$0 and \$852 was allocated to participants in 2024 and 2023. The balance in the REA was \$4 at December 31, 2024 and 2023.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for specific transactions, such as loans and distribution withdrawals, are paid by the individual participant.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 27, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company (the Trustee of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Money market fund:* Valued based on the valuation formula contained in the contract of the underlying fund; provides a daily mil-rate for income accretion.

*Common collective trust and registered investment companies:* Valued at the daily closing price reported by the fund as registered with the Securities and Exchange Commission. The funds held by the Plan are deemed to be actively traded and are required to publish their NAV and to transact at that price.

#### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a benefit-responsive investment contract with Voya Institutional Trust Company referred to as the Voya Fixed Account. The Trustee maintains the contributions in a general account. The account is credited with earnings of the underlying investments and is charged for participant withdrawals and administrative expenses. The crediting interest rate is based on an agreed-upon formula with the issuer. The interest rate is reviewed on a monthly basis for resetting, but there is a floor in place that is determined in advance.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with the Trustee. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

#### **NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain Plan assets are invested with Voya Institutional Trust Company with record keeping performed by Voya Institutional Plan Services, LLC. Voya Institutional Trust Company, the Trustee of the Plan, is related to Voya Institutional Plan Services, LLC. Thus, Voya Institutional Plan Services, LLC and Voya Institutional Trust Company qualify as parties-in-interest. Fees for these services paid by the Plan for the years 2024 and 2023 totaled \$141,575 and \$103,091.

Morgan Stanley Smith Barney, LLC, as an investment advisor for the Plan, qualifies as a party-in-interest. The fees for these advisory services are direct and indirect fees paid by the Plan. For the year 2024, direct fees paid totaled \$19,500 and indirect fees totaled \$58,500. For the year 2023, direct fees paid totaled \$52,000 and indirect fees paid totaled \$76,483.

The Company provides certain accounting, record keeping, and administrative services to the Plan for which it receives no compensation.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

#### **NOTE 8 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS**

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.
