Notes to Financial Statements

Note 1: Description of Plan

The following description of Bayland Buildings, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Bayland Buildings, Inc. (the "Company"). Employees are eligible to participate in the Plan and receive discretionary matching contributions upon attaining age 21 and completing one year of service, as defined by the plan document. Effective January 1, 2024, under the SECURE 2.0 Act, long-term part-time employees who attained age 21 and worked at least 500 hours in the previous three consecutive years are also eligible to participate in the Plan. Employees enter the Plan on January 1, or July 1, following their fulfillment of the eligibility requirements. To receive any discretionary profit sharing contributions, eligible participants must be employed on the last day of the Plan year and have worked 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Each year, participants may contribute to the Plan up to 100% of eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. All participants deferring less than 10% are subject to a 1% annual increase in their deferral rate, up to a maximum of 10% of eligible compensation, unless they affirmatively elect to defer less than 10%.

The Company may make discretionary matching and profit sharing contributions. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 30% of the first 6% of eligible compensation that a participant contributes to the Plan. Rollover contributions are not matched. The Company did not make any discretionary profit sharing contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contribution, and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms may not exceed five years, unless the note is for the purchase of a primary residence, in which case terms may not exceed 10 years. A participant may only have two notes outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which were equal to the prime rate plus 1.00% as of the date of issuance of the note. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service or upon death or disability, as defined in the plan document.

Payment of Benefits

Plan benefits are available at normal retirement age (age 62), disability, death, and termination of employment with vested interests. In addition, hardship distributions out of the participant's voluntary contributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants who are required to receive required minimum distributions may elect to receive benefit payments in the form of installments or a lump-sum distribution. All other benefit payments are made in the form of a lump-sum distribution. Participant account balances are also distributable to the participant upon termination of employment if the balance is less than \$7,000. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. The Plan had unallocated forfeitures from nonvested accounts of \$9,892 at December 31, 2024, and \$6,703 at December 31, 2023. The Company may decide at its discretion how to use forfeitures under the plan document. During 2024, no forfeited accounts were used to pay plan expenses or to reduce Company discretionary matching contributions.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments on the basis of the terms of the plan document.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses for maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses.

Fees incurred by the Plan for custodial services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 29, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or 3 inputs for the periods presented.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds and common/collective trust fund held in pooled separate accounts: Fair value is estimated using the net asset value ("NAV") per unit by the issuer of the pooled separate accounts. Fair value is based on their fair value of underlying investments held by the pooled separate accounts.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company ("John Hancock"), the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by John Hancock. John Hancock is the Custodian, as defined by the plan document; therefore, transactions with John Hancock qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Fees paid to John Hancock for administrative expenses were \$76,684 for 2024. Certain fees incurred by the Plan for investment management fees and other services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

The Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and profit sharing contributions.

Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Reclassification

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 classifications.

The 2023 financial statements have been reclassified to conform to the 2024 presentation by classifying common/collective trust fund held in a pooled separate account to level 2 instead of NAV.
