NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Gray Metal Products, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan established to provide retirement benefits for the employees of Gray Metal Products, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor and the administrator of the Plan. Paychex, Inc. (Paychex) is the Plan's third-party administrator and provides recordkeeping and administrative services to the Plan. Mid Atlantic Trust Company (Mid Atlantic) is the custodian and trustee of the Plan.

Eligibility

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan after attainment of age 21.

Contributions

Participants may contribute any amount of their pre-tax compensation to the Plan, subject to a 1% minimum and 92% maximum, on a pretax or Roth after tax basis, limited to the maximum annual limitations by the Internal Revenue Code (IRC). Participants may also make rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes matching contributions on behalf of the Plan's participants. The Company matches 25% of employee contributions up to a maximum of 5% of their eligible compensation.

The Plan also has provisions, whereby the Company, at its discretion, has the option to make discretionary profit-sharing contributions to the accounts of all eligible participants. Such allocations are made in proportion to the eligible participants' earnings compared to all of the eligible earnings of the other employees who also share in the contribution. The Company made no discretionary profit-sharing contributions in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) actual earnings/losses thereon, and (c) forfeitures of non-vested balances from participant distributions. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon and any rollover contributions.

1. DESCRIPTION OF PLAN (Continued)

Vesting (Continued)

Company matching and discretionary profit-sharing contributions plus earnings thereon become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

Forfeitures

Forfeitures of non-vested accounts are used to offset any administrative expenses of the Plan, reduce Company matching contributions, or are reallocated to participants' individual accounts as discretionary profit-sharing contributions. During 2024 and 2023, forfeitures of non-vested accounts and earnings on unused amounts totaled \$3,352 and \$2,662, respectively. Forfeitures totaling \$3,419 and \$2,595 were used to reduce employer contributions or to offset administrative expenses during 2024 and 2023, respectively.

At December 31, 2024, there were no forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions. Forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions totaled \$67 at December 31, 2023.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum amount of an outstanding loan cannot exceed the lesser of 95% of one-half of the participant's vested account balance or 95% of the total vested account balance excluding the participant's Roth balance. Notes receivable are payable over a period not to exceed 4.5 years, except when used to acquire a principal residence. The notes receivable are secured by the remaining vested account balance and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through weekly payroll deductions over the term of the loan.

Benefit Payments

Upon termination of service due to death, disability, or retirement, participants receive a distribution of their vested account balances. Participants can elect a lump sum payment, partial payment or installment payments. Participants may also elect an in-service distribution upon attaining age 59 ½. Participants whose vested account balance is \$5,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

Hardship Withdrawals

Hardship withdrawals are permitted from the Plan from the participant's pre-tax elective deferral account.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

Administrative Expenses

The Plan's administrative and investment advisor expenses are paid by both the Plan and the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on quoted market prices in active markets.

Common collective trusts: Valued at net asset value per share as a practical expedient based on the underlying assets of the trusts' investments. The Plan is invested in a common collective trust that calculates net asset value on a daily basis. Units are issued and redeemed as of the end of each day at the daily net asset value. The trust's primary investment objectives are to seek income while preserving principal and provide daily liquidity at contract value for participant withdrawals and transfers.

Redemptions are generally restricted to processing on a valuation date at the daily net asset value per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trusts. The funds do not have any unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by Paychex Inc. The pre-approved plan received an IRS Opinion Letter dated August 31, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION TO FORM 5500

While net assets available for benefits and change in net assets available for benefits agree between the financial statements and Form 5500 in total as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Gray Metal Products, Inc. 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Gray Metal Products, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan established to provide retirement benefits for the employees of Gray Metal Products, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor and the administrator of the Plan. Paychex, Inc. (Paychex) is the Plan's third-party administrator and provides recordkeeping and administrative services to the Plan. Mid Atlantic Trust Company (Mid Atlantic) is the custodian and trustee of the Plan.

Eligibility

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan after attainment of age 21.

Contributions

Participants may contribute any amount of their pre-tax compensation to the Plan, subject to a 1% minimum and 92% maximum, on a pretax or Roth after tax basis, limited to the maximum annual limitations by the Internal Revenue Code (IRC). Participants may also make rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes matching contributions on behalf of the Plan's participants. The Company matches 25% of employee contributions up to a maximum of 5% of their eligible compensation.

The Plan also has provisions, whereby the Company, at its discretion, has the option to make discretionary profit-sharing contributions to the accounts of all eligible participants. Such allocations are made in proportion to the eligible participants' earnings compared to all of the eligible earnings of the other employees who also share in the contribution. The Company made no discretionary profit-sharing contributions in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) actual earnings/losses thereon, and (c) forfeitures of non-vested balances from participant distributions. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon and any rollover contributions.

1. DESCRIPTION OF PLAN (Continued)

Vesting (Continued)

Company matching and discretionary profit-sharing contributions plus earnings thereon become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

Forfeitures

Forfeitures of non-vested accounts are used to offset any administrative expenses of the Plan, reduce Company matching contributions, or are reallocated to participants' individual accounts as discretionary profit-sharing contributions. During 2024 and 2023, forfeitures of non-vested accounts and earnings on unused amounts totaled \$3,352 and \$2,662, respectively. Forfeitures totaling \$3,419 and \$2,595 were used to reduce employer contributions or to offset administrative expenses during 2024 and 2023, respectively.

At December 31, 2024, there were no forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions. Forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions totaled \$67 at December 31, 2023.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum amount of an outstanding loan cannot exceed the lesser of 95% of one-half of the participant's vested account balance or 95% of the total vested account balance excluding the participant's Roth balance. Notes receivable are payable over a period not to exceed 4.5 years, except when used to acquire a principal residence. The notes receivable are secured by the remaining vested account balance and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through weekly payroll deductions over the term of the loan.

Benefit Payments

Upon termination of service due to death, disability, or retirement, participants receive a distribution of their vested account balances. Participants can elect a lump sum payment, partial payment or installment payments. Participants may also elect an in-service distribution upon attaining age 59 ½. Participants whose vested account balance is \$5,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

Hardship Withdrawals

Hardship withdrawals are permitted from the Plan from the participant's pre-tax elective deferral account.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

Administrative Expenses

The Plan's administrative and investment advisor expenses are paid by both the Plan and the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on quoted market prices in active markets.

Common collective trusts: Valued at net asset value per share as a practical expedient based on the underlying assets of the trusts' investments. The Plan is invested in a common collective trust that calculates net asset value on a daily basis. Units are issued and redeemed as of the end of each day at the daily net asset value. The trust's primary investment objectives are to seek income while preserving principal and provide daily liquidity at contract value for participant withdrawals and transfers.

Redemptions are generally restricted to processing on a valuation date at the daily net asset value per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trusts. The funds do not have any unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by Paychex Inc. The pre-approved plan received an IRS Opinion Letter dated August 31, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION TO FORM 5500

While net assets available for benefits and change in net assets available for benefits agree between the financial statements and Form 5500 in total as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.
