Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of Gust Rosenfeld P.L.C. Retirement Plan (the Plan) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1980, and is a defined contribution Plan covering all employees of Gust Rosenfeld P.L.C. (Company or Plan Sponsor) except for independent contractors, leased, and temporary employees. Effective January 1, 2024, the Plan was amended to add Benhuff, LLC; J-Mac AZ Consulting, PLLC; and Joseph D. Williams, P.L.C. as participating employers. Employees are eligible to participate in the Plan on the first of the month following or coinciding with attainment of 21 years of age and completion of one year of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan has been amended and restated throughout the years to comply with tax legislation and most recently restated effective January 1, 2022. The Company's Executive Committee and 401(k) Administration Committee are responsible for the oversight of the Plan. The 401(k) Administration Committee evaluates the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Executive Committee.

Contributions

Participants may elect to contribute up to the 402(g) limit under the Internal Revenue Code (IRC) in effect for the Plan year. The participant may designate a portion of their elective deferrals contribution as a Roth elective deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions from other qualified plans are permitted.

The Company makes a discretionary matching contribution equal to 50% of the portion of the participant's elective deferrals which do not exceed the IRC 402(g) limit divided by the IRC 401(a)(17) limit in effect for the Plan year of the match as a percentage of the participant's compensation, plus 50% of a participant's catch-up contribution. The Company made \$339,757 and \$303,053 of matching contributions for Plan years 2024 and 2023, respectively.

The Company profit sharing contributions are discretionary and participants must be credited with 1,000 hours of service during the Plan year and be actively employed at year-end to receive the contribution. The profit sharing contribution may be between 3% of the participant's eligible compensation to a maximum of 9% of the participant's eligible compensation. The Plan specifies the grouping method for allocation of any profit sharing contribution, and each eligible participant constitutes a separate allocation group. The profit sharing contribution is allocated to each group in a nondiscriminatory manner. The Company made \$457,213 and \$453,154 of discretionary profit sharing contributions for Plan years 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching and profit sharing contributions and an allocation of the Plan's earnings (losses). Allocations are based on participant earnings, account balances, or participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, the Company matching contribution and profit sharing contribution plus actual earnings (losses) thereon.

Benefit Payments

Distribution of benefits is made in the form of a lump-sum payment. Required minimum distribution payments are made for participants subject to required minimum distribution rules. The Plan permits total distribution of a participant's account balance in the event of death, disability, termination, or retirement. Active employees may request an in-service distribution upon attaining age 59½. If a terminated participant's vested account balance does not exceed \$7,000, the Plan will cash out the benefit unless the participant elects to have the distribution paid as a direct rollover. Terminated participants with vested balances between \$1,000 and \$7,000, who have not elected otherwise, will have their balance automatically rolled over to an individual retirement account designated by the Plan administrator. Any balance over \$7,000 will not be distributed without the terminated participant's consent.

Hardship Withdrawals

The Plan allows participants to obtain a hardship withdrawal from the participant's pre-tax and Roth elective deferral accounts and rollover account if the participant demonstrates a substantial hardship as defined by the Plan document.

Notes Receivable from Participants

The Plan does not allow notes receivable from participants.

Investment Funds

Participant and Employer contributions are applied at the participant's direction to various investment options offered by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Excess Contributions Payable

Excess contributions payable represent amounts received from participants that exceed the allowable contribution limits as defined by applicable regulations. These excess amounts are recognized as a liability until they are either refunded to the participant or reallocated in accordance with participant instructions and regulatory guidelines.

Subsequent Events

The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan. The trustee has certified that the data included in the accompanying financial statements and supplemental schedule is complete and accurate.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the prototype Plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of Vanguard Fiduciary Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Additionally, CBIZ RPS provided services to the Plan during 2023 and was considered a party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
