Note 1 - Plan Description

The following description of Edw. C. Levy Co. Capital Accumulation Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan operates for the exclusive benefit of the salaried and nonbargaining unit employees of the Edw. C. Levy group of companies (collectively, the "Plan Sponsor"). The Plan is a defined contribution and voluntary tax savings plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor implemented the original plan effective March 1, 1984. The Plan was most recently restated effective May 25, 2022. The restatement did not impact the provisions of the Plan discussed below.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum dollar amount of annual compensation, as limited by the Plan and subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan requires a minimum employer contribution of 3 percent of each participant's creditable compensation.

The Plan allows for a discretionary employer contribution, which is allocated to participants' accounts based on a pro rata share of eligible compensation. In 2024 and 2023, the Plan Sponsor elected to make a discretionary nonmatching contribution to the Plan of \$1,168,537 and \$1,024,002, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participation and Vesting

All salaried and nonbargaining unit employees who have completed three consecutive months of service are eligible to participate in the Plan. Participants are immediately 100 percent vested in employee and employer contributions, including rollovers of funds from other qualified plans.

Benefit Payments

Upon termination of service, a participant may elect to receive, in a lump sum or in various installment payments, an amount equal to the value of his or her account. Distributions are payable upon death, disability, hardship, attainment of age 59½, or termination of employment. Distributions for attainment of age 59½ are limited to once per plan year.

Termination

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, the assets shall be distributed to the participants in accordance with the participants' accounts maintained by Fidelity Management Trust Company (the "Trustee") in accordance with the plan agreement.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the IRC. Notes receivable must be adequately secured, bear a reasonable rate of interest, and have a repayment schedule, as defined in the plan agreement. Participant notes receivable are written off when deemed uncollectible.

Party-in-interest Transactions

Certain plan expenses were paid by the Plan Sponsor on behalf of the Plan. In addition, certain plan assets are in investment funds managed by the Trustee and its affiliates. These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 7 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Transfers

Certain participants may change from salary employees to union employees during the plan year, resulting in transfers between the Plan and the Edw. C. Levy Co. 401(k) Plan for Bargaining Unit Employees (the "BU Plan"), another defined contribution plan offered by the Plan Sponsor. Transfers are shown on a net basis on the statement of changes in net assets available for benefits. Total net assets transferred into the Plan and out of the BU Plan for the plan years ended December 31, 2024 and 2023 were \$343,551 and \$46,862, respectively.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Certified Information

The Trustee holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 7 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 7 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
