NOTE 1 – DESCRIPTION OF PLAN

The following description provides only general information on the provisions of the Kay Manufacturing Company, LLC 401(k) Profit Sharing Plan (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established by Kay Manufacturing Company, LLC (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility and Participation: All non-union employees who have completed at least 90 days of service and have attained the age of 21, as defined in the Plan, are eligible to participate in employee contributions and employer matching contributions.

Contributions: Participants may elect to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Upon meeting eligibility requirements, employees are automatically enrolled at a 5% deferral rate. The employee may change, stop or resume deferring at any time.

The Company makes non-discretionary matching contributions to eligible participants on 100% of employee contributions, up to a maximum of 3% of eligible wages and 50% of employee contributions on the next 2% of eligible wages, in accordance with the Internal Revenue Service (IRS) safe harbor regulations. For the year ended December 31, 2024, the Company made safe harbor employer matching contributions to eligible participants of \$217,339. The Company may also make elective discretionary contributions. During the year ended December 31, 2024, no discretionary elective contributions were made.

Participant Accounts: Individual accounts are maintained for each participant to reflect the participant’s contributions and related employer matching contributions, as well as the participant’s share of the Plan’s income (loss) and any related administrative expenses. Allocations are based on the participant’s eligible compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately fully vested in their contributions and non-discretionary, safe harbor, employer matching contributions plus earnings thereon. Employer elective discretionary contributions plus earnings will be vested in accordance with the following schedule:

Vesting under the Plan is based upon the ‘hours of service’ method. The participant will receive a year of service upon completion of 1,000 hours of service during the Plan year.

Retirement, Death, and Disability: A participant (beneficiary) is entitled to 100% of his or her account balance upon retirement, death, or total disability.

Participant Hardship Withdrawals: Participants may withdraw from the Plan that portion of their account resulting from salary deferrals in the event of undue financial hardship. The maximum hardship withdrawal is the total of a participant's elected deferral, rollover, and transfer accounts.

Forfeitures: The Plan did not have forfeitures at December 31, 2024 and 2023. Forfeited amounts are used to offset future Company contributions or to reduce the Plan's administrative expenses. In 2024, no forfeitures were used to offset Company contributions.

Payment of Benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Participants in service may make hardship withdrawals from their vested contributions upon demonstration of immediate and heavy financial need. Participants in service may also make in service withdrawals upon reaching normal retirement age. The form of payment is a lump-sum distribution or substantially equal periodic installments over a period of time selected by the participant not to exceed the participant's life expectancy.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary contributions and earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans in the form of notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid through payroll deductions.

Investment Options: Upon enrollment in the Plan, a participant may direct employer and employee contributions to any of the applicable investment options available under the Plan.

During the 2024 plan year, the Plan implemented a comprehensive change to its investment platform. The Plan's existing investment options were replaced with a newly selected lineup of funds to improve investment performance, reduce fees, and enhance alignment with participant needs. The transition included the closure of all prior investment options to new contributions and the addition of a diversified range of mutual funds, collective investment trusts and a fully benefit-responsive group annuity contract. Both existing participant account balances and future investment elections were mapped to the new investment options based on comparable risk and return characteristics.

Administrative and Investment Management Expenses: Certain administrative expenses and transaction fees are paid for by the Plan and are reflected in the financial statements as administrative expenses of the Plan. All fees and expenses paid for by the Plan are allocated proportionally against all participant accounts, unless allocable to the accounts of particular participants. Certain other administrative fees are paid by the Company.

Subsequent Events: Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosure within the financial statements for the year ended December 31, 2024. Management has performed their analysis through September 2, 2025, which was the date that the financial statements were available to be issued and has determined the following subsequent event to disclose.

Effective January 1, 2025, the Sigma Machine 401(k) Retirement Plan and the Empire Die Casting Company 401(k) Profit Sharing Plan were merged into the Plan as part of a corporate restructuring and integration initiative, resulting in the transfer of approximately \$5,460,000 million (unaudited) in net assets. As a result of this merger, eligible employees of Sigma Machine Holdings LLC and Empire Die Casting Co., Inc. became participants in the Kay Manufacturing Company, LLC 401(k) Profit Sharing Plan, subject to the same terms and provisions of the Plan unless otherwise specified in applicable transition agreements or addenda. Their eligibility, vesting, and other relevant service with Sigma Machine Holdings LLC and Empire Die Casting Co., Inc. will be credited as service with Kay Manufacturing Company, LLC, to the extent permitted under the Plan and applicable law.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Investment Valuation and Income Recognition: The Plan's investments, except for the fully benefit responsive contract disclosed in Note 5, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive group annuity contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefit payments to participants are recorded when paid.

Estimates: The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. The underlying investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents of the valuation methods and assumptions used by the Plan to estimate the fair values of investments period.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values ("NAV") reported by the fund managers as of the financial statement dates and recent transaction prices. The pooled separate accounts invest mainly in domestic stock, with the majority of the underlying securities valued using quoted prices on nationally recognized securities exchanges. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's NAV per unit. The plan no longer offers pooled separate accounts as investment options as of November 1, 2024.

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive group annuity contract with Principal Life Insurance Company (the “Issuer”) that is reported at contract value, which is the relevant measure for fully benefit-responsive investment contracts. The contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Although the group annuity contract was originally issued by the Issuer on March 1, 2019, the Plan did not acquire an interest in the contract until September 25, 2024, when the interest was formally executed through a Joinder Agreement by Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company, acting solely in its capacity as contract holder. The contract became available to Plan participants only upon the effective date of this Joinder.

Under the terms of the contract, Principal maintains the Plan's interest in its general account, and guarantees principal and a minimum interest rate, as described in the contract's provisions. Interest is credited using a composite crediting rate, declared periodically by the Issuer, and is guaranteed not to be less than the contractually stated minimum rate. These crediting rates are based on the performance of the underlying general account investments and are reduced for administrative fees.

Participants may generally direct the withdrawal or transfer of their investments at contract value. Benefit payments and transfers are processed in accordance with the Plan and contract terms. The group annuity contract includes certain limitations that may apply to Plan-level withdrawals, early terminations, or changes to Plan structure. These include possible installment payout schedules, early termination charges, and restrictions tied to changes in Plan fiduciary, recordkeeper, or qualification status. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Transactions with parties-in-interest during the plan year are included in investment management and administrative services. Certain administrative functions were performed by employees or officers of the Plan Sponsor. No such officer or employee receives compensation from the Plan for these services. Investment management fees are paid by the Plan to investment managers that qualify as parties-in-interest, including Principal Life Insurance Company, Principal Global Investors Trust Company, Global Retirement Partners, LLC, Creative Planning, Inc., and Wellth Advisory Services, LLC. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan's investments. The majority of administrative fees of the Plan are paid for by the Company. The Plan holds a stable value fund and a group annuity contract, managed by Principal Global Investors Trust Company and Principal Life Insurance Company, respectively. Both of these are affiliates of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the current Plan trustee, and similarly qualify as parties in interest. Notes receivable from participants also qualify as party in interest transactions.

NOTE 7 – TAX STATUS

The IRS issued an opinion letter dated June 30, 2020 indicating that the volume submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

US GAAP require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.
