Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TMCO, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. A. Description of Plan

The following description of the TMCO, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering substantially all employees other than union and non-resident alien employees of TMCO, Inc. (Employer) who have six months of service and are age 21 or older. The Plan is subject to the provisions of ERISA. The Board of Directors of the Employer is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Contributions.* Each year, participants may contribute pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, with an automatic increase of 1% per year up to 10%. The automatically enrolled participants have their contributions invested in a designated balanced fund until changed by the participant.

The Employer may contribute a discretionary matching contribution, which for the year ended December 31, 2024, was 100% of the first 10% of compensation, as defined in the Plan agreement, that a participant contributed to the Plan. An additional non-elective contribution may be contributed at the option of the Employer's board of directors. During the year ended December 31, 2024, the Employer did not make any non-elective contributions to the Plan. Once a participant becomes eligible for matching and non-elective contributions, they will share in the allocation regardless of the amount of service if employed on the last day of the Plan year. If a participant terminates employment prior to the last day of the Plan year, they must be credited with at least 501 hours of service during the Plan year to share in the allocation. Contributions are subject to certain IRS limitations.

3. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. *Vesting.* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. Separate provisions apply in the event of retirement, death, or disability.
5. *Payment of benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive 1) a single lump sum payment in cash, 2) installments over a period of not more than the assumed life expectancy (or the assumed life expectancies of the beneficiaries), or 3) ad-hoc distributions. The distribution amount will be equal to the value of the participant's vested interest in his or her account. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. The Plan may make a mandatory distribution if the participant account is \$5,000 or less. If the participant does not provide payment instructions, the Plan will automatically roll the distribution over to an IRA if the participant's account balance is over \$1,000.
6. *Forfeited accounts.* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,812 and \$27,338, respectively. These accounts may be used to pay Plan expenses, allocated as an additional discretionary nonelective or matching contribution, or used to reduce future Employer contributions. During the year ended December 31, 2024, the Employer used \$11,370 of forfeitures to pay Plan expenses.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.

5. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to withdrawals are included with benefits paid to participants in the statement of changes in net assets available for benefits. Fees related to the administration of participant transactions, payment of Plan audit fees, and administration of the Plan are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.
6. *Subsequent events.* The Plan has evaluated subsequent events through August 7, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan adopted super catch-up provisions under SECURE 2.0. Also effective January 1, 2025, the Plan amended eligibility requirements for Employer discretionary matching and non-elective contributions to require employment on the last day of the Plan year and completion of 1,000 service hours during the Plan year.

C. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Union Bank & Trust Company, the trustee, has certified the following as complete and accurate:

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trust: Valued at the NAV of units held by the Plan at year-end. NAV is calculated using the fair value of the underlying investments and is available to participants.

E. Party in Interest Transactions

Certain Plan investments are managed by the Plan trustee, therefore, these transactions qualify as party-in-interest transactions. Payments made to parties-in-interest during the year ended December 31, 2024 consisted of recordkeeping, Plan administration, and audit fees.

F. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

G. Tax Status

The Plan has adopted a non-standardized defined contribution pre-approved plan that has received an opinion letter dated June 30, 2020, in which the IRS stated that the non-standardized plan was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
