## NOTES TO FINANCIAL STATEMENTS

### 1. **DESCRIPTION OF PLAN**

The following description of the MJW Consolidated, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

Milton J. Wood Company (the "Plan Sponsor") established the MJW Consolidated, Inc. 401(k) Plan (the "Plan") on September 1, 1972. The Plan is a defined contribution plan (401(k)) covering all full-time employees who are not considered to be a leased employee, represented by a bargaining unit, and have completed six months of service. There is no minimum age requirement. The Plan is intended to comply with Section 404(c) of ERISA (The Employee Retirement Income Security Act of 1974). The trustee of the Plan is the Principal Financial Group (the "Trustee").

#### **Contributions**

Each year participants may contribute a percentage of their compensation not to exceed a certain dollar limit which is set by law. Every qualified employee is auto enrolled at a 3% contribution rate and must log into the Plan's website to modify the contribution rate to 0% if they want to opt out of the plan. Each participant can modify their contribution rate anytime during the year. The Plan Sponsor may make a discretionary matching contribution equal to a percentage of the amount of the employee's deferral contribution. For 2024 and 2023, the Plan Sponsor's matching contributions were \$-0-. Participants direct the investment of contributions made by them on their behalf to the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution (if any) and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

NOTES TO FINANCIAL STATEMENTS

1. **DESCRIPTION OF PLAN** – (Continued)

**Vesting** – (Continued)

Based on the six-year graded provision of the Plan, which complies with a change in the retirement law effective for plan years beginning after December 31, 2001, a year of vesting service is a vesting service period in which the participant has at least 1,000 hours of service. A service period is a one-year period ending December 31. An hour of service is each hour of paid working time. In addition, it includes up to 501 hours during any one period of paid non-working time, such as paid vacation. However, a participant is 100% vested upon early or normal retirement age, becoming totally disabled or death. The vesting schedule is as follows:

**Distributions**

On termination of service due to death, disability, or retirement, participants are entitled to 100% of his/her account balance. If the vested account balance is \$5,000 or less and the participant is less than 65 years old, the vested account will be automatically rolled into an IRA. If the participant has reached age 65 and the vested balance is less than \$5,000, the vested account will be paid in a single sum. If the vested account is more than \$5,000, the participant may choose to have the vested account paid under any of the distribution options available under the plan.

**Hardship Distributions**

Participants who have incurred certain hardship conditions as specified by provisions of the Internal Revenue Code may elect to receive a distribution from his/her elective contribution account.

**Forfeited Accounts**

Forfeitures may first be used to pay plan expenses. Any forfeitures remaining after paying plan expenses are reallocated. Forfeitures from other participants may increase remaining participant accounts. Forfeited amounts from non-vested accounts for the years ended December 31, 2024 and 2023 was \$-0-.

NOTES TO FINANCIAL STATEMENTS

1. **DESCRIPTION OF PLAN** – (Continued)

**Expenses and Fees**

Expenses and fees associated with the Plan are paid with Plan assets. Such expenses and fees include the compensation of investment managers, brokers' fees, and costs related to Plan administration. During the years ended December 31, 2024 and 2023, expenses and fees were \$39,746 and \$37,982, respectively. Fees associated with the audit for the Plan were paid by the Plan Sponsor and are not included in expenses in these financial statements.

**Participant Loans**

Participants may not borrow from their accounts.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan uses the accrual method of accounting. Under this method of accounting, contributions to the Plan are recognized when approved by the Employer. Revenues are recognized when earned, and expenses are recognized when incurred.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from reported amounts of additions to and deductions from net assets during the reporting period.

**Investment Valuation**

Investments are recorded at the fair market value on the last business day of the Plan year. Quoted market prices are used to value investments. Increases and decreases in market value of the investments are reflected in the statement of changes in net assets available for benefits.

**Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate fluctuations, market changes, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS

**3. PLAN TERMINATION**

The Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100% vested in their account balances from the date of participation to termination.

**4. TAX STATUS**

The Plan has been designed such that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan's trustee, Principal Life Insurance Company, received a determination letter that the plan is acceptable under Section 401 of the IRC. Although the Plan has been amended from time to time, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to taxation within the United States of America. Tax years 2021, 2022, 2023, and 2024 are subject to examination by taxing authorities.

**5. CONCENTRATION OF CREDIT RISK**

Contributions receivable from plan participants as of December 31, 2024 and 2023 were \$7,980 and \$0, respectively.

**6. FAIR VALUE MEASUREMENTS**

Fair value as defined under generally accepted accounting principles ("GAAP") is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value.

These tiers include:

- Level 1: Observable inputs such as quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs other than quoted prices within Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 may also include insignificant adjustments to market observable inputs.
- Level 3: Unobservable inputs used for valuing the asset or liability. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.

6. **FAIR VALUE MEASUREMENTS** – (Continued)

Following is a description of the valuation methodologies used for assets measured at fair values.

There have been no changes in the methodologies used at December 31, 2024.

Collective investment trusts: Valued at fair value based upon net asset value.

Pooled separate accounts: Invests in mutual funds. The fair values of the underlying mutual funds are publicly quoted prices used in determining net asset value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

7. **COLLECTIVE INVESTMENT TRUST**

The Principal Stable Value Fund (“PSVF”) is a collective investment trust for which net asset value is based on the fair value. The PSVF invests primarily in contracts, short-term securities and debt securities. Investments in contracts are presented in the portfolio of investments at contract value, which represents invested principal plus accrued interest thereon. The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contracts are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the Trustee, which determines valuations using methodology generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes.

The net crediting rate is equal to the gross crediting rate minus the wrap fee due the contract issuer and if applicable, the sub-advisor fee for specific investment strategies. Crediting rates reflect the amortization of realized and unrealized gains and losses in the underlying portfolio over the duration of the portfolio and, in consequence, may not reflect the actual returns achieved in the portfolio. From time to time the crediting rate may be significantly greater or less than current market interest rates.

A number of factors can influence future credit rates, which may include, but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in credit ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals, and certain wrap contract terms, including wrap fees.

The weighted average yield to maturity of all underlying investments at year end was 2.84%.

8. **PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of pooled separate accounts managed by The Principal Financial Group and Principal Global Investors Trust. The Principal Financial Group and Principal Global Investors Trust transactions qualify as party-in-interest transactions and have been identified as such within the supplemental information.

Certain plan investments are managed by The Principal Financial Group. It is the trustee/custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTES TO FINANCIAL STATEMENTS

**8. PARTY-IN-INTEREST TRANSACTIONS** – (Continued)

During the years ended December 31, 2024 and 2023, The Principal Financial Group, Principal Life Insurance Company, Gallagher Fiduciary Advisors, LLC, Morningstar Investment Mgmt., LLC, and Wilshire Associates, Inc. received advisory fees and/or administrative fees. Fees paid for these services are included in the plan expense. These transactions also qualify as party-in-interest transactions for which there is a statutory exemption.

**9. CERTIFIED INVESTMENTS**

The plan administrator has elected the methods of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023 including investment information related to the 401(k) account, that is disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee of the Plan.
