Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the INTO North America, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the INTO North America, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan established in 2009 by INTO North America, Inc. (the "Company"), previously INTO USA, LLC, to provide retirement benefits for eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Eligibility

All employees of the Company and any participating affiliates, except those covered by a collective bargaining agreement, are eligible for the Plan. Employees must be at least age 18 and have completed six months of service. Plan entry is the first day of the month following completion of eligibility.

C. Participant Contributions

Participants may elect to defer up to 80% of their eligible compensation in pre-tax or Roth contributions, subject to applicable Code limitations. Participants of age 50 or older may make additional catch-up contributions of up to \$7,500 annually in 2024.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

D. Employer Contributions

The Company made safe-harbor matching contributions, equal to 100% of the first 6% of compensation deferred by participants. The Company may make additional discretionary non-elective contributions, as defined by the Plan. In 2024, the Company did not make a discretionary non-elective contribution.

E. Participant Accounts

Individual accounts are maintained for each Plan participant. Participants direct the investment of their contributions into investment options offered by the Plan. Each participant's account is credited with the participant's contributions, Company safe-harbor matching contributions, rollover contributions, Company discretionary non-elective contributions and an allocation of Plan earnings or losses and expenses.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their accounts attributable to elective deferrals, Company safe-harbor matching contributions, rollover contributions and related earnings. Participants vest at the rate of 25% annually in Company discretionary non-elective contributions

and become fully vested upon completion of four years of service. Forfeitures of terminated participants' non-vested accounts may be used to pay administrative expenses or to reduce Company safe-harbor matching contributions. Forfeitures totaled \$0 in 2024 and \$0 were used to pay administrative expenses during 2024. The balance of unapplied forfeitures was \$5 and \$5 at December 31, 2024 and 2023, respectively.

G. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the participant's account balance. If a terminated participant's account balance is greater than \$1,000 and no distribution election has been received from the participant or beneficiary of the account, the account may be rolled into an individual retirement account at the direction of the plan administrator. If such account does not exceed \$5,000, the balance may be paid in a lump sum distribution. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

H. Notes Receivable from Participants

The Plan allows a participant to borrow not less than \$500 up to the lesser of \$50,000 or 50% of his or her vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate equal to the prime rate plus 2% as determined at loan inception, and must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to 10 years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates of 10.00% to 10.50%.

Notes receivable are measured at their unpaid principal balances plus any accrued unpaid interest. Delinquent notes are recorded as distributions based on the terms of the Plan document.

I. Administrative Expenses

The Company pays most administrative expenses of the Plan. Certain asset charges, account fees and loan fees are paid from participants' accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

C. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 5 - INCOME TAX STATUS

The Company adopted a volume submitter plan that received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize Plan investments at December 31 based on the inputs used to value them:
