## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
**Champions First Credit Union 401(k) Plan and Trust**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Champions First Credit Union 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Emphasis of Matter

As discussed in Note 7 to the financial statements, on July 29, 2024, the Plan Sponsor voted to merge into the Credit Union Retirement Plan Association (CURPA) 401(k) Plan, a multiple employer plan, and subsequently signed the certificate of resolution on November 25, 2024, effective December 31, 2024. The Plan transferred its net assets into the CURPA 401(k) Plan and ceased operations as of that date. Our opinion is not modified with respect to this matter.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### Note 1 – Description of the Plan

#### General

The Champions First Credit Union 401(k) Plan and Trust (the Plan) is a defined contribution plan established on June 1, 1976 by Champions First Credit Union (the Credit Union) and restated effective January 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a more complete description of the Plan's provisions.

On November 25, 2024, the Plan Sponsor signed a certificate of resolution to transfer the Plan into the Credit Union Retirement Plan Association (CURPA) 401(k) Plan, a multiple employer plan (MEP), effective December 31, 2024. See Note 7.

#### Administration

The Plan Sponsor and named Plan Administrator is the Credit Union. The Plan Administrator is responsible for the oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's Trustees are members of the Credit Union's management team. The Plan's Investment Custodian is Matrix Trust Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Plan has also retained CMFG Life Insurance Company (CMFG) to provide participant recordkeeping and administration services. Matrix Trust Company and CMFG are the Plan's certifying entities, see Note 3 for information certified.

#### Eligibility

The Plan covers all employees of the Credit Union. All eligible employees must be 19 years of age and have completed six months of service, with the entry date being the first day of the Plan year quarter after the eligibility requirements are satisfied. Employees with service previously completed with Tree Capital Credit Union, GPCE Credit Union, and Florida Department of Transportation Credit Union (FDOTCU) will be considered in the calculated months of service requirement for purposes of eligibility and vesting in the Plan.

#### Contributions to the Plan

Eligible employees can contribute an amount up to 100% of pre-tax or Roth (after-tax) compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employee contributions are limited by the requirements of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Effective January 1, 2023, the Plan was amended to allow for safe harbor matching contributions, which are subject to a two-year vesting requirement. The Credit Union makes safe harbor matching contributions equal to 100% of each participant's salary deferrals up to 4% of a participant's eligible compensation. For 2024, the Credit Union's safe harbor matching contributions approximated \$155,000. In addition, the Credit Union may make discretionary profit-sharing contributions which are not limited to current or accumulated net profit. The Credit Union provides eligible employees with a discretionary profit-sharing contribution. The Credit Union did not make a discretionary profit-sharing contribution prior to the transfer to the CURPA 401(k) Plan.

Additionally, effective January 1, 2023, the Plan was amended to include an automatic enrollment provision, where participants will be automatically enrolled in the Plan at a set percentage unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation subject to an auto-escalation clause, as defined in the amended Plan document.

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Credit Union's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to certain Department of Labor (DOL) and IRS requirements. The loans are secured by the balance in the participant's account. The loan interest rate is established at a reasonable rate in a nondiscriminatory manner, as defined in the plan document. The loan terms may range from one to five years, except for a loan used to acquire a dwelling as the principal residence of the participant. Principal and interest payments are paid through payroll deductions.

### Distribution of Benefits

On termination of service, participants with vested account balances of \$7,000 (\$5,000 prior to January 1, 2024) or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances exceed \$7,000 (\$5,000 prior to January 1, 2024) may elect a lump sum distribution, substantially equal installments, an annuity, or partial withdrawals, provided the minimum withdrawal is \$500. Additionally, they may also elect to defer the distribution of their Plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability, or retirement. Participants should refer to the full Plan document for details.

The Plan allows for in-service distributions upon the attainment of age 59½ for pre-tax deferral contributions, employer discretionary matching, and discretionary profit-sharing contributions, for any reason, provided the minimum withdrawal is \$1,000, and that the funds are fully vested at the time of distribution. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the Plan document, from vested account balances.

### Vesting

Participants are immediately vested in their contributions, and actual earnings thereon. Vesting in the Credit Union's employer safe harbor matching contributions portion of their account plus actual earnings thereon is based on years of continuous service. A participant vests in safe harbor matching contributions after two years of credit service. Vesting in the Credit Union's employer discretionary profit-sharing contributions portion of their account plus actual earnings thereon is based on years of continuous service.

A participant vests in discretionary contributions in increments of 20% for each year of credited service beginning at the end of the second year, such that a participant is 100% vested after six years of credited service. Participants also become fully vested upon reaching early and normal retirement age, death, or permanent disability.

### Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to offset the Plan's administrative expenses or to reduce the Credit Union's contributions. During the year ended December 31, 2024, forfeitures used to reduce the Credit Union's contributions were approximately \$18,000. There were no forfeited balances as of December 31, 2024. The forfeiture account maintained a \$200 balance as of December 31, 2023.

### **Note 2 – Summary of Significant Accounting Policies**

#### Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's Investment Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are charged to expense when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance of the note receivable from the participant is reclassified to benefits paid to participants.

### Payment of Benefits

Benefits are recorded when paid.

### Fees and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Credit Union. Expenses that are paid by the Credit Union are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Subsequent Events

Effective July 1, 2025, the Plan was transferred from the CURPA 401(k) Plan, to the TruStage Pooled Employer Plan.

### **Note 3 – Unaudited Information Certified by the Certifying Entities**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by the certifying entities as to the completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment and non-interest bearing cash balances reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
2. All investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and
3. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

### **Note 4 – Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies: Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2023, the Plan's investments consisted solely of mutual funds that are measured on a recurring basis using level 1 inputs. There were no investments as of December 31, 2024.

### **Note 5 – Fully Benefit-Responsive Investment Contract**

The Plan invests in a fully benefit-responsive investment contract with CMFG, where the underlying investment is a guaranteed account. Under the terms of this contract, CMFG periodically reestablishes the effective annual interest rates and contract maturity dates. CMFG maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. The Deposit Administration Group Annuity Contract does not permit the insurance company to terminate the agreement under normal circumstances.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 6 – Party-in-Interest Transactions**

Certain Plan investments are managed by the Plan's Investment Custodian. During the year ended December 31, 2024, the Plan paid direct compensation of approximately \$34,000 to CMFG for recordkeeping services rendered, and approximately \$7,000 to Members Capital Advisors, Inc. for advisory services rendered. Indirect compensation (that is netted against investment income in the Statement of Changes in Net Assets Available for Benefits) is paid to the Investment Custodian for total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions which have these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

### **Note 7 – Plan Merger**

On July 29, 2024, the Plan Sponsor voted to merge into the Credit Union Retirement Plan Association (CURPA) 401(k) Plan, and subsequently signed the certificate of resolution on November 25, 2024, to merge the Plan as of December 31, 2024. On December 31, 2024, the Plan's investments were liquidated and a transfer of in-kind investments, investments that were the same in both plans, of approximately \$3,725,000 was processed. The Plan's remaining assets of approximately \$4,547,000 reflect a corresponding payable to multiple employer plan on the Statements of Net Assets Available for Benefits, as they were transferred at end of day December 31, 2024. As a result, the Plan ceased to exist as a standalone qualified retirement plan as of December 31, 2024 and a final Form 5500 was filed.

### **Note 8 – Plan Termination**

The Credit Union has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all participant accounts become 100% vested. As discussed in Note 7, the Credit Union made the decision to merge the Plan into the CURPA 401(k) plan, and therefore the Plan was no longer a standalone qualified retirement plan as of December 31, 2024. In conjunction with the plan merger, all participants' account balances and vesting were unchanged.

### **Note 9 – Plan Amendment and Tax Status**

The Plan is utilizing a non-standardized pre-approved plan, which has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020 from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan document was most recently amended effective January 1, 2023. However, there were no significant changes from the prior Plan document, except for those stated in Note 1.

The Plan permitted provisions of SECURE Act 2.0 during the year ended December 31, 2024 and 2023. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 – Risks and Uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
