We have performed audits of the financial statements of Shick Solutions, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

### ***General***

The following description of Shick Solutions, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Shick Solutions, Inc. and its domestic affiliates (the Company) for the benefit of its employees. Employees who have attained age 18 and met the three-month service requirement are eligible for salary deferral and matching contributions. Participants who have met the one year or 1,000 hours service requirement are eligible for the Company's nonelective employer contributions.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company is the trustee of the Plan and serves as Plan custodian.

Effective January 1, 2025, the Shick Solutions, Inc. 401(k) Plan and Trust was acquired by another entity, which resulted in a change in ownership of the plan sponsor. Plan assets of \$24,250,297 were transferred to Process Equipment Group 401(k) Savings Plan on December 31, 2024.

### ***Contributions***

The Plan permits eligible employees through a pre-tax or Roth salary deferral election to make maximum annual contributions of 96% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes safe-harbor matching employer contributions equal to 100% of the first 1% of eligible compensation and 50% of the next 5% of eligible compensation, up to a maximum of 3.5% of that participant's total compensation.

The Company may make annual discretionary nonelective contributions in an amount determined by the Company. Profit sharing contributions are allocated based on eligible compensation. The Company did not make a nonelective contribution for the years ended December 31, 2024 and 2023.

### ***Participant Investment Account Options***

Investment account options available include various mutual funds and stable value funds. Each participant has the option of directing his/her contributions into any of the separate investment accounts and may change the allocation daily.

The Plan Document also includes an automatic enrollment feature whereby a new participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the employer contributions and plan earnings and is charged with an allocation of administrative expenses. Participants' accounts are valued daily. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their salary deferral and rollover contributions plus earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus earnings thereon is based on completed years of service. The vesting schedule is as follows:

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. Participants may borrow from their fund accounts a minimum of \$500, with the maximum amount being the lesser of 50% of the participant’s vested account balance or \$50,000. The maximum loan term is five years or for a reasonable period of time, which may exceed five years for the purchase of a primary residence. All loans are repayable through payroll withholdings unless the participant is paying the loan in full. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest. Interest on the loans is based on prevailing rates as determined by the Plan Administrator, currently at 2% over the current prime rate, updated monthly for all participant loans.

***Payment of Benefits***

A participant is entitled to a benefit equal to the full value in the participant’s account upon retirement at age 59½, permanent disability or death prior to termination of employment. In the event of resignation or discharge before any of the above events, the benefits will be dependent on the Plan’s vesting schedule. Benefits are payable in a lump sum or in installments, subject to certain provisions as defined by the Plan Document. In the event of death, benefits are payable to the designated beneficiary. Distributions to participants are recognized in the statements of changes in net assets available for benefits when paid to participants. A participant is also entitled to receive a lump-sum distribution of his or her pretax employee contributions after attaining age 59½ without terminating employment.

The Plan permits hardship withdrawals. To qualify for a hardship withdrawal, the participant must demonstrate immediate and heavy financial needs, as defined in the Plan Document, subject to a minimum of \$500.

***Forfeitures***

Forfeited nonvested accounts are retained in the Plan and are used to reduce Company contributions. During the years ended December 31, 2024 and 2023, forfeited amounts totaled \$0 and \$19, respectively. Employer contributions were reduced by \$18,836 and \$40,458 from amounts forfeited by nonvested accounts for the years ended December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are maintained on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value and are held in an account with Fidelity Management Trust Company, the trustee of the Plan. On each valuation date, as defined by the Plan, securities held, plus or minus any net income or loss of the Plan, is allocated to participant accounts. Fair value of the mutual funds is determined based principally on quoted market prices of the funds.

The Plan's interest in the stable value funds are valued based on information reported by the investment advisor using the audited financial statements of the stable value funds at year-end.

Net appreciation in the fair value of investments consists of both realized and unrealized appreciation on assets held by the Plan. Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest is accrued as earned, and dividend income is recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **Note 3. Certification of Plan Trustee**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries of the Plan, individuals who provide services to the Plan, and the Company, as the employer whose employees are covered by the Plan.

Certain plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

The Plan paid \$81,399 and \$67,773 of fees to Fidelity Management Trust Company during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contributions. Upon termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary or, if none, his or her legal representative at the time prescribed by the Plan terms and the applicable provisions of ERISA.

### **Note 7. Plan Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a volume submitter defined contribution plan and trust/custodial document sponsored by Fidelity Management & Research Co. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9. Subsequent Events**

Subsequent events have been evaluated through July 9, 2025, which is the date the financial statements were available to be issued.
