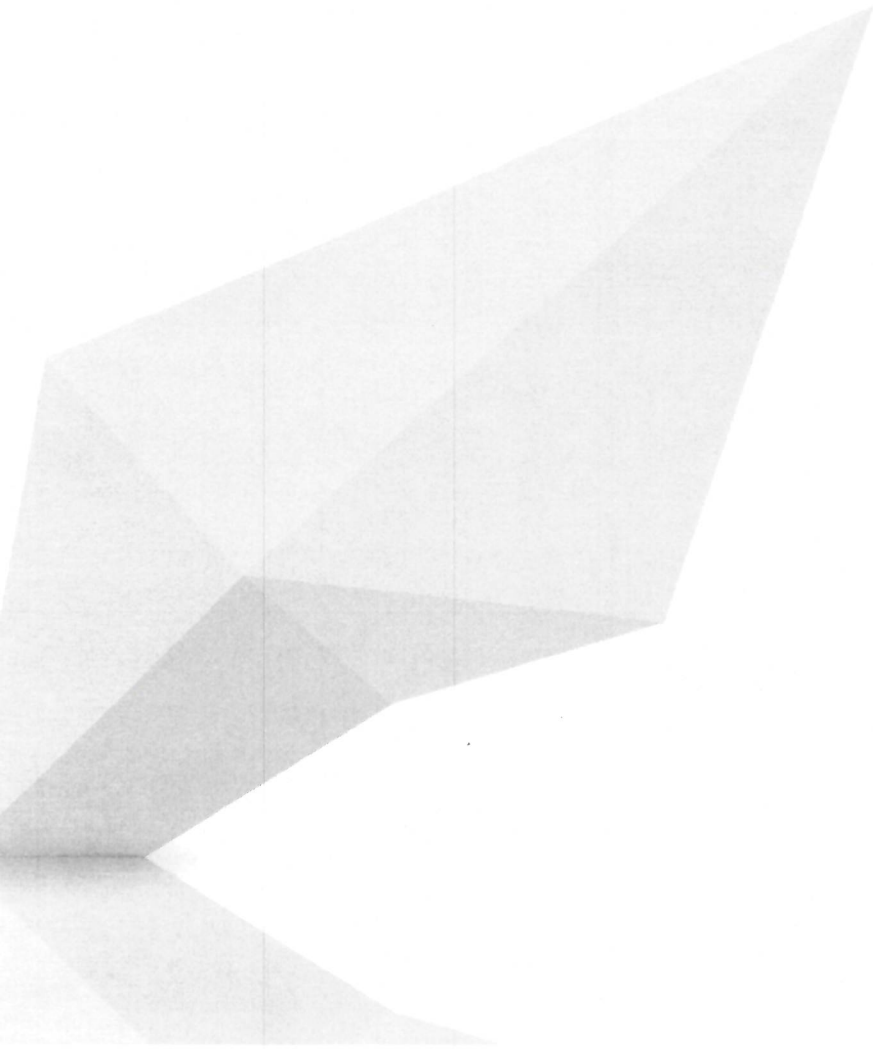

### Note 1: Description of Plan

The following description of the Capstone Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

Capstone Management, LLC 401(k) Plan (the Plan) is a defined contribution plan that has adopted the provisions of the Ascensus, Inc. Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Substantially all employees of Capstone Management, LLC, OnPoint Systems, LLC, Envision Technology, LLC, Rochester Precision Optics, LLC and Capstone Residential Services, LLC (collectively, the "Employer") are participants in the Plan, and all participants have a shared interest in the net assets of the Plan. Certain employees of the employer serve as limited trustees of the Plan.

The Plan covers all eligible employees, as defined, who have completed the applicable age and service requirements. The eligibility requirements for elective deferrals and safe harbor matching contributions are completion of 2 months of service and attainment of age 21. The eligibility requirements to receive discretionary employer matching and employer profit-sharing contributions are completion of one year of service and attainment of age 21. In addition, subject to certain exceptions, you must be employed on the last day of the Plan year to be eligible for profit-sharing contributions.

#### Contributions

Participating employees are allowed to make salary savings contributions as a percentage of their eligible compensation, as defined by the Plan, up to the maximum deferral amount allowed by law. Effective July 1, 2023, the Plan was amended to allow Roth deferrals and in-Plan Roth rollovers. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The employer will make safe harbor matching contributions of 100% of elective deferrals up to 4% of each eligible participant's compensation. In addition, the employer may make discretionary matching and profit-sharing contributions in such amounts as determined by the employer to be appropriate. Any discretionary contributions are allocated to participants in accordance with the Plan document. During the years ended December 31, 2024 and 2023, the Employer made safe harbor matching contributions of \$1,062,810 and \$855,801, respectively. The Employer did not make any discretionary matching or profit sharing contributions during the years ended December 31, 2024 and 2023.

#### Participant Accounts

Separate accounts are maintained for each participant and each participant's account is credited with the participant's contributions and employer matching contributions and allocations of employer profit-sharing contributions, if applicable, and Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Employer safe harbor matching contributions and the portion of the participant's account attributable to their voluntary contributions are immediately vested. Discretionary matching and profit-sharing contributions vest at 20% after two years of service with vesting increasing 20% per year until participants have a 100% vested interest in their share of the net assets. In addition, the participant shall be fully vested upon death, disability, or normal retirement age, as defined. Any amount of a participant's account which is not fully vested is forfeited upon termination and is used to reduce Employer contributions or to pay the Plan's administrative expenses. The Plan had no significant unapplied forfeitures at December 31, 2024 and 2023.

#### Benefits

Benefits may be distributed upon termination of employment, retirement, death or permanent disability. Distributions may be made in one lump-sum payment or in a series of partial payments as defined in the Plan document. A participant may also request a withdrawal, subject to limitations, upon attainment of age 65, or upon demonstration to the Plan Administrator that the participant is suffering from a hardship, as defined in applicable Internal Revenue Service regulations or standards established by the Secretary of the Treasury or his delegate, and meet the criteria specified in the Plan.

#### Investment Options

Plan participants may select their investments from various investment options made available under the Plan. The investment decisions for a participant's account are the sole responsibility of the Plan participant and they may change their investment options at any time throughout the year. Plan contributions are invested based upon these selected options.

#### Notes Receivable from Participants

Plan participants are allowed to borrow up to the lesser of \$50,000 or one-half of the vested value of the participant's account with a minimum loan amount of \$1,000. Loans must be repaid within five years, unless the loan is used to acquire a dwelling to be used as the principal residence of the participant, in which case the loans may be paid over thirty years. Loans are repaid in level payments, primarily on a weekly basis, in amounts sufficient to fully amortize the loan within the repayment period. Loans issued bear interest based upon the Wall Street Journal prime rate plus 1% at the time of borrowing. Interest rates ranged from 4.25% to 9.50% on loans outstanding as of December 31, 2024 and 2023. Participants are allowed to refinance their notes payable to the Plan one time over the life of the loan.

#### Plan Termination

While the Employer has not expressed any intent to terminate the Plan, it may do so at any time. In the event of termination of the Plan, all participants shall become 100% vested in discretionary employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Accounting Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Certain Plan assets are measured at net asset value (NAV), which is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the funds would sell the investments for an amount different from the reported net asset value. See Note 4 for a discussion of fair value.

Purchases and sales of investments are reported on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan document.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 26, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company, the Trustee of the Plan.

### **Note 4: Fair Value Measurements**

Various inputs may be used to determine the fair value of investments. These inputs are summarized into three broad levels for financial statement purposes. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs that are derived principally from or corroborated by observable market data by correlation or other means, or observable inputs other than quoted prices; and Level 3 inputs consist of inputs to the valuation methodology that are unobservable and significant to the fair value measurement and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market funds:** Valued at \$1 as the NAV, which approximates fair value.

Common/collective trust: Valued at the NAV of the shares of the common/collective trust held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the Trust less its liabilities. The objective of the common/collective trust is to maintain the stability of principal and current income.

The Plan also has arrangements with various other service providers which qualify as party-in-interest transactions under ERISA.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Tax Status

Effective July 1, 2021, the employer adopted Ascensus, Inc.'s Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. The Internal Revenue Service issued an opinion letter on the pre-approved plan dated June 30, 2020 indicating it is in compliance with the applicable sections of the Internal Revenue Code. The letter stated, in part, that an employer who adopts this Plan may rely on the letter with respect to the qualification of its plan under Code Section 401(a), provided the terms of the pre-approved plan are followed.

### **Note 6: Tax Status** (Continued)

Although the Plan has been amended and restated since receiving the opinion letter; the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

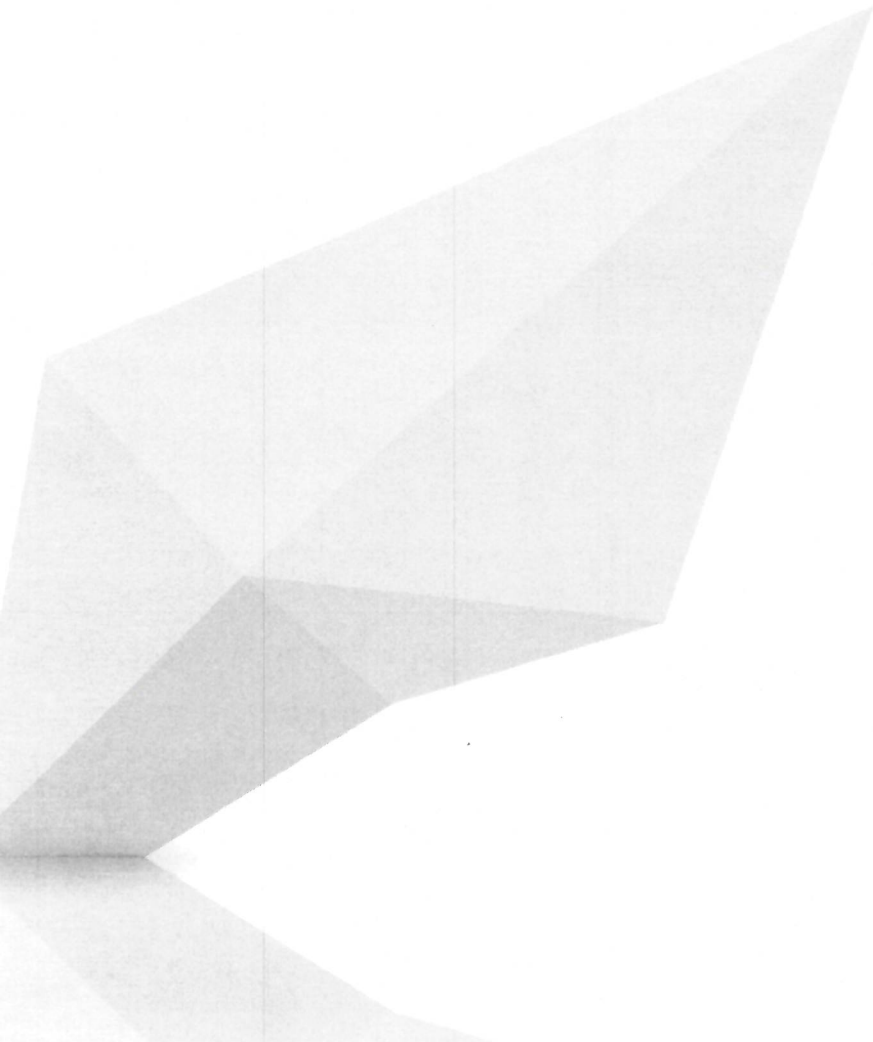

### Note 1: Description of Plan

The following description of the Capstone Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

Capstone Management, LLC 401(k) Plan (the Plan) is a defined contribution plan that has adopted the provisions of the Ascensus, Inc. Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Substantially all employees of Capstone Management, LLC, OnPoint Systems, LLC, Envision Technology, LLC, Rochester Precision Optics, LLC and Capstone Residential Services, LLC (collectively, the "Employer") are participants in the Plan, and all participants have a shared interest in the net assets of the Plan. Certain employees of the employer serve as limited trustees of the Plan.

The Plan covers all eligible employees, as defined, who have completed the applicable age and service requirements. The eligibility requirements for elective deferrals and safe harbor matching contributions are completion of 2 months of service and attainment of age 21. The eligibility requirements to receive discretionary employer matching and employer profit-sharing contributions are completion of one year of service and attainment of age 21. In addition, subject to certain exceptions, you must be employed on the last day of the Plan year to be eligible for profit-sharing contributions.

#### Contributions

Participating employees are allowed to make salary savings contributions as a percentage of their eligible compensation, as defined by the Plan, up to the maximum deferral amount allowed by law. Effective July 1, 2023, the Plan was amended to allow Roth deferrals and in-Plan Roth rollovers. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The employer will make safe harbor matching contributions of 100% of elective deferrals up to 4% of each eligible participant's compensation. In addition, the employer may make discretionary matching and profit-sharing contributions in such amounts as determined by the employer to be appropriate. Any discretionary contributions are allocated to participants in accordance with the Plan document. During the years ended December 31, 2024 and 2023, the Employer made safe harbor matching contributions of \$1,062,810 and \$855,801, respectively. The Employer did not make any discretionary matching or profit sharing contributions during the years ended December 31, 2024 and 2023.

#### Participant Accounts

Separate accounts are maintained for each participant and each participant's account is credited with the participant's contributions and employer matching contributions and allocations of employer profit-sharing contributions, if applicable, and Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Employer safe harbor matching contributions and the portion of the participant's account attributable to their voluntary contributions are immediately vested. Discretionary matching and profit-sharing contributions vest at 20% after two years of service with vesting increasing 20% per year until participants have a 100% vested interest in their share of the net assets. In addition, the participant shall be fully vested upon death, disability, or normal retirement age, as defined. Any amount of a participant's account which is not fully vested is forfeited upon termination and is used to reduce Employer contributions or to pay the Plan's administrative expenses. The Plan had no significant unapplied forfeitures at December 31, 2024 and 2023.

#### Benefits

Benefits may be distributed upon termination of employment, retirement, death or permanent disability. Distributions may be made in one lump-sum payment or in a series of partial payments as defined in the Plan document. A participant may also request a withdrawal, subject to limitations, upon attainment of age 65, or upon demonstration to the Plan Administrator that the participant is suffering from a hardship, as defined in applicable Internal Revenue Service regulations or standards established by the Secretary of the Treasury or his delegate, and meet the criteria specified in the Plan.

#### Investment Options

Plan participants may select their investments from various investment options made available under the Plan. The investment decisions for a participant's account are the sole responsibility of the Plan participant and they may change their investment options at any time throughout the year. Plan contributions are invested based upon these selected options.

#### Notes Receivable from Participants

Plan participants are allowed to borrow up to the lesser of \$50,000 or one-half of the vested value of the participant's account with a minimum loan amount of \$1,000. Loans must be repaid within five years, unless the loan is used to acquire a dwelling to be used as the principal residence of the participant, in which case the loans may be paid over thirty years. Loans are repaid in level payments, primarily on a weekly basis, in amounts sufficient to fully amortize the loan within the repayment period. Loans issued bear interest based upon the Wall Street Journal prime rate plus 1% at the time of borrowing. Interest rates ranged from 4.25% to 9.50% on loans outstanding as of December 31, 2024 and 2023. Participants are allowed to refinance their notes payable to the Plan one time over the life of the loan.

#### Plan Termination

While the Employer has not expressed any intent to terminate the Plan, it may do so at any time. In the event of termination of the Plan, all participants shall become 100% vested in discretionary employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Accounting Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Certain Plan assets are measured at net asset value (NAV), which is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the funds would sell the investments for an amount different from the reported net asset value. See Note 4 for a discussion of fair value.

Purchases and sales of investments are reported on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan document.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 26, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company, the Trustee of the Plan.

### **Note 4: Fair Value Measurements**

Various inputs may be used to determine the fair value of investments. These inputs are summarized into three broad levels for financial statement purposes. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs that are derived principally from or corroborated by observable market data by correlation or other means, or observable inputs other than quoted prices; and Level 3 inputs consist of inputs to the valuation methodology that are unobservable and significant to the fair value measurement and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market funds:** Valued at \$1 as the NAV, which approximates fair value.

Common/collective trust: Valued at the NAV of the shares of the common/collective trust held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the Trust less its liabilities. The objective of the common/collective trust is to maintain the stability of principal and current income.

Fees incurred by the Plan for investment management services are netted against net appreciation in fair value of investments and fees for administration of the plan are reported as administrative expenses. These transactions are deemed to be party-in-interest transactions.

The Plan also has arrangements with various other service providers which qualify as party-in-interest transactions under ERISA.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Tax Status

Effective July 1, 2021, the employer adopted Ascensus, Inc.'s Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. The Internal Revenue Service issued an opinion letter on the pre-approved plan dated June 30, 2020 indicating it is in compliance with the applicable sections of the Internal Revenue Code. The letter stated, in part, that an employer who adopts this Plan may rely on the letter with respect to the qualification of its plan under Code Section 401(a), provided the terms of the pre-approved plan are followed.

### **Note 6: Tax Status** (Continued)

Although the Plan has been amended and restated since receiving the opinion letter; the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
