Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The Cotton Commercial USA, Inc. 401(k) Plan and Trust (the Plan) was adopted effective November 1, 1999 and restated April 1, 2021 to establish a savings and investment plan for the exclusive benefit of the employees of Cotton Commercial USA, Inc. and Cotton Catastrophe, L.P. (the Company) and their beneficiaries. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 18, 2023, the Company acquired 24 Restore NE, LLC (24 Restore). The existing employer sponsored retirement plan for 24 Restore was terminated upon acquisition, distributing the assets to the participants and not rolled over or merged into the Plan for the Company. Employees of the acquired entity enrolled into the Plan of the Company, increasing the number of participants by 88.

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting. Interest income is recognized when earned.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Notes Receivable from Participants - Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Federal Income Tax - The Company adopted a Prototype Non-Standardized Profit Sharing Plan (the Prototype Plan) with a cash or deferral arrangement. The Prototype Plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Prototype Plan constitutes a qualified trust under Section 401(b) of the Internal Revenue Code and is therefore, exempt from federal income taxes. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust is tax-exempt as of December 31, 2024 and 2023.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the fiscal year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B      PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - Substantially all employees are eligible to become participants in the Plan following the completion of one year of service and 1,000 hours and attaining age 21.

Contributions - Participants may elect to make contributions to the Plan in an annual amount up to the maximum percentage allowable not to exceed the limits of the Code. Contributions are made through authorized payroll reductions. These contributions by individual employees were limited to \$23,000 (participants under 50 years of age) and \$30,500 (participants 50 years of age or older) in 2024. This limitation is generally adjusted periodically to reflect cost-of-living increases. The Plan provides automatic salary deferrals of 3% starting on the first entry date after an employee becomes eligible to enter the plan.

The Company may make contributions to the Plan in an amount determined solely at the discretion of the Directors. Such discretionary contributions, if any, are allocated pro rata to all eligible participants based upon the proportion of the participant's compensation to the total compensation of all eligible participants. No discretionary contribution was made for the year ended December 31, 2024.

Each participant account is credited with the participant's contribution, the Company's contributions, if any, and a pro rata share of the earnings of each fund in which the participant has invested.

Vesting - Participants are immediately vested in their salary reduction, rollover contributions, and the Company's nonelective contributions plus actual earnings thereon. Any Company elective contributions and related earnings vest as follows:

Forfeitures - Forfeitures of account balances not fully vested are used to reduce future plan expenses or employer contributions. For the year ended December 31, 2024, approximately \$43,862 was used to reduce plan expenses. The unused forfeiture balances at December 31, 2024 and 2023 amounted to \$3,227 and \$11,543, respectively.

Forms of Benefits - Benefits are recorded when paid. The normal form of benefit payable under this Plan is a lump sum.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Interest rates on loans outstanding at December 31, 2024 were ranging from 5.25% to 10.50%. Principal and interest is paid ratably through monthly payroll deductions.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Administration - The Company is administrator for the Plan. The Company, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. Audit fees were paid by the Company for the year ended December 31, 2024.

Plan Termination - Although the Company has not made a determination to terminate the Plan, the Company has the right under the Plan to terminate the Plan subject to provisions set forth in ERISA. Upon termination, all participants would become fully vested in their accrued benefits as of the date of termination.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 - Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access.

Level 2 - Other significant observable inputs (including quoted prices in active and inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments. All investments are valued using Level 2 inputs.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used during the year ended December 31, 2024.

Pooled separate accounts are valued based on the fair value of the underlying investments.

Guaranteed interest accounts are valued at fair value based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers in or out of the fair value categories during the year ended December 31, 2024.

NOTE E PARTY-IN-INTEREST

The Plan invests in various funds offered by Principal Financial Group. These investments are considered party-in-interest transactions because Principal Financial Group serves as asset custodian of the Plan. The Plan's trustees have approved of these investment options.
